

MINUTES OF THE 44th MEETING OF NATIONAL SKILLS QUALIFICATION COMMITTEE (NSQC) HELD ON 7th OCTOBER 2025

The **44th meeting** of the National Skills Qualifications Committee (NSQC) was held on **7th October 2025** in hybrid mode, under the Chairpersonship of Smt. Debashree Mukherjee, Chairperson, National Council for Vocational Education and Training (NCVET). The list of participants is at **Annexure I**. The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA ITEM 01: Confirmation of the Minutes of the Meeting of the 43rd National Skills Qualification Committee (NSQC) held on 08th May 2025

1.1. The Committee was apprised that the minutes of the 43rd meeting of NSQC held on 08th May 2025 were circulated and the following corrections were received,

1.1.1 Correction in the Nomenclature of two (02) Qualifications relating to Aerospace & Aviation Sector:

The nomenclature of one (01) new qualification and one (01) revised qualification of Aerospace & Aviation Sector Skill Council (AASSC) were erroneously mentioned as “Aircraft Aviation Junior Technician” and “Airline Security Executive” respectively. The corrected nomenclature of the qualifications is “**Aircraft Avionics Junior Technician**” and “**Airline Security Assistant**,” respectively.

The Committee approved the same.

1.1.2 Correction in the Nomenclature of one (01) Qualification, one (01) NOS and one (01) Micro-credential relating to Retail sector:

The nomenclature of one (01) new qualification, one (01) new NOS and one (01) new micro-credential of Retailers Association’s Skill Council of India (RASCI) were erroneously mentioned as “Business Analyst (Retail)”, “Fundamentals of AI and IoT in Consumer Engagement (Omnichannel Retail)” and “Sustainable Practices for Managing Retail Store Operations” respectively.

AGENDA ITEM 09: Archival/ Deactivation of Non-Active and Expired qualification from NQR Portal

9.1. The committee was briefed about the scope of National Qualification Register and its regular audit process to archive qualifications that are obsolete due to various reasons such as,

- The validity of the qualification has expired and the concerned awarding bodies has not taken up the same for revision, hence all such qualification are deemed to be not required in the skill ecosystem.
- All such Qualifications where there is no/low training conducted and/or are inactive for more than a year.
- Qualifications which have not been rationalised as per the National Credit Framework (NCrF) and revised National Skills Qualification Framework (NSQF)
- NCVET recognised Awarding Body has requested for deactivation/archiving of their qualifications.
- Qualifications which have no content (i.e. trainers handbook and participant handbook) available even after 90 days of NSQC approval.
- Upon de-recognition of an Awarding Body

9.2. It was noted that representations were received from various Awarding Bodies (ABs) regarding the archival of their qualifications. The agenda, therefore, needs to be re-examined with respect to the details of the qualifications listed under the archival/expired category.

9.3. Accordingly, the Committee recommended that the archival agenda may be taken up separately in the forthcoming NSQC meeting after resolving the issues.

AGENDA ITEM 10: Submission of Qualifications for NSQF Alignment & Approval

10.1. The committee was apprised that a total of **210** Qualifications/NOSs/MCs/NCs have been **received** at NCVET till August 2025 and placed for consideration in NSQC.
