

**Record of Discussion**  
**2<sup>nd</sup> Meeting of the National Skills Qualifications Committee**  
**held on 24<sup>th</sup> July 2014 at the Planning Commission, New Delhi**

The Second meeting of the National Skills Qualification Committee (NSQC) was chaired by Mr. S Ramadorai, Chairman NSDA.

**Agenda Item No. 1: Approval of Minutes of 1<sup>st</sup> Meeting of NSQC**

There were no comments on the Minutes of the 1<sup>st</sup> meeting of the NSQC and the same stood approved.

**Agenda Item No. 2: Action Taken Report**

DG, NSDA provided an update on the action taken on decisions taken in the 1<sup>st</sup> Meeting of the NSQC. He informed the meeting that the proposal to issue a notification for deemed approval of all non-statutory certification agencies such as CBSE, State Boards, NCVT, SCVT (in case there bodies were not statutory) etc. that have already been approved under the previous dispensation, and which are already functioning, has been submitted to the Department of Economic Affairs, Ministry of Finance. The Department has assured that the notification would be issued during the current week.

**Agenda Item No. 3: NSDA's update on NSQF-related activities:**

Director General, NSDA provided a summary of activities undertaken by the NSDA towards the implementation of the NSQF, including the State-level engagements undertaken by the NSDA, engagement with international stakeholders like the European Union and ADB, Sector specific efforts with SSCs and other sectoral stakeholders, sector-specific pilots for testing assumptions of the Recognition of Prior Learning, etc.

The team leader of the India-EU Skill development project provided a brief overview of the project, including the nature of support they would provide through the project to the NSQC – which would include recommendations to the NSQC on the approach to approval of NOSs and QPs, designing of a draft qualifications template for the National Qualifications Register. He shared that their first draft of proposals would be ready by beginning September 2014, when the same could be shared with the NSQC. **Agenda Item No. 4: Presentation by ADB on role of similar bodies in other jurisdictions:**

The Team Leader ADB Technical Assistance 8010 "Skills For Inclusive Growth" project spoke on the role of bodies similar to the NSQC in other international jurisdictions. The presentation included the role and scope of SSCs, the processes adopted in other countries for approval of NOSs and QPs, and how to potentially deal with cross sectoral NOSs and QPs, international equivalence and also the expectations from different stakeholders. She highlighted that there is currently perhaps too much workload on some Indian SSCs and this could possibly hamper their main function - which is to be constantly engaged with industry. She shared that the project reviewed 98 NOS and that the research found a 20% compliance rate with the NSDC's template. The NOSs and QPs were also found to be narrowly defined, as compared to those in other countries, which are much wider in scope, thereby allowing for greater flexibility for the workforce. 1. DG, NSDA proposed that the sectoral committees of the NSQC should include, in addition to the composition required under the Notification dated 27<sup>th</sup> Dec 2013, five industry representatives from the sector, including MSME and informal sector representatives – who could be nominated by concerned stakeholders including the administrative Ministry and the Sector Skill Council. This was approved by the Committee. The NSDA would initiate this process of seeking nominations in respect of all five sectors. **(Action: NSDA)**
