

Minutes of 22nd Meeting of the National Skills Qualifications Committee (NSQC)

Venue: National Skills Development Agency (NSDA), B-2, Pusa Road,
Kaushal Bhawan, New Delhi 110005

The 22nd meeting of the National Skills Qualifications Committee (NSQC) was held on 19th December, 2018 at National Skill Development Agency (NSDA), New Delhi under the Chairmanship of Dr. K.P. Krishnan, Chairman, NSDA and Secretary, Ministry of Skill Development and Entrepreneurship (MSDE). The list of participants is at **Annexure I**. The meeting discussed total of 12 agenda items. DG, NSDA made detailed presentation on the agenda items.

Agenda Item I: To confirm the minutes of the 21st Meeting of NSQC

The Committee approved the minutes of 21st meeting of NSQC which were modified to incorporate suggestions of NSDC. The corrections incorporated are attached as Annexure II.

Agenda Item II: Action Taken Report on the minutes of the 21st Meeting of NSQC

The Committee was apprised of the action taken by NSDA on the minutes of the 21st meeting of NSQC. The Committee noted the same.

DG, DGT requested the NSQC to add ITI as entry requirement wherever class 10th is mentioned since the qualification holds an equivalency to class. Same was agreed by NSQC.

Policy guidelines on healthcare related skill courses issued by MoHFW

The Committee was informed that a bilateral meeting between Secretary MSDE and MoHFW is to be done as per Cabinet Secretary Meeting to discuss the policy guidelines on healthcare related skill courses issued by MoHFW. Further, MoHFW informed NSQC that they have reviewed the health care sector Qualifications and the same will be shared with NSDA at the earliest.

Agenda Item III: State Visits for Advocacy workshop-Issues & Challenges

The Committee was informed about the NSDA State Advocacy workshops for creating awareness about the Skill India Mission including NSQF. It was highlighted that these workshops facilitated adequate information dissemination about the skill initiatives by various constituents of the Ministry on one platform thereby. It also facilitated understanding states initiatives and addresses the challenges and issues states are facing in terms of:

- Need for proper Mobilization and counseling strategy
- Strengthening information dissemination system
- Mapping aspirations of youth and demand of the industry through skill gap study
- Strengthening Institute Industry linkages
- Achieving convergence for optimum utilization of resources
- Adequate training of trainers and assessors to ensure quality and better outcome
- Framework for monitoring and evaluation.
- Compiling and disseminating best practices for better cross learning.

Committee noted the same for further deliberations.

Agenda Item IV: NCVET notification

NSQC was informed about the notification of NCVET vide gazette notification dated 5th December 2018.

Committee noted the same.

Agenda Item V: Decision on Academic Qualification

DG, NSDA informed the Committee that NSDA has received qualifications which are academic in nature for NSQF alignment. In this regard, a consultation meeting was held on 13th December 2018 at NSDA with UGC, AICTE and MHRD to take their view.

DG, DGT shared that many institutions like IITs and IIMs are institutions set up by act of Parliament and should not be brought under NSQF domain. Also many short term advanced courses are very dynamic in nature, and need not be necessarily aligned to NSQF.

NSQC decided that a letter be sent to ministries, institutions from where such Qualifications have been received to wait till the time NCVET is setup. It also directed NSDA to constitute a Sub-Group with representatives from UGC, AICTE to deliberate on this issue and prepare draft guidelines.

Agenda VI Reduction in Time Span of SOP and Timelines for Line Ministry Concurrence

DG, NSDA highlighted the issue of delay by Line Ministry in giving approval and also reducing the time span for processing the qualification files. **NSQC decided that a three-week window for granting of approval would be provided to the ministries. If no response is received from the ministry within that period, it would amount to deemed approval.**

DG NSDA also informed the NSQC that NSDA is working on digital submission and processing of qualification files to promote more transparency, timeline adherence and clarity in the system. Files under this setup would be submitted through a password

protected user account online. Stakeholders would be able to monitor the progress of the qualification file digitally under such mechanism.

The Chairman mentioned that NCVET may take a call on SOP revision if required.

Agenda VII on Extension of NSQF Deadline

DG, NSDA informed NSQC that the fifth anniversary date of the notification of NSQF is reaching on 27.12.18. Since the alignment work is in process only, MSDE was requested to seek extension of NSQF notification.

Committee noted the same.

Agenda Items for Ratification/Approval

Agenda Item VIII: Extension of review dates for expired Qualifications

The Committee directed NSDA to share the report among concerned stakeholders for wider consultations. The committee was also apprised of the status of de-duplication of Qualifications work done by NSDA. It was decided that review dates of qualifications may be extended so that same can be used under programs.

Agenda Item IX: Industry validation form

NSQC was apprised about the decision taken during in the 19th meeting of NSQC wherein industry validation form was approved. *The Committee reiterated its decision to follow the industry validation format as approved in the 19th NSQC.*

Agenda Item X: To consider the Qualification Files received from Submitting Bodies

The Consultant, NSDA presented QFs of their respective sectors to the Committee for consideration of NSQF alignment. The following discussion and decision was taken:

- 1) All qualifications where entry qualification is 12th, ITI pass of 2 year courses should also be made eligible.
- 2) All qualification files should necessarily include NCO codes.
- 3) There needs to be uniformity in the language used for entry requirement across qualification files.

Sectoral File Approval

i. Gems & Jewellery Sector Skill Council

- The 12 Qualification Files presented by Gems & Jewellery SSC were approved.

- For all the 12 Qualification Files, entry requirement to be kept same as originally suggested by SSC.
- Training materials of these job roles should be according to the audience and have more visuals, incorporating more pictures, visual aids that would be helpful for candidates with basic literacy and numeracy.

ii. **BFSI:** for preparing the qualification files, industry bodies like AMFI were consulted by BFSI SSC. All the 5 QFs have been approved.

iii. **Sports:** MHRD informed that both these QFs are running in schools and there is a huge requirement for them. Both the QFs are approved. A letter has to be resent to the Line Ministry with 3 weeks cap.

iv. **Domestic Workers:**

- There was a discussion that the level of Home Cook is high to which SSC has justified the need for high level.
- These courses will also run in RPL but there will not be entry level requirement or similar criteria for RPL certification.
- The Chairman was of the opinion that there is no need to formalize this qualification as this sector provides huge employment.
- The SSC shall also evolve a parallel RPL system to cater to the informal sector.
- All QFs are approved.

v. **Capital Goods:** 1 file was approved.

vi. **Automotive:** all the QFs are running in PMKVY without NSQF alignment. It was decided that these QFs shall be given post facto approval till May 2019.

vii. **Aviation:**

- There was a discussion on difference between automobile welder and aerospace welder over the QF names Aerospace Welder.
- NSDA was directed to send the letters to Ministries of Civil Aviation, Heavy Industries and Defence Production indicating that the qualifications have been approved and if they have any comments they may be sent within three weeks.
- Chairman indicated that the language in the entry requirement should be uniform in all the files submitted by different submitting bodies.
- All the QFs have been approved.

viii. **Textile**

- The five Jute Qualification Files presented by Textile SSC were approved.
- It was appreciated that the QPs offer skilling and employment to minimally educated person.

- Chairmen NSQC suggested that these types of Qualifications should have apprenticeship component to make it broad based. Since the practical skill training for these QPs is done in the textile industry in actual production conditions, it was suggested that they may be taken up as basic training programs to build up training programs under National Apprenticeship Promotion Scheme in consultation with the industry.

ix. Telecom

- 8 Qualification Files were placed before NSQC. It was informed that for 4 Qualifications namely Fiber to the Home (FTTH/X) Installer, Surface Mount Technology Technician, Hand Soldering Technician Telecom Board and Line Assembler - Telecom Products, line ministry approval is awaited. NSQC directed that SSC needs to resubmit the Qualifications with relevant NCO codes for all of them within a span of 3 weeks. The same will be reported to DG, NSDA for approval. In case there is no issue, files may be approved by DG, NSDA.

x. Green jobs SSC

All 5 qualifications were approved by NSQC. Qualifications - Wastewater treatment Plant Helper, Wastewater treatment Plant Technician and Recyclable Waste Collector and Segregator did not have line Ministry concurrence and it has been communicated by MoEF&CC that they will come with similar qualification since past one year. However, since MoEF&CC has not come up with such qualification till date, the qualification files by green jobs SSC were approved by NSQC. MoEF&CC to be communicated the decision of MoEF&CC.

xi. Food processing SSC

All 4 qualification files were approved by NSQC

xii. IT/ITeS SSC

A total of 29 Qualification Files were placed before NSQC, out of which 19 Qualifications were fresh and 10 were given in-principle approval. The same were approved by the NSQC.

xiii. Electronics SSC

A total of 7 Qualifications were placed before NSQC for approval. The same were approved.

xiv. Directorate of General Training (DGT)

All 17 Dual training system courses are approved. DGT can put additional flexibility in the duration spent in the industry. In respect of Drone one week course, DGCA guidelines issued from time to time may be used to improve upon the course. Qualification Regarding POT qualification of the DGT, the representative from M/o HRD desired that name of the DGT-POT qualification

needs to include word vocational, therefore, name of POT qualification was modified to Principles of Teaching (Vocational training) or [Principles of Vocational Teaching]. This course may be run in classroom, online or blended mode.

All the 26 qualification files of the DGT were approved after their presentation before the NSQC members.

xv. Ministry of Health

- 5 Qualifications proposed by Health Ministry got approved. Healthcare SSC requested to adopt some of these qualifications through formal process of NSQC which was agreed by MoHFW.
- Regarding pending concurrence of existing as well as proposed qualifications under healthcare submitted by NSDA, MoHFW representative mentioned that policy guidelines are finalized and will be shared with NSDA and MSDE. Draft guidelines were submitted to DG, NSDA. Further action on qualifications related to healthcare sector will be taken accordingly.

xvi. Department of Shipping, Sagarmala Cell-

In principally approved qualification was put for ratification and same was approved.

xvii. CIPET

36 previously approved qualifications have been granted extension for next two years. However, NSQC directed CIPET to compress their Qualifications. NSDC requested CIPET to present some of the Qualifications prepared by Rubber SSC.

xviii. Ministry of Environment, Forest and Climate Change

All 14 files were approved. However, it was suggested by Chairman, NSDA to re-look into the levels of the qualifications as they were appearing to be very higher. Ministry agreed to submit suitable justification for the levels given to the qualifications.

xix. Beauty and Wellness Qualification by NESC, Assam

Qualification was approved.

xx. Agriculture sector qualification by ASAP, Kerala

Qualification was approved.

xxi. Management sector qualification by Indian Institute of Chartered Accountants-

In principally approved qualification was put for ratification and same was approved.

xxii. Management Sector qualifications submitted by MEPSC-

- All qualifications got approved. Level of Training Centre manager to be brought down to level 6. Regarding stakeholder consultation done, SSC will

comply to it and a letter will be sent to seek AICTE perspective within 3-week timeline. NCVT may also adopt qualifications proposed by MEPSC.

- Regarding 6 NOS's proposed by Management SSC, it was informed by NSDA that currently we do not have any mechanism to approve NOSs'. However as per requirement of MSDE these NOS's were approved for usage under PMKVY.

xxiii. Security sector qualification submitted by MEPSC-

Qualification was approved. SSC will incorporate the suggestions provided by Fire Services, Govt. of Delhi.

xxiv. Agriculture Sector qualifications submitted by ASCI-

- All qualifications were approved. SSC shall comply to suggestions made in stakeholder consultation meetings. Representative from Agriculture Ministry assured to expedite the concurrence of remaining qualifications.
- For qualification not having line ministry concurrence, a letter for necessary will be sent to Ministry of Agriculture and Ministry of Rural Development (for watershed qualifications) with 3-week timeline. Subject to receiving of any comments from respective ministries SSC will incorporate the suggestion and if no comments received qualifications will be put on NQR.

xxv. Furniture and Fitting qualifications proposed by SSC-

- In principally approved qualification "Lead Carpenter-wooden Furniture" was put up for ratification and same was approved. NSDC will submit justification on revised nomenclature of qualification.
- Interior Designer qualifications at level 5 and 6 were in principally approved subject to compliance of stakeholder and receiving of comments from DGT.
- Remaining 3 qualifications were approved. Regarding concurrence, letter will be sent to Ministry of Small Medium Enterprise and Ministry of Housing and Urban for reply within 3- week timeline. Subject to receiving of any comments from respective ministries SSC will incorporate the suggestion and if no comments received qualifications will be put on NQR.

xxvi. Leather SSC

- 25 files in total were presented and approved.
- 2 ratification files - Shoe Maker and Footwear and Allied Goods Repairer were approved
- 23 revision files for which the review date has crossed were also approved for leather SSC

xxvii. SCVT, J&K:

Two Qualification Files were submitted by SCVT, Jammu and Kashmir, namely Basholi painting and Kani Shawl Weaver. State informed the house that these are the two of the 7 identified and marked traditional skills of the state. Training is already going on in these trades. State had also requested NSDA to guide regarding development and NSQF compliance of the qualifications.

NSQC granted approval to the files and directed NSDA to further refine the qualifications in terms of compliance requirements.

xxviii. Kerala (ASAP) Logistics: approved

NSQC granted approval to the files and directed NSDA to further refine the qualifications in terms of compliance requirements.

xxix. FDDI , DIPP, Ministry of Commerce and Industries

All 4 revision files were approved for 2 years

xxx. NESC, ASSAM

All four Qualifications from State of Assam were approved.

The meeting ended with vote of thanks to the Chair.
