

MINUTES OF THE 24TH MEETING OF NATIONAL SKILLS QUALIFICATIONS

COMMITTEE (NSQC) HELD ON 27TH FEBRUARY 2020

The 24th meeting of National Skills Qualifications Committee (NSQC) was held on 27th February 2020 at National Skill Development Agency (NSDA), Kaushal Bhawan, New Delhi, under the Chairpersonship of Shri. Praveen Kumar, Chairman, NSDA and Secretary, MSDE. The list of participants is at Annexure I.

At the outset, DG- NSDA welcomed all participants for the meeting. She briefed NSQC about the agenda of the meeting which was taken up for detailed discussion. Chairman, NSDA suggested that in order to reduce the delay in NSQF alignment of qualifications, in future, meeting of NSQC shall be conducted in the second week of every month and qualifications received 45 days prior to the meeting will be considered.

AGENDA ITEM 1: CONFIRMATION OF MINUTES OF THE 23RD MEETING OF NSQC

The Committee approved the minutes of the 23rd meeting of NSQC held on 22nd August 2019.

AGENDA ITEM 2: ACTION TAKEN REPORT ON THE MINUTES OF THE 23RD NSQC

NSQC took note of the action taken and approved the same.

AGENDA ITEM 3: QUALIFICATIONS SUBMITTED FOR NSQF ALIGNMENT

DG-NSDA informed NSQC that qualifications received up to 30th November 2019 were being considered in the NSQC. NSDA had received 214 qualifications (145 new & 69 revised) till then. DG- NSDA gave a brief snapshot of the qualifications being considered for NSQF alignment after following the due process of scrutiny. Of the 214 qualifications received, a total of 173 qualifications were considered for NSQF alignment. She informed that the 37 qualifications of Rubber SSC were not being considered as the SSC had requested that these be placed before the next NSQC since these files were still

under discussion with CIPET. The list of qualifications approved is at Annexure II. The sector-wise/submitting body wise discussions and decisions taken are given below:

1. Qualifications submitted by Central Ministries

I. **Directorate General of Training:** A total of 145 files were presented for ratification. NSQC was informed that these files had been approved in the last NSQC held in August 2019 and were being brought back to NSQC only because of revision in number of notional hours and streamlining of the training content. These changes did not impact the learning outcomes of the qualifications. NSQC approved the files with following observations:

- For 6 qualifications relating to health Sector under CTS, it was informed that -3 qualifications namely-‘Dental Laboratory Equipment Technician’, ‘Physiotherapy Technician’, ‘Radiology Technician’ had been disapproved by Ministry of Health;

2 qualifications viz- ‘Old Age Care’ and ‘Health Sanitary Inspector’ had been approved with certain modifications and one qualification file of ‘Health Safety & Environment’ had not been referred to Ministry of Health. NSQC decided that DGT may not enrol any new student for the qualifications disapproved by Ministry of Health. In respect of the two Qualifications in which modifications have been suggested by MoH&FW , no new enrolment to be made till the issue is sorted out with MoH&FW; and the qualification on ‘Health Safety & Environment’ may be shared by DGT with MoH&FW.

- NSQC suggested that while submitting new qualifications for NSQF alignment, DGT may also keep in view the nomenclature of existing qualifications under short term training programs to avoid duplication.

II. **Ministry of Textiles:** 12 files were submitted by Ministry of Textiles. All 12 files were approved subject to following compliances:

- The nomenclature of two files namely ‘Handloom Weaving-Dobby’, and ‘Handloom Weaving- Jacquard’ to be changed to ‘Handloom Weaving (Advance)- Dobby’,

‘Handloom Weaving (Advance)- Jacquard’ respectively as these qualifications are meant for existing weavers who already having basic knowledge of weaving.

- Nomenclature of qualification ‘Hand Dyer Training’ to be changed to ‘Handloom Hand Dyer’.
- Nomenclature of qualification ‘Design Training Program (Manual)’ to be changed to Handloom Design (Manual).
- The entry criteria for these qualification mentions ‘having basic knowledge of weaving’ as basic eligibility of the candidate. NSQC was of the view that to ascertain this entry requirement, there should be provision for evidence of prior learning, hence provision for ‘RPL’ of ten hours should be made within the qualification.
- For two qualifications namely ‘Wool Dyeing Supervisor’ and ‘Wool Cleaning and Scouring Supervisor’, 2 year ITI in relevant trade with 3 years’ experience or 1 year ITI with 4 years experience may be included in the entry criteria.

2. Qualifications Submitted by Sector Skill Councils

I. **Hydrocarbon SSC:** A total of 4 files were submitted by the SSC. All 4 files were approved with the following modifications:

- Qualification ‘Line Patrolling Man’ to be renamed as ‘Line Patrolling Man (Oil & Gas)’ to indicate that it pertains to the hydrocarbon sector.
- Entry-level criteria of qualification – ‘Process Instrument Operator’ to be revised to ‘Class XII (with Science) or ITI with relevant trade’. The requirement of one year of experience with Class XII to be removed.

II. **Leather SSC:** 2 Qualifications were submitted by the SSC for approval of NSQC. NSQC was of the view that the levels assigned to these two qualifications are high. It was decided that DG-NSDA will review these files and these will be placed in the next NSQC for approval.

- III. **Management & Entrepreneurship & Professional Skill Council:** 3 qualification files from the SSC were placed for ratification. NSQC approved and ratified all the three qualifications.

3. Qualifications submitted by States

- I. **Chhattisgarh:** One qualification file was presented to NSQC for NSQF alignment. Committee observed that the proposed entry requirements and notional hours may not be sufficient to achieve the listed competencies of the qualification. Thus, conditional approval was granted subject to resubmission of the qualification by the submitting body after either adding Level 3 certification as a mandatory entry requirement or increasing the notional hours substantially by at-least 75%.
- II. **Hartron, Haryana:** 5 qualification files from Hartron, Haryana, were approved by NSQC subject to the submitting body resubmitting the qualifications after changing the nomenclature of all the 5 Q files by adding "Assistant" at the end of every file name.
- III. **West Bengal-** one qualification of 'Junior Lift Erector' was approved by NSQC.

AGENDA ITEM 4: REPLACING THE QP FILE- "FIELD EXECUTIVE-DATA AND DOCUMENT COLLECTION OR VERIFICATION" WITH NEW FILE

NSQC was informed that qualification of 'Field Executive-Data & Document Collection or Verification' of Management Sector Skill Council was approved in the 23rd meeting of NSQC held on 22nd August 2019. On request of MoSPI, the qualification was upgraded to that of 'Field Survey Enumerator', with 10-15% alteration in the approved qualification with widened scope for data collection.

NSQC approved the replacement of the Qualification of 'Field Executive- Data & Document Collection or Verification' with the qualification of 'Field Survey Enumerator'.

AGENDA ITEM 5: EXTENSION OF RETAIL FILE- SELF EMPLOYED e-TAILOR

A request for extending the validity of the qualification 'Self Employed e-Tailor' for another Special Project by the Centre for the Study of Caste and Capitalism was received by NSDA. The same was discussed in NSQC and details of the outcome of the special project approved earlier were shared with NSQC.

NSQC approved the proposal for extending the validity of Self Employed e-Tailor job role for training under a Special Project, PMKVY, by Centre for the Study of Caste and Capitalism.

AGENDA ITEM 6: NSQF ALIGNMENT OF ACADEMIC QUALIFICATIONS

NSQC was informed of the efforts made by NSDA with respect to NSQF alignment of qualifications perceived to be academic in nature. The NSQC agreed to the approach and recommendations of the Sub-group, constituted by NSDA for the purpose, with slight modifications. The following mechanism was agreed to for NSQF alignment of Academic Qualifications:

- Qualifications having skill component of 60% or more and leading to a job role shall be treated as skill qualifications.
- Skill component shall include skill related theory, practical, and OJT. Practical or/and lab portion of non-skill component shall not form part of skill component.
- Apprenticeship to be included as part of skill component
- Qualifications which are already regulated by any statutory regulator except those which are vocational in nature will not be considered for NSQF alignment

NSQC suggested that, based on the above, NSDA may formulate guidelines to be followed for all B. Voc courses. The B.Voc Courses shall be considered deemed NSQF aligned if the approach/ conditions outlined in the guidelines are fulfilled. The Universities being autonomous bodies can also prepare their own syllabus and conduct their own assessment. NSDA may write to MHRD conveying the same once the guidelines are ready.

AGENDA ITEM 7: NSQF ALIGNMENT OF MULTI-SKILL QUALIFICATION

The Committee was briefed about the Working Group set up to review & recommend revisions in NSQF compliance norms for school education and the Sub Group set up under it to review & recommend revisions in 'Multi Skill Assistant Technician' Qualification and their subsequent meetings. The recommendations of the Working Group with respect to the qualification were discussed in detail. It was brought to the notice of the Committee that many States had approached NSDA for continuation of this qualification owing to its popularity. The Committee observed that since this qualification was more like an orientation program at the school level, it could be left to the States /school boards to include it as one of the subjects in their respective States jurisdiction. The following decisions were taken, which will be applicable for all new batches:

- i. SSCs shall be delinked from this qualification.
- ii. States/school boards are open to use the current qualification, where awarding and assessment function would be taken care of by the respective States/school boards.
- iii. The existing qualification will be revised to incorporate the above changes and shall be submitted to NSDA. The revised qualification shall replace the existing qualification on NQR.

AGENDA ITEM 8: ASSIGNING UNIQUE CODES TO CERTIFICATES UNDER SKILLING PROGRAMS

NSQC was informed about the need to have a uniform Certificate for the short term skilling programs in the country to ensure standardization and also to incorporate the changes consequential after operationalisation of National Council for Vocational Education and Training (NCVET). The Sample certificate prepared was shared and the NSQC was informed about the process followed in preparing the sample certificate.

NSQC was also apprised that to ensure accuracy and authenticity of certificates issued, a unique identification code had been developed which shall be reflected in each certificate of all short term and long term skilling programs.

NSQC took note of the action taken and agreed with the approach followed.

AGENDA ITEM 9: TRANSITION PERIOD FOR CENTURION UNIVERSITY

NSQC was informed that CUTM was recognized as an Awarding Body by a Notification dated 27.11.2018, post which, the Notification was amended on 05.12.2019 as per decisions taken in the 23rd NSQC held on 22.08.2019. It was further informed that CUTM had requested NSDA to withdraw the revised/ amended Notification and to provide 5 year transition period to adjust to the new guidelines.

NSQC reiterated that CUTM was recognised as an Awarding Body only in respect of Qualifications as approved by NSQC. However, once a Qualification is revised/ suspended/ de-recognized by the NSQC, the recognized Awarding Body shall cease to run those Qualifications. Further, it was informed by NSDC that they are in process of reviewing the qualifications and in the process a number of short term qualifications are being retired/ merged. NSQC directed that if any retired qualification is a part of 137 qualifications (approved for CUTM), approval for such a Qualification would cease. DG-NSDA informed that as per adoption guidelines, the adopting body has to comply with the changes that may come about in the original qualification.

NSQC agreed to grant one-year transition time to CUTM from the date of the revised Notification i.e. 05.12.2019 in respect of MoUs signed on or before the date of the revised Notification.

AGENDA ITEM 10: EXPERIMENTAL APPROVAL OF QUALIFICATIONS

A proposal seeking exemption from NSQF alignment for new & emerging qualifications of Sector Skill Councils (SSCs) for a period of one year, was received by NSDA. The NSQC did not agree to the exemption from NSQF alignment. However, it agreed to the following mechanism for 'Experimental Approval' in respect of all submitting bodies:

- Submitting bodies can submit their qualifications under this mechanism for approval within 15 days of receipt by NSDA/NCVET after preliminary scrutiny and verification of the documents and information.
- Submitting bodies will ensure that Qualifications submitted under this mechanism comply with NSQF norms/ parameters.

- Submission shall be made in NSQF Q File template along with annexures.
- Submitting bodies would need to necessarily bring before NSQC, the qualification for approval within a suitable period, and not later than nine months from initial approval, so that final approval is received within one year of experimental approval, failing which the experimental approval will lapse and cannot be renewed.
- Qualifications approved under this mechanism will not be eligible for any Government funding, however they may use the Skill India logo for certification.
- For Government funded programs, existing NSQF qualification approval process will continue as it is.
- This will be tried out on an experimental basis and the outcomes will be reviewed after a year of its implementation to decide upon its continuation.
- In the meantime, NCVET will work towards strengthening its approval mechanisms so as to reduce the time taken between receipt and approval of qualifications.

AGENDA ITEM 11: EXTENSION OF REVIEW DATE OF 1080 QUALIFICATIONS TILL JUNE 2020

NSDC requested to consider extension of the date of review of 1039 qualifications from March 2020 to June 2020 and to extend the review date for additional 41 qualifications till June 2020.

The NSQC accorded approval for extension of these 1080 qualifications till June 2020.

AGENDA ITEM 12: FOR INFORMATION OF NSQC

i. Inclusion of PwD as a new sector on NQR & in Q-Files

NSQC appreciated and took note of the efforts made by NSDA for inclusion of PwD as new sector on NQR and steps taken for their inclusion in the development of qualification files.

ii. Retirement of 8 qualifications of Automotive Sector Skill Council

The action taken on the request of Automotive Sector Skill Council was noted by NSQC. However, NSDC requested that one qualification namely 'Dealership Sales & Value added Services Executive' may be continued on NQR till March since it had already been given extension till March, earlier. This was agreed to by NSQC. The details of 7 files approved for removal from NQR is at Annexure III.

ADDITIONAL AGENDA ITEMS

i. Approval of Hindi Steno Typist Qualification

Considering the urgency in rolling out the training, the Committee gave in-principle approval for the qualification. However, it was decided that the qualification will be placed before next NSQC for final approval, after completion of necessary compliances.

ii. Adoption of MoH&FW qualification by HSSC

The Committee was informed about the decision made in 22nd NSQC held on 19th December, 2019 wherein it was decided that 5 qualifications of Ministry of Health can be adopted by Healthcare SSC, to which MoH&FW had agreed.

Accordingly, Healthcare SSC had now submitted their proposal under adoption guidelines.

The Committee took note of the decision above. The details of the five files adopted by Health care SSC is at Annexure IV.
