& technology/ social sciences/ vocational education/ skilling/ law from top 500 ranked Universities/ Institutions as per National Institutional Ranking Framework (NIRF), of MoE or International Institutes of repute are also eligible to apply for the internship.

Age limit: 30 Years

## (b) Desirable:

- Experience in Policy & Planning in Social/ Development Sector preferably in Skilling/Education domain
- Implementation, Supervision & Monitoring of Skill Development/ Education schemes.

Technology related fields

- Government Consulting/ Legal, Finance, work experience with international development agencies, preferably in implementation of Programmes.
