
ORDER

Subject: Extension of Transition Period for the Assessment Agencies, empanelled with the existing Awarding Bodies, seeking NCVET recognition- Reg.

1. The applications are being received by NCVET from entities seeking NCVET recognition for functioning as Assessment Agency (AA) in the skill ecosystem. All such applications received till 30th April, 2022 have undergone extensive scrutiny and evaluation at various levels in NCVET.
2. Whereas, in order to ensure continuity in the skill ecosystem, out of the above proposals, 103 applicants who were earlier empanelled as Assessment Agencies (AAs) with different existing Awarding Bodies had been granted transition period, last extended upto 30th April, 2022 vide NCVET circular No: 38004/01/AA/2022/NCVET dated 31st January, 2021.
3. Whereas of these 103 AA applicant bodies, LoI has been issued to 29 AAs (list at Annexure-1); compliances are awaited in respect of 18 AA applicant bodies whose final review has already been conducted by the Sub-Committee, empowered by the NCVET Council to take a decision on the recognition of AAs; also the final review has been scheduled for another 18 applicants; while the remaining are either ineligible or have withdrawn their application.
4. Therefore, in view of the above, in public interest to facilitate the continuity in the assessment process being carried out in the skill ecosystem, the transition period in respect of 36 applicant bodies (list at Annexure-2), which includes 18

whose compliances are awaited and 18 whose final review has been scheduled, as detailed in the para above, is extended upto 15th July, 2022, or till a final decision is taken by NCVET on their individual proposal, whichever is earlier.


