#### **AGENDA ITEM NO 04: CHANGE IN COMPOSITION OF NSQC**

6. With the appointment of Chairperson, and two Executive Members, NCVET the composition of NSQC has been revised by the Council to align it with the NSQF gazette notification of 27<sup>th</sup> December, 2013.
7. Further, as per the NSQF notification, three (3) new States/UTs and two Industry Associations are to be nominated as members in rotation, for a period of one year. The existing three member States/UTs, namely, Andhra Pradesh, Haryana & Arunachal Pradesh and two Industry Associations namely, FICCI and CII, have completed their term of one year and hence the Council has approved three new States/UTs and two new Industry Associations, as new NSQC members for a period of one year i.e. till 31<sup>st</sup> August 2022.
8. Accordingly, the approved composition of NSQC by Council is as under: -
  - a) The Chairperson, NCVET is the Chairman, NSQC.
  - b) The following **three States** have been nominated to be the member states of NSQC from September 2021 to August 2022.
    - i) Uttar Pradesh.
    - ii) Goa.
    - iii) Jammu& Kashmir.
  - c) The following two industry associations have been nominated to be the member associations from September 2021 to August 2022.
    - i) ASSOCHAM.
    - ii) Laghu Udyog Bharti.
9. The Agenda has the approval of the Council and has been placed before the NSQC for information.
