**AGENDA ITEM NO 03: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT**

1. A total of 135 Qualification Files were received till 31<sup>st</sup> May 2021 and scrutinized by NCVET for NSQF alignment. The details of the files received are as under: -

- a) New QFs - 63.
- b) Revised QFs - 72.

2. Following 25 revised and 10 new Qualification Files are not being considered for 10<sup>th</sup> NSQC. Justifications for the same are mentioned as under: -

**AGENDA ITEM NO 04: ACTION ON VALIDATION OF QUALIFICATIONS EXPIRING ON 30<sup>TH</sup> SEPTEMBER 2021**

The 7<sup>th</sup> meeting of NSQC held on 25<sup>th</sup> March 2021, had approved a one-time extension till 30<sup>th</sup> September 2021 to 1857 qualifications in various Sectors which was due to expire on 31<sup>st</sup> March 2021. All concerned submitting bodies were also informed to submit the qualifications due for revision well in advance before NSQC. It is also important to note that with the launch of New Education Policy, 2020 and formulation of credit framework at NCVET, it is imperative that the revised files are relooked wrt entry criteria, notional hours and NSQF levels so as to align with the requirements of general education and enable a seamless integration between Vocational education and General Education.

2. The awarding bodies concerned were expected to submit the qualifications, which are due for revision, to NCVET along with the requisite documents. It is however seen that even with only 2 months remaining for the September timeline, the number of qualifications received by NCVET for revision is proportionately much less.

3. Accordingly, the following are proposed before the NSQC for consideration:-

(a) All Qualifications (revised, with or without changes) which were due for revision by September 2021 be submitted before NCVET by all SSCs, earliest but not later than 15 September 2021, along with the Annexure 'O' giving details of number of candidates trained and placed since approval of the ibid qualification.

(b) All such revised qualifications having conducted **ZERO** number of training and placement of candidates trained since its approval is recommended to be qualified as '**In-active**' and be shifted to the archive section of NQR.

(c) In case the Submitting Body of such Qualifications has a justification for continuation of these Qualifications expiring by September 2021, may submit the same to NCVET with supporting documents of not having conducted training since its approval as also their future requirements. NCVET after detailed scrutiny of the

submitted documents and stakeholders' consultation shall bring before the NSQC for approval.
