### **3. AGENDA ITEM NO 03: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT**

3.1. A total of 283 Qualification Files were received till 31<sup>st</sup> July 2021 and scrutinized by NCVET for NSQF alignment. Details of the files received are as under: -

- b) Revised QFs - 255.

**4. AGENDA ITEM NO 04: EXTENSION OF VALIDITY OF ALL REVISED QUALIFICATIONS SUBMITTED TO NCVET BEFORE 15<sup>TH</sup> SEPTEMBER 2021**

4.1. In the 7<sup>th</sup> meeting of NSQC held on 25<sup>th</sup> March 2021, approval was given to extend the validity of 1859 Qualifications of various Sector Skill Councils (SSCs), till 30<sup>th</sup> September 2021.

4.2. Further, in the 10<sup>th</sup> meeting of the NSQC, it was brought before the Committee that Awarding Bodies concerned had submitted proportionately much less number of revised Qualifications for approval of the NSQC. Taking note of the matter, the Committee had directed that of these qualifications, those received by NCVET on or before 15th September 2021 will be considered for renewal/ extension and qualifications not received by the mentioned date will not be considered for renewal/ extension.

4.3. In this regard, 965 Qualifications have been received out of which 157 qualification files have been approved in various NSQCs. The remaining 808 qualifications received at NCVET are at various stages of scrutiny. Keeping in view the requirement of two months' time for proper scrutiny of qualifications, as per the SOP on approval of qualifications, following is proposed:

- a) For all the qualifications received at NCVET till 15<sup>th</sup> of September 2021, an interim extension of validity be accorded till 31st December 2021 or till a decision is taken by the NSQC, whichever is earlier, subject to fulfilment of compliance with NSQF alignment norms.
- b) For all other qualifications, whose validity is due to expire on 30<sup>th</sup> September 2021 and which have not been received by NCVET from the submitting body/ Awarding body till 15<sup>th</sup> September 2021, would be presumed to be intentionally not being taken up or not required by respective SSCs for further extension/ renewal. These would accordingly be deactivated or archived. These qualifications can be reviewed and activated as and when specific request is received from submitting body/ Awarding body for revision of such qualifications.

**5. AGENDA ITEM NO 05: REQUEST FOR GRANT OF EXTENSION OF VALIDITY FOR THE QUALIFICATIONS DEVELOPED BY ADDITIONAL SKILL ACQUISITION PROGRAMME (ASAP), KERALA**

5.1. Four (4) Qualifications from Additional Skill Acquisition Programme (ASAP), Kerala were accorded NSQC approval as per the details mentioned below: -

5.2. ASAP Kerala has intimated that due to transition of the legal status of the organisation from a Government project to a Government Company, the revised Qualification files could not be submitted for grant of extension in time. They have now sought extension of validity for the above mentioned four (4) qualification files. NCVET had sought the data on trainings conducted w.r.t. these four Qualifications from ASAP and the details furnished by them is as mentioned: -

5.3. The following is proposed for consideration of NSQC: -

- a) Ex-post facto sanction is not recommended to be given for the above mentioned Qualifications. However, keeping in view that the qualification "Assistant Offset Printing Operator" is being run under the school education program, the approval for extension of validity of the course may be given till the end of the academic session of the mentioned batch i.e. till 31<sup>st</sup> March 2022 with a specific instruction that this is only applicable for the current ongoing batch in the vocational higher secondary educational schools.
- b) Approval for extension of validity is also recommended to be given to qualification "Communicative English Trainer" till the time the trainings for the ongoing batches are completed. However, w.r.t the trainings conducted on this qualification from 2<sup>nd</sup> Jan 2019

onward, ASAP Kerala may consider issuing their own certificate for the training done in this period. No NCVET approved certificate will be issued for the period mentioned above.

- c) For the two Qualifications, ie, "Certificate course in Hi Tech Farm management" and "Air Cargo Management Executive" the extension of validity is not recommended as ASAP, Kerala, has not rolled these qualifications for any training.
- d) ASAP Kerala may submit the revised Qualifications for approval based on laid down parameters on NSQF alignment of Qualifications along with the evidence of proof.

**6. AGENDA ITEM NO 06: REQUEST FOR GRANT OF EXTENSION OF VALIDITY TO ONE (1) QUALIFICATION OF HEALTHCARE SSC 'EMERGENCY MEDICAL TECHNICIAN' TILL MAY 2022.**

- 6.1. In the 6<sup>th</sup> NSQC held on 19<sup>th</sup> May 2015, the Committee had approved one Qualification namely 'Emergency Medical Technician-Basic' of healthcare sector. Subsequently, this qualification was provided extension till September 2021.
- 6.2. In the meanwhile, due to the Covid-19 pandemic and urgent nature of national requirement, the NSQC in its 8<sup>th</sup> meeting held on 25<sup>th</sup> May 2021, approved 6 crash courses, customised for frontline health workers, (launched by Hon'ble PM) for a period of one year. These courses are linked to already existing healthcare qualifications, referred to as base qualification and being implemented across India under PMKVY 3.0 under Special scheme wherein 1 lakh youth are envisaged to be trained & certified in both fresh skilling based on new crash courses and RPL.
- 6.3. Out of the 6 approved courses, one course, namely- 'Emergency Care Support' is linked to base qualification of 'Emergency Medical Technician-Basic'. HSSC has requested that the qualification 'Emergency Medical Technician-Basic' be granted extension till May 2022, to correspond to the validity period of crash course of - 'Emergency Care Support', post which SSC has indicated that they will withdraw this qualification and submit its revised/ updated version for approval of NSQC.

**7. AGENDA ITEM NO 7: EXTENSION OF ACTIVE QUALIFICATIONS OF SKILL COUNCIL FOR PERSONS WITH DISABILITIES (SCPwD) EXPIRING ON / BEFORE 30TH SEPTEMBER, 2021.**

7.1. SCPwD adopts NSQF aligned and NCVET approved qualifications and after mapping the qualifications with various types of disabilities submits to NCVET for approval before rolling out the training. The entire process takes approximately 6 months to one year. Till date, SCPwD has adopted 146 Qualifications from domain SSCs and after mapping them with the type of disabilities (like- Low Vision, Locomotor Disability, Speech & Hearing Impairment and Visually Impaired) has developed a total of 250 Qualifications.

7.2. In the 7<sup>th</sup>NSQC meeting held on 25th March 2021, 1859 qualifications were granted extension of validity till September 2021. Accordingly, the extension was also applicable to all such qualifications adopted by SCPwD till 30th September 2021. In order to cater to the changes, if any, w.r.t the revisions carried out by the domain SSCs, the Committee directed PwD SSC that in case of extension given to revised qualifications with changes, then SCPwD will need to seek further approval from NSQC within six months from the date of approval of the said Qualification. However, if the extension is accorded to the revised qualifications without any changes, the extension applies mutatis - mutandis to those qualifications adopted by SCPwD as well.

7.3. The SCPwD has requested for the following:

- a) In case of deactivation/withdrawal of any qualification/s that has been adopted by PwD SSC, an additional period of six (6) months over and above the deactivation date/withdrawal date of Qualification by the Domain SSC, may be granted to SCPwD.
- b) SCPwD may be allowed to decide whether to retain and continue training on the adopted Qualifications or withdraw in line with the Domain SSC, based on the demand of the industry for PwD training.

7.4. In view of the above, following is proposed before the Committee: -

- a). SCPwD be granted extension of validity for six months in respect of all the adopted Qualifications, from the date of approval or deactivation of the said qualifications.

b). SCPwD may be authorised to take decision on de-activation/ continuation of adopted Qualifications which have been deactivated/ withdrawn by the domain SSC. However, in case of continuation, SCPwD may provide suitable justification to NCVET for approval.
