4. AGENDA ITEM NO 04: Monitoring & Supervision process of Awarding Bodies

4.1 NCVET notification no. SD-17/113/2017-E&PW mandates a dynamic and robust monitoring mechanism to ensure that the standards of quality and reliability are maintained amongst all ABs. During the tenure of a recognized body both continuous and periodic evaluation of performance shall be undertaken based on clearly defined parameters and evidence.

4.2 As per para 4.3. of the Guidelines under Continuation Criteria, a recognized AB must ensure strong and effective data management system with respect to, inter-alia, the Qualifications for which the training is being conducted.

4.3 Hence it is proposed that details of the trainings conducted with respect to the NSQF aligned and approved qualifications being implemented through various Govt/fee-based schemes including the details of the Assessments and Placements in the respective qualifications be shared with NCVET **every quarter**. The first report for the quarter ending June 2022 be submitted to NCVET by **16 August 2022**. The template for the same is at **Annexure II**.
