1. AGENDA ITEM 01: Confirmation of the Minutes of 21st Meeting of the NSQC held on 28th July 2022

2. AGENDA ITEM 02: Action Taken Report on the decisions taken in the 21st Meeting of the NSQC

3. AGENDA ITEM NO 03: Realignment & Rationalisation of 150 DGT Qualifications (CTS)

3.1. The Committee in the 16th meeting of NSQC, had decided that all CTS and CITS courses of duration 1 and/or 2 years currently being offered to be rationalized from existing 1600 teaching hours to:

- a) 1200 Notional Hours (including Employability Skills (120 hours in case of 1 year course/ first year of the two-year course and 60 hours advanced employability skills in second year for two-year course).
- b) 150 hours of OJT/ group project for better industry alignment for job readiness.
- c) The students can also opt for an add on course of 240 hours (which could be one language course through NIOS for 10th/ 12th class certificate along with ITI certification or an add on short term course of up to 240 hours) as optional.

3.2. In addition, it was suggested that each qualification shall also include employability skills of 120 hours consisting of 12 modules which will have immense value to the trainee both as an employee as well as while exploring self-employment avenues as an entrepreneur.

3.3. Accordingly, 150 qualifications (CTS) have been standardized and rationalised in accordance with the decision of NSQC and submitted by DGT. While majority of the learning outcomes have been converted and mapped to the existing NOSs, there are few Qualifications where the work is in progress to either realign the LOs to existing NOSs and in the absence of existing NOSs for the LOs, relevant new NOSs have either been developed or are in the process of being developed. However, DGT has the complete curricula and material to cover such NOSs under development.

3.4. Keeping in view the decision of NSQC regarding rationalization of all existing NSQF aligned and approved qualifications as per the new rationalised NSQF norms and adoption of standard Employability Skills Modules developed (for 30 Hrs, 60 Hrs 90 Hrs and 120 Hrs) as also to integrate the NSQF aligned and approved qualifications with provisions of National Credit Framework (NCrF), DGT has submitted 150 Qualifications (CTS) which were earlier approved in-principle by NSQC in 16th NSQC, for concurrence as DGT are to be implemented from the ensuing academic session commencing from Sept 2022.

3.5 All the above mentioned DGT qualifications have been deemed approved and Qualification (NQR) code allotted with the following provisions:

- a) The Learning Outcomes mapped to the existing NOSs have been deemed approved as they are already NSQF aligned and approved in various NSQCs. Any change required in the NOSs to the extent of 20% is already allowed in the NCVET guidelines and DGT may go ahead with the same.
- b) The DGT shall complete the mapping and conversion of remaining Learning Outcomes into NOSs under intimation to NCVET. For any modification in the number of hours for individual PCs etc is to be decided by DGT.
- c) Where LOs cannot be mapped to existing NOSs, new NOSs be developed by DGT for such LOs. DGT should develop model curriculum for the new NOSs in a time bound manner and as per the priority of their teaching schedule in the upcoming session and intimate to the NCVET for uploading the same on NQR.
- d) The status of all CTS qualifications is at the Annexure attached. All qualifications may be restructured/ reorganised by DGT and submitted to the NCVET '**on priority**' for uploading the same on NQR. Even if the NOS names and numbers for the new NOSs have not been finalised, DGT may submit the same indicating timelines against each NOS in the qualification for uploading on NQR.

3.6 DGT has submitted their commitment to comply and abide by the guidelines conveyed on the restructuring of the DGT qualifications as per the Minutes of the 16th NSQC Meeting held on 24th February 2022

The matter is placed for the ratification of the NSQC.

4. AGENDA ITEM NO 04: Submission of Qualifications for NSQF Alignment

4.1 A total of one hundred four (27 New and 77 Revised) qualifications have been received till 30th June 2022. Of these, 84 qualifications are being considered for placing in the 22nd NSQC. The remaining twenty (20) qualifications could not be considered due to non-submission of complete documents. The details of 84 qualifications under consideration are as under: -

- a) New QFs - 20
- b) Revised QFs- 64.
