1. AGENDA ITEM 01: Confirmation of the Minutes of 22nd Meeting of the NSQC held on 25th August 2022

3. AGENDA ITEM NO 03: GRANT OF REGULAR VALIDITY TO THE FOUR QUALIFICATIONS OF AWARDING BODY LOGISTICS SECTOR SKILL COUNCIL (LSC)

3.1 In the 17th meeting of NSQC held on the 31/03/2022, five (05) revised qualifications of the Logistics Sector Skill Council were aligned to NSQF and **approved with a validity period of six months** as the number of trainings was less than 100. The Awarding Body was asked to conduct minimum 1000 trainings in each qualification and submit the details to NSQC within 06 months i.e, by 30th November 2022 for grant of regular extension of 3 years by the NSQC.
