AGENDA ITEM No 04 : CORRECTION IN NEXT REVIEW DATE OF TWO QUALIFICATIONS OF HYDROCARBON SSC APPROVED IN 25TH NSQC MEETING HELD ON 25.06.2020

1.Two qualifications of Hydrocarbon SSC i.e., Process Instrument Operator (Oil & Gas), {HYC/Q6201} and Line Patrolling Man (Oil & Gas) {HYC/Q6401} were approved by NSQC in its 25th meeting held on 25.06.2020.

2. Hydrocarbon SSC has informed that that qualification review date in the Q-File were inadvertently mentioned incorrectly by them and the one qualification has got deactivated on the Skill India Portal (SIP) which has affected issue of the assessment and certification of ongoing batches.
3. There is no change in the qualification except the next-review-date, which is proposed to be of three years from the date of approval of qualification.
4. NSQC may consider the proposal for correction of the next-review date of the qualifications mentioned as under:-

AGENDA ITEM No 5: CUSTOMIZED COVID SPECIFIC CRASH COURSES IN HEALTHCARE SECTOR

1. Keeping in view the present pandemic-COVID situation and as per the directions of Ministry of Skill Development and Entrepreneurship (MSDE), Healthcare Sector Skill Council (HSSC) has identified the desired competencies to meet the urgent requirements of pandemic. The identified competencies are part of the six National Skills Qualification Committee (NSQC) approved Qualifications in Healthcare Sector which are listed below:

2. HSSC has adopted the National Occupation Standards (NOS) from the above mentioned already approved six Qualifications and after mapping them with current pandemic demand, have developed shorter duration courses that are proposed to be

provided as crash courses to trainees under Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0).

3. Following this HSSC has submitted the below mentioned six crash courses (comprising of NOSs only) for approval. (The details of the crash courses are placed at Annexure-III)

- (a) "COVID frontline Worker (Basic Care Support) Mapped to General Duty Assistant".
- (b) "COVID Frontline Worker (Home Care Support) Mapped to Home Health Aide".
- (c) "COVID Frontline Worker (Advanced Care Support) Mapped to GDA Advanced (Critical Care)".
- (d) "COVID frontline Worker (Sample Collection Support) Mapped to Phlebotomist".
- (e) "COVID Frontline Worker (Emergency Care Support) Mapped to Emergency Medical Technician- Basic".
- (f) "COVID Frontline Worker (Medical Equipment Support) Mapped to Medical Equipment Technology Assistant".

4. Further, as per the National Skills Qualification Framework (NSQF) alignment process, the comments, concurrence of MoHFW have also been sought on the six crash courses. However, the same is awaited.

The matter is placed before the Committee for further direction.
