**3. AGENDA ITEM NO 3: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT**

4.1. A total of 254 qualifications (69 new and 185 revised) were received from 1<sup>st</sup> October to 31<sup>st</sup> October 2021. However, 200 qualifications are being considered for placing in the 14<sup>th</sup> NSQC. The remaining 55 qualifications (6 new and 49 revised) are not being considered for this NSQC due to either non submission of complete documents, delay in receipt of response to the observation made and/ or rationalization of qualifications being undertaken by the SSCs. The details of Qualifications under consideration are as under:-

- a) New QFs - 63.**
- b) Revised QFs- 137.**

**4. AGENDA ITEM NO 04: ARCHIVING OF NON-ACTIVE QUALIFICATIONS (FOR INFORMATION OF THE COMMITTEE)**

4.1. In the 12<sup>th</sup> Meeting of NSQC held on 30<sup>th</sup> September 2021, extension of validity was accorded to 992 revised qualifications till March 2022. The Committee decided that 343 qualifications which had undertaken either zero (0) or less than 100 trainings shall be required to submit a commitment for conducting a minimum training till the extension period.

4.2 The Committee had also decided that all other qualifications which had not been received by NCVET as on 30<sup>th</sup> September 2021 shall be archived. However they can be reviewed for activation/ revision as and when the concerned awarding body submits any proposal with evidence of need and sufficient justification for the same. Accordingly, 190 qualifications have been identified to be archived.

**5. AGENDA ITEM NO 04: SIMPLIFICATION OF QUALIFICATION FILE TEMPLATE AS PART OF SIMPLIFICATION OF NSQF ALIGNMENT PROCESS**

5.1. NCVET Notification SD-17/113/2017-E&PW dated 5<sup>th</sup> December 2018, mandates NCVET to undertake NSQF alignment and approval of qualifications. Accordingly, NCVET has laid down a detailed SOP and process for NSQF alignment and approval of qualifications submitted by various submitting bodies. Amongst the many steps being taken to simplify the NSQF alignment and approval process for an expeditious approval of qualifications, it has been decided to simplify the Qualification template to make it more objective, simple and user friendly. Two templates have been developed:

- a) The Qualification file template relating to the Unorganised sectors, such as traditional heritage, and handicraft sectors, to address the requirements of the District Skill Committees (DSCs) for their local skill clusters and as required for the School Boards offering vocational education subjects.
- b) The Generic Draft Qualification file template for all other sectors. This is work in progress for any comments and the final version would be brought before the NSQC for approval after detailed stakeholders' consultations.

## 6. AGENDA ITEM NO 6: APPROVAL OF QUALIFICATIONS SUBMITTED BY A REPUTED ENTITY OTHER THAN RECOGNISED AWARDING BODY

6.1 Many times Government, reputed industry as well as private sector organisations approach NCVET for approval of their well-designed & developed high quality qualifications which are customised to the industry needs (e.g. i-phone manufacturing, electric vehicle manufacturing etc.) and for skills in high demand in the market by the Industry and have bright prospects of employment/entrepreneurship opportunities. As we are aware, the development of high quality qualification process is very resource intensive in terms of manpower, effort, cost as well as time consuming.

6.2 Under the existing process/ procedure for qualification approval NCVET permits only its recognised awarding bodies to submit the qualifications for NSQF alignment and approval in NSQC meetings. In order to take advantage of the available high quality qualifications, which are well developed and customised to the industry needs, it is essential that NCVET allows such Government department/ agency, reputed industry as well as private sector organisations to bring in their qualifications for approval by NSQC and place these on the National Qualifications Register (NQR) to be available to the entire skilling eco-system. This will also break the monopoly of agencies, bring in the required competitiveness and lessen the burden on the Awarding Bodies for development of the industry ready quality skill qualifications.

6.3 Therefore, it is proposed that NCVET should consider allowing the Government, reputed industry as well as private sector organisations to bring in their high quality industry driven qualifications for being considered for NSQF alignment and NSQC approval, subject to fulfilling the NCVET norms and the following additional conditions:

- a) The Qualification should be well-designed & developed, with high quality content which are customised to the industry needs;
- b) The Qualification should be relating to the skills which are in high demand in the market, the future skills required by the Industry having bright employment prospects or entrepreneurship/ self-employment opportunities;
- c) The qualification approved under this category would become part of the National pool of qualifications in NQR under the ownership of NCVET and shall be available to all other recognised Awarding Bodies for adoption as per adoption guidelines.
- d) The initial validity of such qualifications may be for a period of one year which shall be reviewed for its usefulness and relevance and based on the outcome subsequent grant of regular validation period of three years may be considered;
- e) NCVET shall become the owner of such approved qualifications which can also be implemented through existing awarding bodies in the skill ecosystem. The detailed modalities would be worked out and notified by NCVET.
- f) This arrangement may be approved as a pilot to be reviewed after one year.
- g) All common NOSs, like, health & safety, Digital Literacy , Team Building ,etc, developed either by NCVET or by Awarding Bodies will form part of the common pool of NOSs and will be anchored and owned by NCVET for adoption by recognised Awarding Bodies across all sectors as applicable.
