**1. AGENDA ITEM 01: CONFIRMATION OF MINUTES OF 16<sup>th</sup> MEETING OF NSQC HELD ON 24<sup>th</sup> FEBRUARY 2022**

Minutes of the 16<sup>th</sup> Meeting of NSQC held on 24<sup>th</sup> February 2022, were circulated. No comments have been received.

**2. AGENDA ITEM 02: ACTION TAKEN REPORT ON DECISIONS TAKEN IN MEETINGS OF NSQC**

**2.1 Action Taken Report on the decisions taken in the 15th NSQC meeting:**

**2.2 Action taken report for decisions taken in 16<sup>th</sup> NSQC:**

A total of 198 (74 new and 124 revised) qualifications were considered in the 16<sup>th</sup> NSQC. 192 (70 new and 122 revised) qualifications were **approved**, 05 qualifications (4 new and 1 revised) were **conditionally approved** and 01 qualification was **not approved**. The action taken report w.r.t 16<sup>th</sup> NSQC meeting is given below:

**3. AGENDA ITEM NO 3: APPROVAL OF TWO (02) QUALIFICATIONS OF HEALTHCARE SECTOR- 'GENERAL DUTY ASSISTANT', 'HOME HEALTH AIDE' FOR IMPLEMENTATION IN SCHOOLS**

3.1. In the 6th meeting of NSQC held on 19.5.15 under erstwhile NSDA, the Qualification 'General Duty Assistant', referred as Version 1, (NSQF Level 4) with 420 notional hours was approved. This qualification was taken from NQR and implemented by the Department of School Education for classes 9-12 in consultation with health care SSC and NSDC but without any intimation to NSDA/NCVET.

3.2 Consequent to the policy decision taken by MoHFW with respect to the skilling programs, it was decided that the term 'aide' is appropriate for a candidate with minimum 10<sup>th</sup> standard qualification and the term 'assistant' is appropriate for a candidate with minimum 12<sup>th</sup> standard qualification. Also, the notional hours of the qualification 'general duty assistant' were revised to 1000 by adding 580 hours of OJT. Thus, revised qualification, referred as, version 2', was

approved in the 5th meeting of NSQC under NCVET held on 29.1.21 wherein the version 1 was to be replaced by the version 2 as mentioned above.

3.3 Further to the decision of NSQC regarding archiving of version 1 of the qualification, the Department of School Education raised a concern that it is practically not possible for them to implement a course of 1000 notional hours at school level. DoSEL thereby requested that they may be allowed to complete the ongoing training of students, already enrolled, under version 1 and if possible, permitted to continue with this version for the new academic session as well. Since the qualifications pertain to the regulated sector, they were referred to MoHFW for their views.

3.4 MoHFW has communicated that the nomenclature of qualification, version 2 **being offered in schools**, be modified as under:

- a) **‘General Duty Assistant’(V2) - To ‘General Duty Aide-Trainee/ Inductee’ and;**
- b) **‘Home Health Aide’(V2) – To ‘Home Health Aide Trainee/Inductee’.**

3.5 Further, to get the NCVET certificate of General Duty Aide or Home Health Aide, a student would have to undertake additional training in the form of OJT of 580 hours and 640 hours respectively, after completion of school education. Further, the prescribed arrangement shall only be applicable for the academic year 2022-23, for students already enrolled.

3.6 Based on the recommendations of MoHFW, the following is proposed by NCVET:

- a) The Version 2 of the above-mentioned qualifications to be approved for schools with the revised names: General Duty Aide- Trainee and Home Health Aide- Trainee, both with 420 notional hours each.
- b) Should the student desire to get the NCVET certificate of General Duty Aide or Home Health Aide, they will have to undergo training in the form of OJT of 580 hours and 640 hours respectively, as required under NSQF aligned and approved Version 2 of the said qualifications.
- c) The aforesaid proposal shall be applicable only for already enrolled batches till the academic year 2022-23.

The snapshot of qualification is at Annexure IV.

**The above proposal has been approved, on file, by the Chairperson, NSQC and is submitted before the Committee for ratification.**

3.7 With reference to the proposal above, it may be noted that with the New Education Policy, 2020, and current ongoing work of formulation of unified credit framework (UCF) wherein vocational education is being integrated with general education and provision has been made for accumulation and redemption of credits in a common credit bank, it is visualised that more such NSQF aligned and approved qualifications may be included in the schools. Thus, current number of 62 courses being run under ‘Samagra Shiksha’ may also increase. Presently for implementation in Schools, NSQF aligned and approved qualifications are taken from the NQR and adapted to the requirements of the school. To streamline the existing practice, it is proposed that a joint working group be constituted with members from DoSEL and select

stakeholders, to formulate NCVET Guidelines on mechanism for implementation of NSQF aligned and approved qualifications in schools.

**4. AGENDA ITEM NO 4: GRANT OF EXTENSION TO REVISED QUALIFICATIONS VALID TILL 31<sup>ST</sup> MARCH 2022**

4.1 In the 12<sup>th</sup> meeting of NSQC held on 20<sup>th</sup> September 2022, extension of validity was accorded to 992 qualifications of various Sector Skill Councils till 31<sup>st</sup> March 2022. In the meanwhile, concerned SSCs were to rationalise, revise and resubmit qualifications to NCVET for NSQF alignment and approval by NSQC. Further, in the 13<sup>th</sup> meeting of NSQC, it was also decided that all such qualifications having less than 100 numbers of training shall be required to submit a commitment of conducting a minimum no. of trainings till 31<sup>st</sup> March pending/failing which the qualifications shall be archived. Accordingly, 70 qualifications have been archived by NCVET due to non-submission of the written commitment by the concerned Awarding bodies. Further, NCVET has received 78 qualifications as on date, duly revised or rationalised.

4.2 Keeping in view the gestation period of 60 days for detailed scrutiny and consultation with SMEs and stakeholders, it is proposed that of the qualifications which were granted extension till 31<sup>st</sup> March 2022, those which have been submitted to NCVET as on 31<sup>st</sup> March 2022, be accorded an interim extension of 2 months i.e. till 31<sup>st</sup> May 2022 or till a decision is taken by NSQC on them, whichever is earlier. Further it shall be presumed that those awarding bodies who have not submitted their qualifications expiring on 31<sup>st</sup> March 2022 do not feel necessary to run them in the skill ecosystem and accordingly these shall be deactivated w.e.f. 01 April 2022. The list of qualifications proposed for two (02) month extension is at **Annexure II.**

**5. AGENDA ITEM NO 5: RATIFICATION OF 14 QUALIFICATIONS OF AGRICULTURE SSC**

5.1 Based on the standardization of notional hours, entry criteria and other parameters of Qualifications approved in 16<sup>th</sup> NSQC meeting held on 24<sup>th</sup> February, 2022, the Agriculture Sector Skill Council (ASCI) has proposed the additional entry requirement criteria options for incorporation in the fourteen (14) approved Qualifications pegged at level 3 and 4 respectively, to ensure wider outreach, better inclusivity and clarity for the users. The additional entry requirement criteria for incorporation are as below:

NSQF Level	Additional Entry Requirement requested for incorporation in approved QF
3	8 <sup>th</sup> Class pass and pursuing continuous regular schooling (9 <sup>th</sup> and 10 <sup>th</sup> )
4	10 <sup>th</sup> Class pass and pursuing continuous regular schooling (11 <sup>th</sup> and 12 <sup>th</sup> )

The proposed addition is in line with the parameters enlisted in the standardized entry criteria as brought out in 16<sup>th</sup> NSQC, which can be viewed in the MoM of 16<sup>th</sup> NSQC at NCVET website. The details of fourteen Qualifications listing out their level, NSQC approval date, entry requirement as approved in the NSQC and additional entry requirement requested is placed at **Annexure-III**.

**The matter is placed before the Committee for ratification.**

**6. AGENDA ITEM NO 6: RATIFICATION OF THE PROPOSAL FOR MODIFICATIONS IN THE ENTRY CRITERIA OF QUALIFICATION – “INLAND CAPTURE FISHERMAN CUM PRIMARY PROCESSOR” OF AGRICULTURE SSC**

6.1 The Qualification- “Inland Capture Fisherman cum Primary Processor” submitted by Agriculture Sector Skill Council (ASCI) was approved in the 14<sup>th</sup> NSQC meeting held on 30<sup>th</sup> December 2021.

6.3 In the recently approved standardization of qualifications norms for NSQF alignment and approval of Qualifications as approved in 16<sup>th</sup> NSQC meeting held on 24<sup>th</sup> February, 2022, “Ability to read and write” has been included for NSQF alignment of qualifications upto Level 3. The Agriculture Sector Skill Council (ASCI) has submitted a proposal requesting NSQC to bring down the level of the already approved qualification from 4 to 3 and add “Ability to read and write” in the entry requirement criteria. The proposal if approved, corresponding changes w.r.t. the NSQF level and notional hours will be made in the aforesaid Qualification accordingly. The amended details are as below:

The above-mentioned modification was accorded approval by the Chairperson 'On File' keeping in view the urgency. The matter is submitted for ratification by NSQC.

**7. AGENDA ITEM NO 7: ADHERENCE TO TIMELINE FOR OBTAINING CLEARANCE/RESPONSE/COMMENTS FROM LINE MINISTRY ON THE QUALIFICATION FOR NSQF ALIGNMENT & APPROVAL**

7.1 In the 19<sup>th</sup> NSQC meeting (under erstwhile NSDA) held on 5.2.18, it was agreed upon to obtain Line Ministry concurrence/consultation before submitting qualifications by Awarding Bodies for NSQF alignment and approval of qualification in NSQC. Accordingly, all ABs/SSCs bringing their qualifications were requested to consult their concerned line ministry for their views/concurrence on their qualifications. **This was particularly mandatory for sectors falling in regulated sector like healthcare and aviation.**

7.2 NCVET and various Awarding Bodies have experienced that in case of certain Line Ministries, the response has either been unduly delayed or some conditions have been imposed even for offering/giving comments/clearance. Case in point is the response from Tourism Ministry wherein they had asked for ₹15,000 per qualification as evaluation charge for getting the qualifications submitted by SSCs from some consultant. Hence, in the 3<sup>rd</sup> meeting of NSQC (under NCVET) held in September 2020, it was decided that **barring the regulated sectors like healthcare and aviation** where line ministry concurrence remains an essential criteria, for all other sectors, a time line of four weeks was to be given to the for concerned Line Ministries for giving clearance/response/comments after which the qualifications would be put up before NSQC subject to the concerned awarding body submitting the evidence of proof related to communication made with their concern line ministry.

7.4 A similar concern has been observed in case of Ministry of Health and family welfare (MoHFW). As brought out by SSC concerned, there has been prolonged delays in responses from MoHFW due to which the healthcare sector skill council has not been able to submit the qualifications related to health sector even after having got the endorsement from the reputed health institutes from public and private sectors like AIIMS, Medanta, Sir Ganga Ram, Narayana Health, Fortis etc. some of the examples are as below:

7.3 In the light of the facts enumerated above following points are proposed for the consideration of NSQC:

- a) A written communication be sent from Ministry of Skill Development and Entrepreneurship (MSDE) to all ministry dealing with skill related qualifications to accord PRIORITY in responding to the communication made with them either by concerned Awarding Body or NCVET and clear the same within the stipulated 4weeks of having initiated the communication. However, in case of the regulated sectors like Aviation and health the response time can be increased to 8weeks or else the Line Ministry may specify the time required by them to respond, by the next NSQC meeting. For facilitating the process, in case no response is received from the Ministries concerned by the next meeting of the NSQC, the 8 weeks deadline would apply for such regulated sectors instead of 4 weeks for the other Ministries.
- b) The concerned Ministries dealing with the skill ecosystem maybe requested to nominate a nodal officer (government officer) and share their contact details with NCVET and concerned Awarding Body for ease of connecting and communicating.

**8. AGENDA ITEM NO 8: GRANT OF EXTENSION TO QUALIFICATIONS ADOPTED BY SCPwD DUE TO NON-SUBMISSION OF CORRESPONDING REVISED QUALIFICATIONS BY THE DOMAIN SSCs**

8.1 In the 7<sup>th</sup> NSQC held on 25<sup>th</sup> March 2021, it was decided that SCPwD shall be given additional 06 months to submit their revised qualifications post approval of such related revised qualifications by the respective domain SSCs.

8.2 SCPwD vide letter dated 3<sup>rd</sup> March 2022 (letter no. SCPwD/NCVET/2022/08) has drawn attention to the fact that there are a number of adopted Qualifications of the respective domain SSCs which have their validity date till 31<sup>st</sup> March 2022 and are yet to be revised by the domain SSCs in view of their rationalization/review/standardization of qualifications. Further there may be a possibility of such qualifications not being revised at all by the respective domain SSCs. Under such eventuality, there is a period of uncertainty in respect of revision of such adopted qualifications by SCPwD. Hence, they have submitted the request that they should be given a window period of one year to obviate the current process of quick deactivation and subsequent prolonged reactivation on the Skill India Portal (SIP).

8.3 Keeping in view the request proposal of SCPwD, following is proposed before the committee:

- a) The qualification adopted by SCPwD from the respective domains SSCs is further modified using its own expository to align these qualifications to be suitable for use by the differently abled trainees. Further, in the light of the new standardised norms of qualification issued vide 16<sup>th</sup> Minutes of Meeting, all such qualifications are being reworked with respect to their performance criteria like entry criteria, reducing the NSQF level, number of notional Hours OJT & apprenticeship hours etc meaning thereby it is as good as a new qualification. Hence it is proposed that after adoption of such qualifications by SCPwD, they may be considered as a new qualification for them and should be allotted separate qualification code on NQR. Thereafter SCPwD may follow the normal procedure of revision/rationalization/deactivation as the case may be and not be dependent on the domain SSCs. or
- b) Alternatively, proposal of one year extension as submitted by the SCPwD be considered. Or
- c) No change be made to the 6 months existing timeline given to them at present and the status may be reviewed after 4 months.

**9. AGENDA ITEM NO 9: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT**

9.1 A total of 299 qualifications (88 new and 211 revised) were received from 1<sup>st</sup> January to 31<sup>st</sup> January 2021. Of these, 287 qualifications (83 new and 204 revised) are being considered

for placing in the 17<sup>th</sup> NSQC. The remaining 12(03 new and 09 revised) qualifications could not be considered for this NSQC due to non-submission of complete documents. The details of 286 files under consideration are as under: -

- a) New QFs - 83
- b) Revised QFs - 204

A total of two eighty-six (287) Qualifications are being placed for consideration of NSQC. Summary of the Qualifications is as below: -
