3. AGENDA ITEM NO3:MECHANISM FOR IMPLEMENTATION OF NSQF ALIGNED QUALIFICATIONS IN SCHOOLS

3.1. In the 17th meeting of NSQC held on 31st March 2022, NSQC was informed that DoSEL as on date, selects already aligned and approved qualifications from the NQR and adapt all such qualifications as per the requirement of the school education and implement them. While adapting the qualifications the DoSEL carries out certain modifications in the qualifications which lead to non-concordance with the original qualification approved. The present system of adoption of qualifications by DoSEL from the NQR creates information gap leading to difficulty in implementation of NSQF aligned and approved qualifications by the school boards. Hence it was felt that a simple but robust mechanism for adoption of NSQF aligned and approved qualification from NQR should be formulated to remove this information gap and to ensure smooth implementation of NSQF aligned and approved qualifications at school level. Hence NSQC had advised that a joint working group be constituted with members from DoSEL, CBSE, NCERT and PSSCIVE to formulate **‘Guidelines on Mechanism for implementations of NSQF aligned and approved qualifications in schools.**

3.2. Accordingly, a meeting of the joint working group was held on 12th April 2022, under the chairpersonship of Dr. Vinita Aggarwal, Executive Member, NCVET wherein the following decisions in this regard were taken:

- a) PSSCIVE will be the nodal body for adopting qualifications under Samagra Shiksha for implementation across the country including adoption of qualifications in consultation with concerned ABs.
- b) PSSCIVE shall ensure the following while adopting the qualifications:
 - i) The qualifications being adopted for implementation in schools to have at least 2 years of validity left.
 - ii) If a qualification expires in-between, after completion of the ongoing batch, it shall be ensured that thereafter the latest version of the qualification is implemented in schools.
 - iii) In case of regulated sectors like Health and Aviation, only the relevant and latest Qualifications shall be implemented.
- c) It was also agreed that DOSEL may suitably amend the already exiting SOPs for selection of qualifications to be adopted in schools under various

government schemes keeping, amongst others, the above in view. In so far as the revised qualifications with electives which have been NSQF aligned and approved, are concerned, PSSCIVE/DoSEL may choose specific electives as per their requirement and implement the qualifications. A detailed order of implementation in this regard shall be issued by NCVET.

- d) PSSCIVE may submit the adopted qualifications, as per the NSQF norms, for approval of the NSQC.
- e) A new section on NQR may be created wherein all such qualifications which are adopted by school education shall be reflected and shall be only applicable for skilling in schools. All school boards can select NSQF aligned and approved qualifications reflected in this sector as relevant to them.
- f) With respect to assessment and certification of the adopted qualifications, the following options may be considered:
 - i) All such NSQF aligned and approved qualifications being implemented in schools under Samagra Shiksha whose assessment is done by NCVET recognized AAs through the respective Awarding Bodies and certification of all successful students/trainees is done individually by the Awarding Body or jointly by School Boards and the Awarding bodies concerned, NCVET certificate shall be issued.
 - ii) In case the Central Board/State Board applies for/ obtains dual body recognition as Awarding Body and Assessment Agency and implements training, assessment, and certification of NSQF aligned and approved qualifications, they may directly issue the prescribed NCVET Certificate **subject to satisfactory assessment.**
 - iii) However, if the Central Board/State Board implements NSQF aligned and approved qualifications without following any of the above two options, they may issue certificate having the logo of skill India only. NCVET Certification, in such an eventuality shall not be issued in the instant case.
- g) As the validity of NSQF aligned and approved qualifications are generally for 3 years, **PSSCIVE maybe be given an additional one year of validity over and above the original validity** in respect of all such qualifications adopted to enable transition within the school ecosystem. This, however, **shall not be applicable for qualifications falling within the regulated sectors like healthcare and aviation.**
- h) It was also agreed upon by all the members that it shall be mandatory to include the employability skills (various modules of 30 hrs, 60 hrs, 90 hrs and 120 hrs, currently work under progress) as applicable in the job roles with various NSQF levels. The PSSCIVE informed that they already have an employability NOS included in the qualification however, both PSSCIVE and DoSEL agreed that they shall review the content of the NCVET employability modules and suitably modify their employability NOSs and include in their qualifications being run under Samagra Shiksha in the schools.

4. AGENDA ITEM NO 04: STANDARDISATION OF ASSIGNING CODES TO NSQF ALIGNED AND APPROVED QUALIFICATIONS

4.1 All the qualifications are submitted to NCVET for NSQF alignment and approval through NSQC. After approval, these approved qualifications are assigned a unique qualification code and uploaded on the National Qualifications Register (NQR) for implementation in schemes & other programs across the skill development ecosystem.

4.2 The Standing Operating Procedure being followed is explained in succeeding paras. These codes are alphanumeric and reflect the following: -

- a) Year of NSQF alignment & approval.
- b) Sector.
- c) Name of Awarding Body.
- d) Overall Serial (sequential) Number.

4.3 Generally, a Qualification has a validity period of 3 years (may vary in a few specific cases). To maintain currency and relevancy of the qualification wrt technological changes, industry needs etc, after expiry of the validity period, the qualification is resubmitted, duly revised (with or without changes) by Awarding Body for review at NCVET and accordingly granted approval of NSQC for continuation for next 3 years or as the case may be. **As per the current practice, a new code is assigned to a Qualification each time it is revised and approved by NSQC.** This leads to assignment of multiple codes to the versions of the same qualification. Following drawbacks have been observed as also reported by various Sector Skill Councils in the current qualification coding mechanism during its implementation in the VET system:

- a) Multiple Codes for the versions of the same Qualification leading to implementation issues in Government Schemes.
- b) Multiple qualification codes for a single qualification create technological challenges on IT enabled platforms and portals for its reflection and accounting.
- c) Multiple codes create ambiguity in understanding amongst stakeholders such as trainees, employers, training providers and industry.
- d) Same qualification upon each revision having been assigned a new code, in effect, leads to erroneous representation of actual overall number of NSQF aligned and approved qualifications in the overall national skill ecosystem.
- e) This coding has no provision for reflecting NOSs, micro-credentials, multi-killing, cross-sectoral skilling, horizontal NOS, flexi qualifications for apprenticeship etc.

4.4 In order to overcome these issues being faced during implementation as listed above, **a rationalised mechanism of coding for the qualifications along with NOSs**

has been formulated. The Code being assigned to a qualification/NOS shall have two elements:

- a) **Static/ Fixed/ Standing Component:** This is a unique and constant number assigned to qualification/NOS which will remain uniform till the qualification remains valid. This shall be used to identify the qualification/NOS throughout its implementation across schemes by various stakeholders. The same code shall be used for record keeping and uploading on various portals. This code will have following components:
- i) Type – There are multiple types of qualifications and NOSs which shall be represented by different codes as below:

- ii) NSQF Level of the qualification- This shall be reflected as **Lx** (x ranging from 1 to 8).
- iii) Sector – Name of the Sectors as per NCO classifications.
- iv) An Overall Running Serial number – number depicting the overall sequence at which it is approved actually indicating the total number of qualifications approved till date.
- b) **A Dynamic/ Changing Component:** These are additional descriptive components which shall be added to provide the additional information/important qualification description relating to each static code of the qualification. This code will be reflected on the NQR over and above the static code thereby clearly establishing the static and dynamic parts of the code for better understanding in the ecosystem. Components of the dynamic element of the code shall be as follows:
- i) Year of NSQF original alignment & approval or the Revision – In YYYY format.
- ii) Version of the Qualification i.e., how many times this qualification has subsequently undergone revision and approved by NSQC – This shall be reflected in **VX** (X ranging from 1 to no of times a qualification has been revised)
- iii) Version depicting upto 20% flexibility if introduced by the Awarding body (AB)/ Adopting Body in the qualification – This shall be reflected in V.X (y) where y depicts the changed version as per the flexi qualification provisions.

- iv) Name of the Awarding Body who developed the qualification.
- v) Number of Elective (in case of a qualification offering electives) – this shall be depicted as **EX** (X ranging from 1 to the number of electives available)

4.5 Codes for NOSs: Similarly, codes for NOSs shall also be assigned with static and dynamic elements as described above.

4.6 Reflection on NQR: The underlined portion in the above code is the static code of the qualification and rest is the dynamic code which shall only be reflected on the NQR. With each component of the dynamic code a drop-down menu on NQR shall facilitate the information about the qualification & NOS as below:

4.7. Portability of the qualification to Skill India Portal (SIP): The National Qualification Register (NQR) shall be the national official repository of all the NSQF aligned and approved qualifications for authenticity of the data which shall be operated and maintained by NCVET. Once the NSQF aligned and approved qualification is uploaded on NQR, it shall be ported to SIP through API integration (which is under development) in the same format with same information attributes, till such time the process of porting of qualifications from NQR to SIP shall continue mutatis-mutandis.

5. AGENDA ITEM NO 5: REQUEST FOR EXTENSION OF VALIDITY OF 3 QUALIFICATIONS: TOURISM SSC

5.1 In the 11th meeting of NSQC, held on 31st August 2021, three qualifications of Tourism SSC were given approval for six months i.e., till 28th February 2022 subject to fulfilling the requisite number of trainings and submission of the evidence of training conducted for seeking further extension.

Accordingly, the SSC has now submitted the details of training conducted/student enrolled and has requested for consideration of three-year extension of validity for the

below mentioned qualifications upto 31st August 2024. The training details are as below:

6. AGENDA ITEM NO 6: SUBMISSION OF QUALIFICATIONS BY JAN SHIKSHAN SANSTHAN FOR NSQF ALIGNMENT

6.1 The Jan Shikshan Sansthan, a scheme of Ministry of Skill Development and Entrepreneurship, is implemented through the NGOs with beneficiaries spread across the country. The mandate of the scheme is to provide vocational skills in non-formal mode to non-literate, Neo-Literate, and school dropouts within the age group 15years to 45 years with priority groups being Women, SC, ST and PwD.

6.2 The Directorate of JSS has submitted their expression of interest for being recognised as an awarding body by NCVET. As per the Govt mandate on the subject, the concerned body also has to submit their qualifications for NSQF alignment and approval. DJSS has indicated that they are in process of finalizing a number of qualifications and the same shall be presented to NSQC as and when they are ready. However, since there is an urgent requirement of implementing the training program on the qualification '**Assistant Dress Maker**', the same is placed before NSQC for Alignment and approval. The detailed summary of the qualification is as below:

7. AGENDA ITEM NO 7: APPROVAL OF 3 QUALIFICATION OF SPORTS SSC

7.1. The 17th Meeting of NSQC held on 31st March 22 did not grant approval to 3 qualifications of sports SSC namely 'Self Defence Facilitator', '**Early Age Physical Activity Facilitator**' and '**Primary Age Physical Activity Facilitator**' owing to the issue of nomenclature of the qualifications and its modalities of conduct. The NSQC was of the view that the name of the qualifications does not appropriately reflect the purpose of the Qualification.

7.2. NSQC further instructed that a separate meeting be held with Sports SSC in consultation with representatives from CBSE and department of school education to decide the modalities of implementing such qualifications. Once a consensus is reached between the SSC, NCVET and CBSE/ DoSEL, the qualifications shall be presented for approval at the earliest as the same are to be offered from the next academic session.

7.3 Accordingly, a meeting was held on 12th April 2022, with representation from DoSEL, PSSCIVE and sports SSC, wherein a consensus was reached on removing the word 'facilitator' from the qualifications and replacing it with word 'Assistant'. The qualifications are being placed again with the amendments for NSQC approval.

The details of the qualification are at Annexure I.

8. AGENDA ITEM NO 8: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

8.1. A total of 59 qualifications (27 new and 32 revised) were received from 1st February to 29th February. Of these, 56 qualifications (**25 new and 31 revised**) are being considered for placing in the 18th NSQC. The remaining 10 qualifications (7 new and 13 revised) could not be considered for this NSQC due to non-submission of complete documents. The details of 62 files under consideration are as under: -
