**3. AGENDA ITEM NO 3: ACCORDING APPROVAL TO FOREIGN LANGUAGE COURSES
SUBMITTED BY ENGLISH AND FOREIGN LANGUAGES UNIVERSITY HYDERABAD
DULY RECOMMENDED BY UGC**

3.1 In the 15th meeting of the National Skills Qualification Committee (NSQC) held on 25th March 2022, it was decided by the Committee that any quality and industry relevant qualifications being submitted by Government Department/ Agency, reputed Industry as well as Private Sector Organizations (which are not recognized as Awarding Bodies) may be considered for NSQF alignment and be presented before NSQC for approval, subject to fulfilling the NCVET norms as highlighted under Agenda 6 paras 39 &30 of the Minutes of Meetings of the 14th NSQC held on 30th December 2021.

- a) The qualifications should be from a government department/ Agency, reputed Industry/ private sector organizations
- b) The qualification should be well-designed & developed, with high quality content which are customized to the industry needs.
- c) The qualification should be having bright employment prospects or entrepreneurship/ self-employment opportunities.
- d) The qualification approved under this category would become part of the National pool of qualifications in NQR under the ownership of NCVET and shall be available to all other recognized Awarding Bodies for adoption as per Adoption Guidelines.

e) The initial validity of such qualifications will be for a period of one year which shall be reviewed based on its usefulness. This arrangement is approved as a pilot to be reviewed after one year

3.2 Ministry of Skill Development and Entrepreneurship (MSDE) and the Ministry of Education (MoE) have implemented the Skill Hub Initiative (SHI) under Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY3.0). Under this initiative Higher Education Institutions (HEI) have been requested to offer foreign languages as skill courses. The foreign language courses are not aligned with National Skills Qualification Framework (NSQF) which is mandatory for the skill courses to be run under the government scheme, PMKVY. Hence, the University Grant Commission (UGC) had requested English and Foreign Language University (ELFU), Hyderabad, a Govt and only Central University for Foreign languages, to prepare model syllabi for foreign language courses and submit to the NCVET for NSQF alignment and approval. English and Foreign Languages University, accordingly, has prepared ten (10) foreign language courses and submitted to NCVET for NSQF alignment and approval. The details of the courses are as follows:

3.3 Accordingly UGC has forwarded the names of the following universities/colleges which have been nominated to run foreign languages courses under the skill hub initiative:

- a) Graduate School of Management Studies (GSMS), Gujarat Technological University (GTU) Ahmedabad.
- b) Jagan Nath University, Bahadurgarh, Haryana.
- c) Sathyabama Institute of Science and Technology (Deemed to be University), Accredited with 'A' Grade by NAAC and Approved by AICTE.

- d) Chaudhary Charan Singh university, Meerut.
- e) Manipur University.
- f) Goa University.

3.4 it is proposed to accord approval to the above mentioned 10 foreign language qualifications with following conditions:

- a) A simplified application format for seeking restricted recognition as an awarding body/ dual body for running the above language/es course/es under SHI, will be shared with the universities/ Institutes whose details are received through the UGC, subject to their having availability of qualified trainers, assessors, infrastructure etc required for those languages for which the recognition is being sought.
- b) The qualification approved under this category would become part of the National pool of qualifications in NQR under the ownership of NCVET and shall be available to all other recognised Awarding Bodies for adoption as per Adoption Guidelines. This arrangement as approved in 14th NSQC **as a pilot** to be reviewed after one year.
- c) The initial validity of all the ten foreign language courses shall be for a **period of one year** which shall be reviewed based on its usefulness, relevance for considering subsequent grant of regular validation period of three years by NSQC.
- d) The detailed syllabus, instructional material, TOT and ToA shall be ensured by the respective universities and English and Foreign Language University (ELFU), Hyderabad.

4. AGENDA ITEM NO 04: PROPOSAL FOR GRANTING APPROVAL TO 69 NSQF ALIGNED AND APPROVED QUALIFICATIONS FOR RUNNING IN SCHOOL BOARDS UNDER SAMAGRA SHIKSHA ABHIYAN

In accordance with the decisions of the National Skills Qualification Committee (NSQC) in its 18th meeting held on 28th April 2022, Pandit Sunderlal Sharma Central Institute of Vocational Education (PSSCIVE), as the Nodal Agency, has submitted 69 qualifications for adoption under Samagra Shiksha, in consultation with the concerned Awarding Bodies, for implementation in the schools across the country. The summary of the qualifications submitted in consultation with the respective domain Awarding Bodies are as under:

The issue of certificates for NSQF Level 4 shall be on completion of class XIIth and similarly for NSQF Level 3 as per NSQF norms.

5. AGENDA ITEM NO 5: RE-ALIGNMENT AND RATIONALIZATION OF NSQF LEVEL & NOTIONAL HOURS OF NSQF ALIGNED AND APPROVED QUALIFICATIONS FOR IMPLEMENTATION IN SCHOOL EDUCATION

5.1 NEP 2020 provisions integration of vocational education with the general education to make vocational education aspirational thus adding another step towards making India the Skill Capital of the world. NCVET, accordingly has made policies for smooth integration of vocational education into general education (both at school education as well as higher education level).

5.2 PSSCIVE has been designated as the nodal agency by the Department of School Education and Learning (DoSEL) which in consultation with the concerned Awarding Body will select already NSQF aligned and approved qualifications hosted by NCVET on the National Qualifications Register (NQR) Website after carrying out necessary tweaking and submit it before NSQC. These qualifications will thereafter run in schools under the Samagra Shiksha Abhiyan.

5.3 Some of the awarding bodies/sector skill councils have approached the NCVET regarding difficulties in implementing their NSQF aligned and approved qualification under the Samagra Shiksha Abhiyan as the standardised NSQF norms set for a particular qualification sometimes does not fit into the school time table to enable some of the most popular qualifications to be run in schools due to the restricted number of hours which can be assigned to a particular vocational qualification in the school. For example, over a period of two years from class 10th to class 12th, 400 hours have been assigned by the DoSEL/PSSCIVE to the vocational subject, thereby making a large number of qualifications from being unimplementable in the schools.

5.4 Keeping in view that only those qualifications which are of NSQF level 4 and below are applicable for implementation under the school education system, amongst them those which have notional hours of more than 400 hours, may be revised/rationalised up to 400 hours to suit the requirement of the school system and for running them under the Samagra Shiksha Abhiyaan. However, to bring parity between the trainees doing such courses in schools vis-a-vis various accredited and affiliated Training Centers of the respective Awarding Bodies, the level of such qualifications being run in the schools under Samagra Shiksha may have to be brought down by 0.5. The students having acquired such qualifications under Samagra Shiksha and desirous of pursuing these job roles as their career in future, will have to undergo upskilling to be able to come up to the NSQF level which has been assigned to that original qualification.

6. AGENDA ITEM NO 06: PROPOSAL FOR WITHDRAWAL OF NSQF ALIGNED AND APPROVED QUALIFICATIONS

6.1 **SPEEFL-SC:** The qualification '**Lifeguard-Open Water**' was approved in the 15th NSQC meeting held on 27th January 2022. SPEEFL-SC subsequently submitted a written request to re-visit the aforementioned qualification with regard to its assigned NSQF Level. An online meeting was held with the SPEEFL-SC and it was explained to them that once the qualification has been approved, subsequent changes in the same NSQF aligned and approved qualification can only be done through the NSQC. Accordingly, The AB had submitted a written communication request to withdraw the said approved qualification and has since been withdrawn by them through the process streamlined for the withdrawal of such NSQF aligned and approved qualification on file with the permission of the Chairperson, NSQC.

The proposal is placed before the Committee for information and ratification.

6.2 **SCPwD:** The qualification '**Goods packaging Machine Operator'LD**' was approved in the 18th NSQC meeting held on 28th April 2022. The awarding body has communicated vide mail that the said qualification was designed for speech and hearing impairment (**SHI**) disability and erroneously reflected as **locomotor disability**. The NCVET has accordingly scrutinized the qualification and found that the notional hours were not aligned to the specification as set for the **SHI**. Hence the qualification is proposed to be withdrawn from the national qualification register (NQR). SCPwD has resubmitted the qualification duly aligned for SHI disability.

The proposal is placed before the Committee for kind consideration and approval.

7. AGENDA ITEM NO 07: DEACTIVATION OF 41 QUALIFICATIONS OF ELECTRONICS SECTOR SKILL COUNCIL OF INDIA & 03 QUALIFICATIONS OF TELECOM SECTOR SKILL COUNCIL

7.1 In continuation of the audit of the NSQF aligned and approved qualifications reflected on National Qualification Register (NQR) Electronics Sector Skill Council has submitted 41 qualifications and Telecom SSC has submitted 03 qualifications for deactivation as they have not been able to conduct the requisite number of training on all these 41 qualifications.

7.2 Further, as the deactivation of qualification is an ongoing and continuous process, it is proposed that as and when the request from the Awarding Bodies are received for deactivation/archiving of the NSQF aligned and approved qualifications , the same shall be examined and processed on file and subsequently ratified in the upcoming NSQC. Details are attached at **Annexure IV**.

8. AGENDA ITEM NO 08: RATIFICATION OF TWO QUALIFICATIONS SUBMITTED BY NIELET

NIELET had submitted two (2) qualifications namely '**O Level**' (IT) and '**A Level**' (IT) for the 2nd NSQC held on 22.09.2020. Both the qualifications were approved by the Committee. However, after the revised standardized NSQF norms approved vide 16th NSQC and issued in the ecosystem, NIELIT has revised/rationalized these qualifications by carrying out changes in the entry requirements, NSQF level and notional hours (i.e. multiples of 30) as per the new norms and had resubmitted to the NCVET with a request for according urgent approval. The said two were approved on file as per the policy by the Chairperson, NSQC. Details are attached as **Annexure V**

9. AGENDA ITEM NO 9: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

6.1 A total of 86 qualifications (34 new and 52 revised) were received from 1st March to 31st March 2022. Of these, 57 qualifications (**5 new and 52 revised**) have been considered for placing in the 19th NSQC. The remaining 30 qualifications (29 New and 01 revised) could not be considered for this NSQC due to non-submission of complete documents. The details of 51 files under consideration are as under: -
