

**MINUTES OF THE 15th MEETING OF NATIONAL SKILLS QUALIFICATIONS
COMMITTEE (NSQC) OF NCVET HELD ON 27th JANUARY, 2022**

1. The 15th meeting of the National Skills Qualifications Committee (NSQC) under National Council for Vocational Education and Training (NCVET) was held on 27th January 2022, through Video-Conferencing, under the Chairmanship of Dr Nirmaljeet Singh Kalsi, Chairperson, NCVET. The list of participants is at **Annexure-I**.
2. The decisions taken, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA-1: CONFIRMATION OF MINUTES OF 14th NSQC MEETING

3. The Committee **confirmed** the Minutes of the 14th meeting of NSQC held on 30th December, 2021

**AGENDA-2: ACTION TAKEN REPORT ON THE MINUTES OF THE 14TH
MEETING OF NSQC**

4. The Committee was given a detailed account of the action taken on the Minutes of the 14th NSQC meeting wherein compliance on conditionally approved qualifications from various Awarding Bodies had been received and uploaded on National Qualification Register (NQR) Website. Details of the qualifications pertaining to FDDI, Apparel SSC and Agriculture SSC where additional compliances were to be fulfilled have been given below:

- a) **FDDI:** NSQC had directed **FDDI** to expedite submission of comments on two (02) qualifications namely 'Training of Trainer- Footwear' and 'Training of Trainer- Goods & Garments' and submit by 10th January, 2022 pending which the qualifications shall be considered as 'Not Approved' and withdrawn. However, since no response was received from FDDI w.r.t comments regarding the ibid two qualifications. These two (02) qualifications have been put under the category of '**Not Approved**' and withdrawn.
- b) **Apparel SSC:** NSQC had directed the Apparel SSC that w.r.t three (03) qualifications namely 'Storekeeper', Garment Cutter (CAM)' and 'Online Sample Designer' to either expedite submission of compliance or submit detailed justification for not being able to commit any target for



training. The SSC has submitted the undertaking of commitment there by fulfilling the compliance. All the three Qualifications have been **approved** and uploaded on NQR.

- c) **Agriculture SSC:** The qualification 'Dairy farmer/ Entrepreneur' of Agriculture SSC was conditionally approved in the 13th NSQC Meeting subject to vetting by DGT on entrepreneurship module which was not vetted by DGT till the conduct of the 14th NSQC held on 30 December 2021. NSQC had directed the DGT to expedite and submit the comments by 7th Jan 2022 pending which the qualification shall be considered as approved. Since the comments from DGT were not received even as on 24th January 2022, the qualification has been **'Approved'**.

5. NSQC members were requested to share their comments, if any, on Simplified Qualification File templates by 15th January 2022. **The Committee members were apprised that no comments have been received so far.**

6. The Committee had decided that all such qualifications of Department of School education, where extensions were sought and which are being run under any Government scheme, be activated till 31st March 2022 (academic year) including the 08 deactivated Qualifications being implemented under Samagra Shiksha Abhiyan. The Committee had further directed the officer concerned in NCVET to communicate to NSDC for activating these qualifications forthwith in consultation with the concerned Awarding Bodies.

7. NCVET vide its communication dated 09th January, 2022 regarding activation of 08 specific qualifications being implemented under Samagra Shiksha Abhiyan has informed NSDC and in addition, NCVET has also issued directions to NSDC for continuation/ activation of qualifications other than those falling in the regulated sectors, being implemented in any Govt. Schemes till 31st March 2022 and intimate the details of any such qualifications to NCVET. **It was informed by Ms Deepti Saxena, representative of NSDC that the compliance has been met and all the 08 deactivated qualifications have been activated on Skill India portal (SIP).**

8. The status of conditionally approved files with respect to compliance is at **Annexure-II**.

AGENDA- 3: QUALIFICATIONS SUBMITTED FOR NSQF ALIGNMENT

9. The Committee was apprised that a total of 365 qualifications (64 new and 301 revised) were received from 1st November 2021 to 30th November 2021. Of these, 254 (43 new and 211 revised) qualifications were considered for placing in the 15th NSQC. The remaining 111 qualifications (24 new and 87 revised) could not be considered for the 15th NSQC due to either non submission of complete documents, delay in response to observations made and/ or rationalization of qualifications being undertaken by the SSCs. **Chairperson NCVET requested all Awarding Bodies concerned to complete the information/ clarifications so that these qualifications can be taken up in the next meeting. The decision of NSQC on these 254 Qualifications has been given in the succeeding paras.**

10. **Directorate General of Training (DGT) :** Four (04) new qualifications of Food Processing Sector and Mining Sector were presented before the Committee for NSQF alignment and approval. The Committee **approved** all the Qualifications.

11. **Ministry of Textiles:** Fourteen (14) revised qualifications of the Textile Sector were presented for NSQF alignment and approval which were **approved**.

12. **Agriculture SSC.** Twenty-one (21) revised qualifications of the Agriculture Sector were presented before the Committee for approval. The Committee **approved** twenty one (21) qualifications. The Committee also suggested to SSC to add ***“8th Class with one year experience”*** as the entry level criteria of the Qualification “Agriculture Warehouse Worker”. The CEO, Agri SSC consented to the suggestion of the Committee and confirmed to submit the qualification with amendment to NCVET forthwith.

13. **Automotive SSC:** Two new qualifications, one (01) STT and one (01) Degree Apprenticeship curriculum were placed for approval before the NSQC. The Committee **approved** both the qualifications.

14. **Electronics SSC:** Thirty-Three (33) revised qualifications were placed before the committee for NSQF alignment and approval. The NSQC **approved** all the qualifications subject to the condition that for all such qualifications which have similar nomenclature in multiple sectors/ sub sectors /domains, the nomenclature be appropriately renamed for which it has been NSQF aligned and approved. Like Welding Operator Qualification of ESSC should be changed

to Welding Operator (Assembly Line & Manufacturing). This will enhance the ease of understanding of qualifications to the viewers. The CEO, ESSC present in the Meeting consented to this amendment and confirmed to submit all such qualifications, duly renamed, to NCVET.

15. **Furniture & Fitting SSC**: Four (04) new qualifications were placed before the committee for NSQF alignment and approval. The NSQC **approved** all four (04) qualifications.

16. **Green Jobs SSC**: Five (05) new and one (01) revised qualification were placed before the committee for NSQF alignment and approval. The NSQC **approved** all qualifications.

17. **Handicrafts and Carpet SSC**: Seventeen (17) revised and three (03) new qualifications of Handicrafts and Carpet Sector Skill Council were placed before the committee for NSQF alignment and approval. The committee **approved** all the qualifications.

18. **Hydrocarbon SSC**: Nine (09) revised qualifications were placed before the committee for NSQF alignment and approval. The Committee **approved** all the nine (09) qualifications.

19. **Logistics SSC**: Eleven (11) revised qualifications were placed for approval before the NSQC. The Committee **approved** all the qualifications.

20. **Media SSC**: Forty-one (41) revised qualifications were placed before the committee for NSQF alignment and approval. The NSQC **approved** all qualifications.

21. **Mining SSC**: Fifteen (15) revised qualifications were placed before the committee for NSQF alignment and approval. The committee **approved** fifteen (15) qualifications subject to carrying out following two changes:

- a) The entry criteria of ***“8th class pass with 4 years of Experience”*** be removed from the qualification “Mining Mate/Sirdar” pegged at level 5.
- b) Suffixing the word ***“Mining”*** for its qualification “Loader Operator” pegged at Level 4 for better clarity amongst the other relevant qualifications.

Representative of the SSC Mining Sector (SCMS) consented to change the above mentioned suggestions of the Committee and confirmed to submit the renamed qualifications to NCVET forthwith.

22. NASSCOM SSC: Fourteen (14) revised qualifications were placed before the committee for NSQF alignment and approval. The committee **approved** all qualifications.

23. PWD SSC: Four (04) revised and nineteen (19) new qualifications of the Persons with Disability (PwD) sector were presented before the Committee for approval. The Committee **approved** one (01) revised qualification and fourteen (14) new qualifications and accorded **conditional approval** to one (01) new qualification and three (03) revised qualifications. Remaining four (04) new qualifications were **not approved** by the Committee. The details of the “Conditionally Approved” and “Not Approved” qualifications are given below:-

- a) The Committee suggested that the three (03) revised qualifications - *“Gardener-PwD LD”, “Gardener-PwD SHI” and “Gardener-PwD LV”* be either pegged at Level 3 instead of their current level 4, or they may consider bringing in a new qualification of Assistant Gardener at level 3.
- b) The Committee also suggested adding *“one year of relevant experience”* with 8th Class in the entry requirement criteria of the Qualification-“Automotive Showroom Host-PwD LD”, to which the CEO, SSC agreed.
- c) Four (4) new Qualifications, ‘Paper Bag Maker-PwD LD’, ‘Paper Bag Maker-PwD SHI’, ‘Paper Bag Maker-PwD SHI’, ‘Multi - Purpose Associate-PwD SHI’ were **not approved** and the Committee suggested to resubmit the qualifications by using appropriate levels, notional hours and nomenclature of the Qualifications.
- d) However, a mechanism for assignment of appropriate levels, notional hours, etc to qualifications adopted for the PwD sector will be brought out by NCVET.

24. Sports SSC: Six (06) new qualifications were submitted by SSC for the NSQF alignment and approval. The Committee **approved** all the six (6) qualifications. The Committee also suggested the SSC to carry out amendments in each qualification mentioned as below:

- a) **Pool Maintenance Worker:** Number of OJT hours be increased from proposed 70 hours to 120 hours and overall notional Hours be increased to 300 Hours.

- b) **Life Guard-Pool:** The Committee suggested increasing the number of OJT Hours to 70, overall notional hour to 300 hours and including live demonstration in the entry criteria.
- c) **Lifeguard-open water:** The Committee suggested that live demonstration be added as entry criteria and also that level be reduced to 4.
- d) **Swimming Instructor:** The Committee suggested that level be reduced from 5 to 4.
- e) **Rescue Operation Head:** The Committee suggested that the entry criteria should include 'Certification for disaster management' from NDRF/any reputed organization.

CEO, SPEFL- SC consented to the above mentioned suggestions of the Committee and confirmed to submit the qualifications with amendments as suggested by the Committee to NCVET forthwith.

25. The member representative from CBSE suggested the Committee that SPEFL may consider bringing lower level (Level 3 and 4) qualifications on self-defense especially for girls. The Committee appreciated the suggestion from the CBSE representative and advised the CEO Sports SSC to accord priority to the request of CBSE and bring-in the relevant qualifications as per NSQF norms for consideration of the NSQC.

26. **Telecom SSC:** Ten (10) revised qualifications were placed before the Committee for NSQF alignment and approval. The Committee approved all qualifications.

27. **Textiles SSC:** Twenty-one (21) revised qualifications were placed before the committee for NSQF alignment and approval. The Committee **approved** all twenty-one (21) qualifications subject to the observations that wherever the entry requirement is of class five (5), apprenticeship is to be made mandatory.

Representative from the Textile SSC confirmed that the practice of mandatory apprenticeship training is already in vogue and shall be ensured.

28. A consolidated statement of approval status of qualifications considered in the 15th meeting of NSQC is placed at **Annexure- III. The detailed qualification wise status is at Annexure-IV.**

AGENDA- 4: GRANT OF EXTENSION TO INACTIVE QUALIFICATIONS BEING RUN UNDER SAMAGRA SHIKSHA ABHIYAN TILL ACADEMIC SESSION 2022-23

29. The Committee was apprised that Additional Secretary, D/o School Education (MoE) has made a written request with regard to grant of extension to certain qualifications which are in high demand in schools and have sent the following proposals for the consideration of the NSQC:

- a) 20 job roles (list attached) including 08 inactive qualifications (confirmed to have activated on SIP by NSDC) be granted extension till end of academic session 22-23.
- b) Allow admission in the above mentioned 20 qualifications for next academic session namely 2022- 23 at state level as well.
- c) Validation of qualification 'General Duty Assistant' of Healthcare SSC be permitted to be continued till 2022-23 (i.e. up to march 2023) for completion of existing batch.
- d) Allowing admission in qualification 'General Duty Assistant' for next academic session namely 2022-23 (i.e. up to march 2023) at state level as well.


30. With respect to the above mentioned request submitted by the D/o School Education (MoE) the decisions of the Committee are as given below:

- a) The 08 qualifications, as requested, were accorded conditional extension till the end of academic session 2022-23 for completion of training of the existing enrolled students, while for other ABs/ TPs/TCs the validity of these 08 qualifications shall continue till 31st March, 2022 only. **Further extension of these 08 Qualifications till 2022-23 is only for school education.** The list of 08 qualifications is at **Annexure V**.
- b) The Committee also decided that, admission in any such active qualifications, in academic session starting 2022-23, is permissible for all such qualifications which are active during the said period.
- c) As regards qualification- '**General Duty Assistant**' of the

Healthcare SSC is concerned, the said qualification has already been revised in Jan 2021 and hence the version 1 of the qualification has been deactivated while the revised version (V2) approved in January 2021 continues to be active. For the upcoming academic session commencing in 2022-23, the Department of School Education (DoSEL) may, therefore, implement the revised version-2 of this qualification which is currently active as the same has concurrence of Ministry of Health and Family Welfare. In case the DoSEL desires to implement the earlier version 1 of the 'General Duty Assistant' qualification, they may seek specific consent from the MoHF&W and intimate the same to NCVET. The representative from MoHFW agreed with the decision of the Committee and suggested that D/o School Education should send the proposal to MoHFW and appropriate decision after deliberation with the concerned authorities in MoHFW shall be communicated to the DoSEL under intimation to NCVET. The Additional Secretary, DoSEL (MoE) agreed to take up the matter with them. It was decided to maintain status-quo on the NSQC decision w.r.t the qualification 'General Duty Assistant'.

ADDITIONAL AGENDA 5: GRANT OF EXTENSION TO QUALIFICATIONS OF MINING (SCMS) AND APPAREL (AMHFSSC) SSC TILL 31st MARCH , 2022

31. Two (02) qualifications of Mining SSC namely "Mazdoor/Helper" and "Dewatering Pump Operator" were valid up to 30th Sep 2021. The Mining SSC had not submitted these two revised qualifications for further validation before 30th September 2021, it was assumed that the SSC is not undertaking any training on these two qualifications and hence were archived. Further, the Mining SSC has undertaken the rationalization of the two ibid qualifications. Meanwhile the SSC was offered training targets of 116 learners from Manganese Ore India Ltd. (MOIL) and the SSC had to undertake the trainings from November' 2021 to January' 2022 without prior approval of NCVET. Apropos, the SSC has requested for an extension of validity of the two ibid qualifications for six (06) months to enable them to certify trained learners.



32. The Committee took note of the lapses on part of the Mining SSC and advised to be proactive and accord seriousness in qualification related matters. The Committee accorded extension of validity to both the qualifications till 31st March, 2022.

33. Apparel SSC was accorded approval for extension of validity for forty-five (45) qualifications for 6 months from 1st October 2021 to 31st March 2022 with an instruction to rationalize and revise these qualifications as and when ready before the scheduled date. Accordingly, SSC had revised and rationalized its 45 Qualifications to thirty-six (36) and submitted before the NSQC mentioned asbelow:

- a) 16 Qualifications in 12th NSQC;
- b) 20 Qualifications in 14th NSQC.

34. However, nine (09) out of 45 pre-revised qualifications which were subsequently merged and clubbed under thirty-six (36) qualifications were archived by NSDC on SIP without taking into consideration that they were running under various Govt schemes ((NULM/ PMKVY/ DDU-GKY (NULM/PMKVY/)) and schools. The Apparel SSC has received communications from various Schools and Training Partners informing that approximately 900 students have already commenced their training in 09 qualifications (list attached as **Annexure VI**) and requested for grant of extension of validity. Accordingly, the Apparel SSC has requested for an extension of validity to the 09 qualifications up to 31st March 2022.

35. The Committee accorded approval to the proposal and granted extension of validity till 31st March, 2022.

The meeting ended with a vote of thanks to the Chair.




