**1. AGENDA ITEM 01: CONFIRMATION OF MINUTES OF 15<sup>th</sup> MEETING OF NSQC HELD ON 27<sup>th</sup> JANUARY 2022**

Minutes of the 15<sup>th</sup> meeting of NSQC held on 27<sup>th</sup> January 2022, were circulated. No comments have been received. However, a request was received for reconsideration of two (02) qualifications which will be examined separately.

**2. AGENDA ITEM 02: ACTION TAKEN REPORT ON DECISIONS TAKEN IN MEETINGS OF NSQC**

2.1. Action taken report for decisions taken in 15<sup>th</sup> NSQC:

A total of 254 (43 new and 211 revised) qualifications were considered in the 15<sup>th</sup> NSQC. 250(42 new and 208 revised) qualifications were approved in the 15<sup>th</sup> NSQC subject to some minor amendments which were duly consented by the Submitting Bodies in writing. All the 250 NSQF aligned and approved qualifications have been uploaded on the NQR. Four qualifications were conditionally approved subject to meeting criteria as given below:

### **3. AGENDA ITEM 03: FOR INFORMATION/IN PRINCIPLE APPROVAL OF NSQC**

#### **3.1. ALIGNING QUALIFICATIONS WITH UNIFIED CREDIT FRAMEWORK**

The Government of India has constituted a high level Committee to develop a Unified Credit Accumulation & Transfer Framework for both Vocational and General Education to enable integration and embedding of academic and vocational domain /component of learning and ensure flexibility and mobility between the two. While the Committee is in the process of finalising its report, the following basic principles have been agreed:

- a) The total notional learning hours in a year across education, higher education and skill education: 1200 Hrs.
- b) The credits earned in a year: 40
- c) Total notional hours per credit : 30

Accordingly, to take the full advantage of the Unified Credit Framework (UCF), all awarding bodies are being advised to align their qualifications in the multiple of 30 hrs when the qualifications are submitted for NSQF alignment and approval. Even for all existing qualifications all Awarding Bodies may be advised to update these as multiple of 30 hrs as far as possible without of course compromising the quality of the qualification.

#### **3.2. STATUS OF RECOGNITION OF AWARDING BODIES AND ASSESSMENT AGENCIES**

The Guidelines for Recognition and Regulation of Awarding Bodies and Assessment Agencies were brought out by the National Council for Vocational Education and Training (NCVET) on 27<sup>th</sup> October 2020. In the interim, in order to facilitate continuity in training, assessment and certifications being carried out in the skill ecosystem, transition period was granted to the existing Awarding Bodies (ABs) and Assessment Agencies (AAs) for seeking NCVET recognition on a regular basis vide **Order Number 22003/4/2020/NCVET dated 28/10/20**. The transition period was subsequently

extended for all existing ABs and 103 AAs empanelled to the existing ABs and who had applied for seeking NCVET recognition, up to 31<sup>st</sup> January, 2022, vide NCVET Circular No: 38004/01/2021/AB/NCVET dated 10<sup>th</sup> November, 2021, corrigendum dated 18<sup>th</sup> November, 2021 and NCVET Order No: 38004/01/2021/AA/NCVET dated 10<sup>th</sup> November, 2021 respectively.

While 41 existing Awarding Bodies and 17 existing Assessment Agencies have completed their final presentations before the recognition Sub-Committee, out of which 38 have completed compliances and from 3 final presentations after compliance is awaited. These are being given the recognition after completing the process and signing of the agreement etc. The various other ABs and AAs had conveyed their difficulty in submitting additional information/ documents/ response to the observations made by NCVET, due to the unavoidable circumstances because of the third wave of COVID-19 pandemic situation, especially the restrictions imposed by the Government and have requested for additional time to meet the compliances. A request was also made by them to extend the transition period beyond **31<sup>st</sup> January, 2022**.

In view of the request received for extension of transition period, and to facilitate continuity in training, assessment and certifications being carried out in the skill ecosystem, the transition period for 06 existing AB applicants and 103 Assessment Agencies empanelled with existing ABs have been extended till 31<sup>st</sup> March, 2022 and 30<sup>th</sup> April 2022 respectively or till a decision is taken by NCVET on their individual proposal, whichever is earlier.

### **3.3. IMPLEMENTING A SIMPLIFIED NATIONAL OCCUPATIONAL STANDARD (NOS)/ QUALIFICATION TEMPLATES FOR QUALIFICATIONS TO BE OFFERED UNDER SKILL HUB INITIATIVE (SHI)**

The Committee is apprised that MSDE has launched the Skill Hub Initiative in association with MoE under Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) on a pilot mode from 1st January 2022 to cater to 5000 (currently identified) Skill Hubs to provide skill development and vocational training opportunities to the target population segments covering school students (Class 9 to 12th students), school dropouts and out of education candidates. The scheme is being implemented through NSDC with the support of State Skill Development Missions (SSDMs), State's Education and District Skill Committees (DSCs).

As the committee is already aware that standardization of Qualification approval is an ongoing, dynamic process and NCVET is regularly taking periodic steps to ensure simplification of this process. In this regard, NCVET has formulated a simplified template to cater to the qualifications being implemented under Skill Hub Initiative (SHI) including those qualifications of generic nature from unorganized/ traditional sectors being implemented at school level under various skill programs being implemented by different entities under SHI.

**The template formulated for usage under SHI and other such initiatives is placed at annexure II.**

### **3.4. ADOPTION GUIDELINES**

Adoption Guidelines have been formulated after wide stakeholders' consultation and putting up in the public domain for comments. The final "Guidelines for adoption of qualification by Awarding Bodies" are available & may be viewed at NCVET website at the following Link: <https://ncvet.gov.in/sites/default/files/Adoption%20Guidelines.pdf>.

### **3.5. MULTI SKILLING AND CROSS-SECTORAL SKILLING**

The guidelines for Multiskilling and Cross Sectoral Skilling Qualifications have been formulated by NCVET in consultation with the committee comprising of CEOs of Sector Skill Councils (SSCs) and other prominent subject experts.

The guidelines aim at outlining the process of development of Multi-Skill & Cross-Sectoral Qualifications. It defines the rights, obligations, and responsibilities for Awarding Bodies and Assessment Agencies for sharing of development responsibilities and ownership in case of multi-skilling and cross-sectoral qualifications. It shall also incentivize all sectors to closely work together to create such much needed qualifications Multiskilling and Cross Sectoral Skilling for trainings. ### **3.6. CONDUCTING NSQF ALIGNED VET QUALIFICATIONS IN ENGINEERING COLLEGES & POLYTECHNICS**

AICTE has launched Project 'KARMA' to focus on utilization of surplus infrastructure with their polytechnics and engineering colleges. This initiative also addresses the issue of the lack of sufficient infrastructure within skilling ecosystem which has been a major concern for implementation of quality skilling initiatives. In this regard, AICTE in collaboration with NCVET has organized awareness program with all the 37 SSCs to encourage them to run their qualifications of higher NSQF Levels, in training/ internship modes in the polytechnics and engineering colleges.

### **3.7. IDENTIFICATION & DEVELOPMENT OF QUALIFICATIONS FOR FUTURE SKILLS**

NCVET has taken initiative to identify and address the need for future skills, owing to the emerging new technologies, the industry 4.0 and post Covid changing job world to develop a list of newer 21<sup>st</sup> century job roles that may be compliant with future skills requirements.

Accordingly, all the awarding bodies were advised to identify the future skills within their sectors and subsectors and prepare NOS/ Qualifications w.r.t such future skills which shall be further aligned with NSQF and approved by NSQC.

Till date NCVET has received list of Future Skills related Qualifications from 21 Sector Skill Councils who have started working on the development of such qualifications.

### **3.8. MODIFICATION & DESIGN IMPROVEMENT IN EXISTING NCVET CERTIFICATE AND NEW CERTIFICATE NORMS**

The uniform NCVET certificate template for NSQF aligned and approved qualifications was originally approved and launched in October 2020. NCVET has undertaken review of the existing approved NCVET certificate format based on feedback received from MSDE and the Skill Ecosystem. It is now felt that since the certificate needs to cater to

additional multiple requirements including inclusion of Skill India Logo, and programs being implemented under recognition of prior learning (RPL), Skill Hub Initiatives, School Boards and those being issued for Regular/ Standard Trainings.

Accordingly, NSDC has been assigned the responsibility to carry out certain modifications and improvements in design for different variants of certificates to cater to the above mentioned requirements. NSDC has been requested to carryout changes in the certificates as mentioned and submit to NCVET for approval and issue to the ecosystem along with explanatory notes.

### **3.9. GRIEVANCE REDRESSAL MECHANISM**

In pursuance of NCVET' mandate as per para 16(e) on Functions of the Council vide Govt gazette Notification No. SD-17/113/2017-E&PW dated 05 December 2018 to create and monitor a system of redressing the grievances of recognized entities under NCVET, the Council has formulated guidelines on grievance redressal mechanism after wide stakeholders' consultation and put in the public domain. ## **4. AGENDA ITEM NO 4: SIMPLIFICATION AND RESTRUCTURING OF QUALIFICATION FILE BEING SUBMITTED BY AWARDING BODIES FOR NSQF ALIGNMENT AND APPROVAL PROCESS**

### **4.1. COMPREHENSIVE REVIEW AND STANDARDIZATION OF QUALIFICATIONS FOR NSQF ALIGNMENT AND APPROVAL**

- a) Qualification approval is an ongoing process and takes place every month through NSQC. The Committee is apprised that qualifications being submitted by various Awarding Bodies for NSQF alignment and approval had many variations and complexities with regard to various parameters viz, nomenclature of the qualification, Learning hours/ notional hours, NSQF levels, entry level criteria etc.

Also in view of the Unified Credit Framework all parameters need to be standardised and rationalised for seamless integration of skill education with school education and higher education and horizontal and vertical mobility of the learners/ students.

- b) To address the above mentioned issues, NCVET undertook an extensive exercise to simplify, streamline, standardise and improve the existing qualification parameters and make them more adaptable by various submitting bodies in the Skill Ecosystem.
- c) Accordingly, the standardised and rationalised parameters with respect to NSQF levels ranging from 1 to 8 in terms of entry requirements (including relevant experience), notional hours, apprenticeship & OJT and naming convention etc have been developed in line with the proposed provisions of Unified Credit Framework. The standardized template for NSQF parameters and naming convention is at **Annexure-III**

## **4.2. AUDIT OF ALL NSQF ALIGNED AND APPROVED QUALIFICATIONS ON NQR**

- a) An exercise was undertaken to conduct an audit of the NSQF aligned and approved qualifications listed on the NQR Portal to remove the duplicate and non-active Qualifications in collaboration with Awarding Bodies. Accordingly, the existing data of NSQF aligned and approved qualifications since beginning were shared with all the Awarding Bodies (Sector Skill Councils in **phase I**) for authentication of the data and intimating NCVET w.r.t those qualifications which are non-active and needs to be deactivated and archived. In **phase II** of the audit of the Qualifications on NQR in respect of DGT and other existing Govt Awarding Bodies shall be undertaken.
- b) A total of old 859 Qualifications have been recommended by the respective SSCs to be deactivated and archived. As and when these archived qualifications will be required by Awarding Bodies with or without changes, they may submit proposals demonstrating need for such re-activation of these old qualifications by the NSQC.
- c) Duplicate Qualifications (as a result of multiple versions being approved post revision) identified on the NQR will be archived for record. In the event of any of

these duplicate qualifications being used in the Skill ecosystem, the concerned Awarding Bodies/ NSDC/ and other recognised/ Govt body may inform NCVET so that appropriate action can be taken to activate that qualification for the specified duration to meet the requirement of trainees.

List of duplicate and to be archived / deactivated Qualifications are attached as **Annexure IV and Annexure V.**

#### **4.3. ADDING EMPLOYABILITY SKILLS(ES) AS COMMON NOSs ACROSS ALL QUALIFICATIONS**

The NCVET has been encouraging all submitting bodies to make efforts to ensure that the job roles brought for NSQF alignment and approval are holistic in nature and cater to industry demand thereby imparting the trainees with adequate employability skills (ES). However, the ES includes by the Awarding Bodies for various qualifications are not comprehensive and has lot of variations in the components included in such skills. The matter also came up for discussion with MSDE to standardise such ES components for easy adaptability by all SSCs, and other Awarding Bodies as also as part of the skill qualifications in schools etc under SHI.

In the spirit of the above, it has been decided that mandatory common NOSs on employability skills roughly to the extent of 10% duration of the notional hours may be got prepared and included in all the relevant job roles being submitted for NSQC approval. Accordingly, NSDC has been given responsibility to prepare and submit NOSs on employability skills, mainly consisting of following modules with 120 Hrs, 90 Hrs, 60 Hours and 30 hours along with the e-content and learning material (digital and physical) for such common horizontal NOSs to cater to all the job roles of varying notional hours of all Awarding Bodies:

- i. Introduction to Employability Skills
- ii. Constitutional values /Citizenship
- iii. Becoming a professional in the 21st Century
- iv. English Skills
- v. Career Development & Goal Setting
- vi. Communication Skills

- vii. Inclusion, Gender Sensitivity, PWD etc
- viii. Financial and Legal Literacy
- ix. Digital Literacy & Skills
- x. Entrepreneurship
- xi. Customer Service
- xii. Job readiness and exam preparation

A generic decision needs to be taken that such ES NOSs may be included by any Awarding Body without referring the matter to the NCVET subject to the following:

1. For all Qualifications close to 900 to 1200 (or more) Notional Hours, a NOS of 120 hrs is included within these notional hours out of the for OJT component and if there is no OJT component then out of the practical training. No domain training is to be compromised.
2. For all Qualifications close to 750 to 900 Notional Hours or more a NOS of 90 hrs is included within these notional hours out of the for OJT component and if there is no OJT component then out of the practical training. No domain training is to be compromised.
3. For all Qualifications between 450 - 750 Notional Hours or more a NOS of 60 hrs is included within these notional hours out of the for OJT component and if there is no OJT component then out of the practical training. No domain training is to be compromised.
4. For all Qualifications between 300 to 450 Notional Hours a NOS of 60 hrs is included within these notional hours for OJT and if these is no OJT then practical training.
5. For all Qualifications close to 300 Notional Hours or less, a NOS of 30 hrs is included over and above these notional hours out of the for OJT component and if there is no OJT component then out of the practical training. No domain training is to be compromised.
6. In case the Awarding Bodies want to include a longer ES module than 10% of the Notional Hours, they may do so over and above the approved Notional Hours.
7. For Qualifications with lower NSQF levels, the Awarding Body can add additional hours of employability NOS provided the domain training is not compromised.

8. The awarding body can also add more modules to the employability NOS, if they so desire.
9. The revised QF shall be submitted by the Awarding Bodies to NCVET for uploading on the NQR to make the revised qualification active.

In all other cases the Awarding Bodies may approach NCVET with revised qualifications for approval of NSQC.

#### **4.4. RESTRUCTURING OF DGT QUALIFICATIONS ACROSS ALL QUALIFICATIONS**

DGT is currently offering 149 CTS and 54 CITS courses which are NSQF aligned and approved qualifications being implemented under various trades through Industrial Training Institutes (ITIs) across the country and many more such qualifications are in the pipeline. CTS courses of duration 1 year and 2 years are currently being offered by DGT with 1600 notional hours in each year.

The matter has come up for discussion with MSDE on various occasion for restructuring of DGT courses. Keeping in view the alignment of their qualifications with the Unified Credit framework, under formulation, DGT has submitted the following proposals:

- a) CTS courses of duration 1 year and 2 years currently being offered with 1600 notional hours in each year to be rationalized to 1200 learning hours (including Employability Skills (120 hours in case of one year course/first year of the two year course plus 60 hours advanced employability skills in second year of two year course) + 150 hours of OJT/ group project for better industry alignment for job readiness. The students can also opt for 240 Hrs (one language course through NIOS for 10th/ 12th class certificate along with ITI certification or an add on short term course of upto 240 hours) as optional.
- b) Each qualification shall also include employability skills of 120 hours consisting of Introduction to Employability Skills, Constitutional values /Citizenship, Becoming a professional in the 21st Century, English Skills, Career Development & Goal Setting, Communication Skills, inclusion, Gender Sensitivity, PWD etc, Financial and Legal Literacy, Digital Literacy & Skills,

Entrepreneurship, and Customer Service which will have immense value to the trainee both for an employee as well as exploring self-employment avenues.

- c) For six months courses, it is proposed to have 600 learning hours (including 60 hours of employability skills) plus mandatory 150 hours of OJT/ group project.

DGT has proposed to start these courses from the coming academic session i.e. August 2022 onwards and has communicated that they shall submit the revised qualifications to NCVET for record and updating of the same on NQR before actually starting a course. DGT further undertakes that no course shall be started without undertaking and completing this exercise.

In view of the above, it is proposed before the Committee that 'In-principle' approval for restructuring and rationalising all 149 CTS courses (1 year course + 2 Years courses) and 54 CITS courses, earlier approved by NCVET be accorded to DGT subject to the following:

- i. DGT shall submit an undertaking that they will carry out the restructuring exercises on NOS basis/ with Learning Outcomes etc, including the provision of training of trainers (ToTs) and training of assessors (ToAs).
- ii. While restructuring, the theory and domain learning shall not be cut down/ compromised, however, the duplication shall be removed wherever possible.
- iii. All qualifications shall conform to 4.4 (a), (b) and (c) above.
- iv. DGT shall submit the revised and restructured qualification files to NCVET for uploading the same on NQR before actually starting the course.
- v. Any observations of NCVET/ NSQC for any further modifications/ improvement and alignment in this regard shall be addressed and complied by them DGT.
- vi. DGT shall submit an undertaking that the revised qualifications conform to the NCVET guidelines and the other conditions, including alignment with proposed UCF, mentioned above.

#### **4.5. IMPLEMENTATION OF THE CONCEPT OF DYNAMIC QUALIFICATION**

In the budget speech Hon'ble FM has committed that National Skill Qualification Framework will be aligned to dynamic industry needs and Digital Ecosystem for Skilling and Livelihood, the DESH Stack e-Portal will be launched. This aims to empower the

citizen with skilling, re-skilling and up-skilling through online training. With this objective in mind NCVET is already relooking and re-evaluating and re-vising the existing 5000 plus skill qualifications in the National Qualification Register (NQR) on a continuous basis to re-orient the active qualifications in collaboration with SSCs and the industry bodies, to promote continuous skilling, re-skilling and up-skilling, sustainability and employability and also to enhance productivity and create more and better-quality jobs.

In line with the above NCVET is encouraging all Awarding Bodies to bring the core skills that are used in the era of digitization and automation like AI, Block-Chain, IoT, drones, Industry 4.0 and beyond etc, as also integrate digital skills in job roles wherever required.

For ensuring NSQF alignment to the dynamic needs of the industry NCVET has already introduced a number of measures like elective NOSs, however, the council further proposes to supplement these efforts for **ensuring required flexibility and dynamism in implementation of the Qualifications** in the skill ecosystem as follows:

1. Already 100% Qualifications are developed and mandated by the Sector Skill Councils/ Awarding Bodies which are aligned to industry requirements. It is proposed that the Awarding Bodies may carry out even wider and extensive consultations with the industry ecosystem to take their dynamic requirements into account while developing the qualifications and propose them as separate electives while getting the Qualifications approved by NSQC.
2. Awarding Bodies are also encouraged to add elective NOSs to their existing NSQF aligned and approved qualifications for which they may bring only the additional elective NOSs either within the same Notional Hours or over and above the same, for approval of NSQC. No need to bring in the entire qualification.
3. While implementing the approved qualifications by the Awarding Bodies, upto 20% flexibility in the non-mandatory NOSs (including any changes made for adopted qualifications) may be allowed subject to the following:
  - a. The Awarding Body shall clearly define the mandatory NOSs (normally not less than 60%) and non-mandatory NOSs. If no mandatory NOSs have been defined by the Awarding Body concerned, the changes proposed shall need approval of NSQC.

- b. 10% modifications shall be permitted within the mandatory NOS. The changes in the non-mandatory NOSs/ Elective NOSs shall be made well before starting a qualification batch.
- c. Adoption of qualifications from other Awarding Bodies already provide for with 20% flexibility while adopting qualifications from other Awarding Bodies for which detailed guidelines have already been issued.
- d. Adding elective NOSs to suit the customized requirements of the particular job role.
- e. All such changes shall be properly documented and submitted to NCVET for updating of NQR. These shall be treated and updated as the version of the same qualification. This exercise is required to ensure proper assessment of such qualifications by the Assessment Agencies.

#### **4.6. IMPLEMENTATION OF THE CONCEPT OF FLEXIBLE QUALIFICATIONS WITH OPTIONAL NOSs FOR JSS PROGRAMMES – GIVING JSS DIRECTORATE THE STATUS OF AWARDING BODY AND ASSESSMENT AGENCY**

A proposal has been received from the Directorate of Jan Shikshan Sansthan for giving them the dual status of Awarding body (AB) and Assessment Agency (AA) for implementing NSQF aligned and approved qualifications in the skill development programs under the scheme of JSS with implementation of flexible qualifications.

The scheme of JSS aims to provide vocational training to non-literates, neo-literates as well as school drop-outs in rural areas by identifying skills that have a relevant market in that local area. The objective of JSS is to uplift the rural population economically by imparting essential skills training, thereby enabling local trades to grow creating new employment and micro business opportunities for the natives of the region. JSS is being implemented by MSDE. At present, there are 304 JSS in 26 states and 7 UTs across the country.

Such initiative was also discussed during one of the brain storming sessions with MSDE, where it was agreed that NCVT would consider JSS as dual awarding bodies in respect of skill of NSQF levels 1 and 2 with adequate simplicity while allowing them adequate flexibility for catering to the varied local needs of the areas they are serving.

While the Council will consider their case separately for grant of dual status of Awarding body (AB) and Assessment Agency (AA), the following points are proposed for consideration of NSQC:

- a) DJSS may identify and select NSQF aligned and approved qualifications of level 1 and 2 from the NQR which best suit the target beneficiaries of JSS scheme. The qualification so selected may broadly be such as to have a local market demand and should lead to employment/ self-employment leading to enhancement of the income of the beneficiary.
- b) Normally the qualification at level 2 will be  $180 + 60 = 240$  hours including domain skills, practical skills with preferably 60 hours of employability skills for which a generic simplified template including the mandatory NOSs, flexibility of choosing NOS as per local requirement, assessment methodology, template for course, curricula etc would be developed by Directorate of Jan Shikshan Sansthan and got approved by NSQC.
- c) Once the template is approved, DJSS would create various versions of qualifications at its own level depending upon the local need and offer them under JSS after the same is submitted and updated on NQR. As long as DJSS certifies that the qualification conforms to the templates and other specifications approved by NSQC while approving the Qualification, no separate approval of NSQC would be necessary for each qualification.
- d) For any qualification above level 2, DJSS as Awarding body (AB) would follow the established mechanism for developing the NSQF aligned qualification and getting them approved from NSQC as other Awarding Bodies. Also, the JSS will have to follow the assessment norms as is prescribed for a standard awarding body i.e getting assessment done through a NCVET recognized assessment agency.
- e) As it is mandatory to seek recognition as dual category awarding body by NCVET for assessment and certification of NSQF aligned skill programs, DJSS would be asked to submit its proposal to NCVET under the category of a Government body at the earliest.

5.1. A total of 227 qualifications (92 new and 135 revised) were received from 1<sup>st</sup> December to 31<sup>st</sup> December 2021. Of these, 198 qualifications (74 new and 124 revised) are being considered for placing in the 16<sup>th</sup> NSQC. The remaining 29 (18 New and 11 revised) qualifications are not being considered for this NSQC due to either non submission of complete documents or delay in response to observations. The details of files under consideration are as under:-

- a) New QFs - 74
- b) Revised QFs - 124

**6. AGENDA ITEM NO 6: GRANT OF EXTENSION OF VALIDITY TO  
ONE (01) QUALIFICATION OF TOURISM AND HOSPITALITY SSC**

In the 11th NSQC, the qualification of 'Transport Coordinator' was approved for 6 months with a caveat that the Tourism SSC will have to submit the evidence of training for the qualification.

The SSC has submitted the documentary evidence on the number of training allocated for this qualification. The SSC has further informed that they have also received requests from multiple states for conducting training for the job role of transport coordinator and a total of 1425 training is to be undertaken.

The qualification is due for expiry on 28th February 2022. On the basis of the above mentioned performance details, it is proposed that the qualification be accorded extension up to 3 years i.e. till February 2025.

**7. AGENDA ITEM NO 7: RATIFICATION OF ONE (01) QUALIFICATION  
OF DGT**

Qualification "Operation & Maintenance of PSA Oxygen Plant" submitted by DGT was approved in 9th meeting of NSQC held on 24th June 2021. The qualification was

approved with a suggestion that relaxation be given to the trainees who are currently working in that plant for more than 2 months.

The DGH has conducted training on the above qualification and also some SCVTs have enrolled students for this qualification in view of the urgency of requirement of such skills during the pandemic. In this regard DGT has requested that the entry criteria of the said qualification be modified to – ‘Degree or Diploma in Engg./ NTC (ITI)/ NAC/ SCVT Passed in Fitter/Welder/ MMTM/RAC / Electrician /Instrument Mechanic, AOCP/MMCP/ IMCP trade’. Keeping in urgency of the Qualification the amendment was approved by the Chairperson, NSQC on file as per the norms and subsequently is to be brought before NSQC for ratification.
