**OFFICE ORDER**

As per the 'Guidelines for Adoption of Qualifications by Awarding Bodies' dated 23.02.2022 and under the scope mentioned there in under Para 5 of the same, Skill Council of Mining Sector (SCMS) is granted awarding rights for the following qualifications of original developing body Infrastructure Sector Skill Council (IESC): -

- 1) Backhoe Loader Operator, NSQF Level 4
  - 2) Excavator Operator, NSQF Level 4
  - 3) Hydra Crane Operator, NSQF Level 4
  - 4) Crawler Crane Operator, NSQF Level 4
2. Grant of the Awarding rights is subject to following conditions: -
- a) For the qualifications mentioned above, where SCMS is an Awarding Body, it shall be responsible for training followed by certification. An independent, reliable and fair mechanism of assessments through NCVET recognised Assessment Agencies is to be ensured by the SCMS.
  - b) Such awarding rights shall be exercised within the jurisdictional/ operational/ territorial boundaries defined as per the Act/Notification/any such order under which the recognized body was created
  - c) Approved norms and standards as prescribed for a particular NSQF compliant Qualification and extant NCVET guidelines including 'Guidelines for Adoption of Qualifications by Awarding Bodies' shall be adhered to.
  - d) The validity of adoption shall commence from the date of approval by NCVET up to the 'Date of Planned Review' as mentioned in the originally approved qualification. The adopting body will have to comply with all the conditions mentioned in the revised qualification as and when approved by NCVET. In case of de-recognition of developer body or dis continuation of the Qualification NCVET would decide the further course of action.
  - e) In order to properly implement the qualifications and ensure sustainability of operations in the long run, the training rights and responsibility to conduct Training of Trainers (ToT) and Training of Assessors (ToA) shall remain with the Developer Body or as mutually decided between the two bodies. Such decision shall be documented and communicated to NCVET. However, in case the original developer body delays/ refuses TOT/TOA activities then the adopter body may approach NCVET for suitable directions, as deemed appropriate. NCVET reserves the right to get the Training of Trainers (ToT) and Training of Assessors (ToA) for any qualification conducted through any other Government body.

- f) Both the developer (IESC) and the adopting body (SCMS) are expected to develop the teaching and learning content on their own or decide to share the content as mutually decided.
- g) Processing fee payable to NCVET for every Renewal (i.e. in every 3 years) is Rs. 10,000/- or the amount as decided by NCVET at the time of renewal.
- h) Certification shall be made in the latest standard format as released by NCVET.
- i) SCMS shall share information of training, assessment and certification activities with NCVET as prescribed vide section 4 i.e Monitoring and evaluation of "NCVET Guidelines for Recognition & Regulation of Awarding Bodies' including as amended from time to time.
- j) The NCVET shall carry out the performance appraised review as per the parameters laid down in 'NCVET Guidelines and Operational Manual for Recognition & Regulation of Awarding Bodies' including any amendments/addendum issued from time to time.
