

MINUTES OF THE 27th MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE (NSQC) HELD ON 28th FEBRUARY 2023

1. The **27th meeting** of the National Skills Qualifications Committee (NSQC) under National Council of Vocational Education and Training (NCVET) was held on 28th February 2023, through video conferencing, under the Chairpersonship of Dr. Nirmaljeet Singh Kalsi, Chairperson, NCVET. The list of participants is at **Annexure- I**.
2. The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA ITEM 01: CONFIRMATION OF THE MINUTES OF THE 26th MEETING OF NSQC HELD ON 31st JANUARY 2023

3. The Committee **confirmed** the minutes of the 26th meeting of the NSQC held on 31st January 2023.

AGENDA ITEM 02: ACTION TAKEN REPORT ON DECISIONS TAKEN IN THE NSQC MEETINGS

4. The Committee was given a detailed account of the **action taken** on the following matters pertaining to the Minutes of the 25th and 26th NSQC meetings. The Committee took note of the action taken and advised the following:

4.1. Amendments/ Modification to the existing Guidelines on Adoption of Qualifications by Awarding Bodies to be completed and brought before the NSQC scheduled in March 2023.

4.2. Constitution of Committee on Mapping of qualifications with NCO codes. The Committee advised to complete the proceedings, as listed out in the Terms of Reference of the Convening Order on Constitution of Committee on Mapping of qualifications with NCO codes and place the report for public consultation and feedback by end of March 2023 and submit the report before NSQC at an earliest time frame possible. The Committee further recorded the decision that the same members from various organizations shall constitute as a Standing Committee to address all the future challenges pertaining to the NCO mapping of the NSQF aligned and approved qualifications.

AGENDA ITEM 03: USAGE OF NCVET LOGO ON NSQF ALIGNED AND APPROVED STT CERTIFICATE FOR TRAINING UNDER SAMAGRA SHIKSHA

5. The Committee was apprised that under the GoI scheme 'Samagra Shiksha', multiple awarding bodies, mainly the Sector Skill Councils in collaboration with the CBSE/State School Boards are implementing the training and assessment of selected NSQF aligned and approved short term qualifications/job roles.



6. Further, NCVET has received requests from some of the recognized ABs seeking clarification on the process for issue of NCVET approved short term training (STT) certificates for certification of school students enrolled in centrally sponsored scheme for Vocationalisation of Secondary and Higher Secondary Education under 'Samagra Shiksha'. Director, NCVET clarified the following in this regard:

6.1. CBSE is one of the recognized NCVET awarding body (dual category) and they may get NSQF aligned and approved qualifications assessed under their own arrangement and issue NCVET approved certificates to the children as per the guidelines on this subject.

6.2. CBSE board may also implement these qualifications through the respective domain ABs/ SSCs and can get them assessed through the empaneled NCVET recognized Assessment Agencies. For all such qualifications, the CBSE may issue NCVET approved certificates and can have logos of both the organizations i.e., CBSE and the concerned domain Awarding Body/ SSCs.

6.3. State Boards which are not recognized ABs of NCVET as on date and wish to run the NSQF aligned and approved qualifications may also do so provided they get the training and assessment done through the NCVET recognized ABs and AAs as per the laid down policy on the subject.

6.4. However, if the State Boards, which are not recognized ABs of NCVET, want to conduct the training and assessment of NSQF aligned and approved qualifications on their own, they shall not be able to issue the NCVET approved nationally recognized certificates to the students/ learners, but they may issue their own state level certificates as deemed appropriate.

7. The Committee was also updated that the NCVET vide Para 10 of section 4.3 under continuation criteria of Awarding Body Guidelines has already published the policy on use of Logo and Certification. The extract of the policy is given below:

7.1. **Usage of Logo:** The recognized AB must ensure that the usage of NCVET logo is in line with the NCVET Guidelines.

7.2. **Certification:**

7.2.1. The recognized AB must ensure that the certificates issued by it are as per the format prescribed by NCVET.

7.2.2. The recognized AB must ensure that certificate is released to the learners within a stipulated time, as defined by NCVET.

7.2.3. Certificate should be available through secured online platforms.

7.2.4. Storage of digital certificates in National Academic Depository".

The Committee took note of the same and accorded concurrence.



AGENDA ITEM 04: USAGE OF NCVET APPROVED CERTIFICATE TEMPLATE FOR NSQF ALIGNED & APPROVED QUALIFICATIONS BY THE RECOGNIZED AWARDING BODIES

8. The Committee was briefed that the NSQC had approved 12 certificate templates which would be awarded to the learners/candidates under various skilling programs, on completion of training in the NSQF aligned and approved qualifications, through a centralized regulated digital portal and DGT as applicable.

9. To facilitate the issuance of certificates to learners by ABs through the SIP/DGT, the certificate templates along with the open-source files and explanatory notes are being shared with the NSDC/DGT. However, currently there is no provision for on boarding all the NCVET recognized ABs other than SSCs on the SIP. Also, there is no provision for the issue of certificates for the fee-based trainings conducted by any NCVET recognized AB, including SSCs, through SIP. Director NIELET mentioned that currently NIELET has capacity for digital certification for their own trainees. He mentioned that scope exists to expand the facility with them to other recognized Awarding Bodies for which they would need to understand the process being currently followed for issue of certificates for SSCs through SIP.

10. The representative of NSDC was not aware of the present status of development of such provision in the existing SIP. The Committee took note of the same and advised to explore the possibility of getting centralized digital portal developed through NIELET both for issuance of these certificates to learners especially under fee-based programs to mitigate the current on-going crisis of digital certification as well for on-boarding all such ABs getting recognition as an Awarding body (standard/ dual).

11. However, as the first option the case may be taken up with NSDC to make such provisions in this skill India digital (SDI) platform for issue of fee-based certificates not only by the recognized awarding bodies of the council but also by the bodies like the state school education board etc who are offering National Skill Qualification Framework (NSQF) aligned and approved qualifications.

AGENDA ITEM 05: MODIFICATION IN THE ENTRY CRITERIA FOR THREE (03) QUALIFICATIONS OF CTS AND CORRESPONDING CITS

12. The Committee was apprised that in the 22nd NSQC meeting following three (3) CTS qualifications of DGT were approved:

12.1. Fire Technology and Industrial Safety Management (2022/SEC/DGT/06314),

12.2. Health, Safety and Environment (2022/HLT/DGT/06272),

12.3. Fireman (2022/SEC/DGT/06312).

13. The minimum physical standards in the entry requirements of these three qualifications were drafted in line with the Recruitment Rules (RRs) of various government organizations and requirements of the industry which was only applicable for men. Keeping in view the gender equality, the provision for entry of women has also been included and accordingly the physical attributes for the women candidates for the above mentioned three qualifications have been published in RR as also in many states' RRs. Therefore, DGT has also proposed to include the following physical standards for the corresponding CTS Qualifications in line with the state and RRs:

14. The Committee approved the entry criteria with revised physical standards for the three above mentioned (3) CTS qualifications of DGT.


AGENDA ITEM No 06: CUSTOMIZATION OF EIGHTY-FIVE (85) NSQF ALIGNED QUALIFICATIONS (SHORT TERM TRAINING-STT) WITH 210 NOTIONAL HOURS FOR IMPLEMENTATION UNDER PMKVY4.0

15. The Committee was informed that on the request of the MSDE a meeting was convened regarding shortlisting of existing NSQF aligned and approved qualifications to be run under the PMKVY3.0/ 4.0 scheme. The qualifications of NSQF levels up to 4 which are high in demand in the industry and have good placement prospects were selected by the Awarding Bodies and their notional hours were suitably modified to 210 Hrs with other necessary changes.

16. Following parameters have been decided for the customization of existing NSQF aligned and approved qualifications:

- 16.1. Qualifications have been rationalized to 210 Notional hours. (About a month). The occupational maps for each of the qualifications shall be updated by the concerned awarding body.
- 16.2. Notional hours of 210 hours include Employability Skills (ES) of 60/ 90/ 120 hours as proposed by the recognized AB.
- 16.3. The nomenclature of the qualifications has been revised as per their Learning Outcome and competencies being achieved and as per the need of the industry and NOSs have been selected as per the competency outcome expected from that job role.
- 16.4. The ABs/ SSCs to ensure 90 percent placement of the total enrolled candidates under the scheme.
- 16.5. As number of notional hours of all these customized courses have been rationalized to 210 Hrs, the entry level criteria of these customized qualifications have also been raised by one NSQF level.

17. The validity of these selected and customized qualifications is for a period of **six months** i.e., from 15th February 2023 till 31st August 2023 (tentative date of conduct of the NSQC). The concerned ABs are advised to ensure that no qualification is kept active after 31st



August 2023.

The Committee approved these qualifications and directed to implement them for the training/ skilling.

AGENDA ITEM 07: REGARDING GRANT OF RECOGNITION AS AN AWARDING BODY (STANDARD) TO RASCI BY THE NCVET

18. The Committee was apprised that the Retailers Association's Skill Council of India (RASCI) has been recognized as an Awarding Body of NCVET on 07/02/23. The awarding rights with respect to 20 Qualifications originally developed and aligned to NSQF by RASCI, which were earlier given to the other awarding bodies in the absence of RASCI, have also been reinstated to RASCI vide an Order No. 21004/01/2022/NCVET dated 16/02/23 superseding the previous order No.36002/9/2022/ NCVET and partial modification of Order of even no dated 01/06/2022 issued by NCVET on the subject *ibid*. However, adoption rights of RASCI qualifications which were granted to five (05) NCVET recognized Awarding Bodies (AB) vide an Office Order No. 21004/01/2022/NCVET dated 01/06/22, to facilitate uninterrupted continuation of training and certification in the retail skill ecosystem in the absence of RASCI as an Awarding Body will continue *mutatis-mutandis*.

The Committee took note of the same and ratified it. Further, RASCI was also advised to submit a list of new/future qualifications which they had proposed to submit during their Sub-Committee review.

AGENDA ITEM 08: SUBMISSION OF QUALIFICATIONS/ NOSs FOR NSQF ALIGNMENT

19. The Committee was given an account of fifty-one (51) qualifications (10 New and 41 Revised) qualifications and two (2) new NOSs, received till 31st December 2022 for NSQF alignment and approval and being placed before the Committee. The decision of the committee on all the 51 qualifications and two NOSs is given in succeeding paras.

Awarding Bodies


20. Automotive Skills Development Council (**ASDC**): **Seven (07) new qualifications** of the automotive sector pertaining to future skills placed for approval before the NSQC was **approved**. The details are given in **Annexure II**.

21. Gem & Jewellery Skill Council of India (**GJSCI**): **Two (02) revised qualifications** presented before the Committee were **approved**. The details are given in **Annexure II**.

22. Logistics Sector Skill Council (**LSC**): Thirteen (13) qualifications (01 new and 12 revised) were presented before the Committee for approval. The Committee approved **12 qualifications** (01 new and 11 revised). The remaining 1 revised qualification "Commercial Vehicle Driver- LMO" was **conditionally approved** subject to addition of one new NOS on the oxygen component and its safety. The details are given in **Annexure II**.

23. Management & Entrepreneurship and Professional Skills Council (**MEPSC**): Six (04 revised and 2 new) qualifications were presented before the Committee for approval. The Committee approved five qualifications with revised nomenclature of two qualifications as follows:

One qualification namely 'Certified Public Accountant' was accorded conditional approval subject to re-examination of the nomenclature. The details are given in **Annexure II.**

24. **Sector Council for Persons with Disability:** A total of 23 qualifications (22 revised and 01 New) were placed before NSQC for approval. NSQC approved all the 23 qualifications. 21 revised qualifications in which the training numbers were 'NIL' or less than 100, the Committee gave the approval for the validity of 01 year keeping in view the challenges in the PwD sector as against the normal policy of 06 months for other sectors. The details are given in **Annexure II.**

25. **ESSCI:** Two (02) new Standalone NOS presented before the Committee were **approved.** The details are given in **Annexure II.**

AGENDA ITEM 08: ADDITIONAL AGENDA WITH THE PERMISSION OF THE CHAIR

The Chairperson, NSQC observed with concern that the CEOs of all the Awarding Bodies were still not attending the NSQC despite having fixed the date of conduct of NSQC as last Thursday of the month/ adequate time being given through written communication. It was again reiterated that in the event of qualifications being submitted for NSQF alignment and approval of any recognised AB, the presence of the CEO of that AB is obligatory.

For other ABs, whose qualifications are not being submitted for NSQF alignment and approval should also endeavour to attend the meeting as their contribution to the discussion is very important for approving quality qualifications. However, in the event of any emergency the CEO should intimate through written communication to the NCVET of their inability to attend with reasons and seek the exemption of National Skills Qualification Committee (NSQC) for their absence.

26. The Director Policy apprised the Committee that Tourism and Hospitality Skill Council (THSC) has requested to activate their two (02) archived qualifications namely, **'Cleaner Roadside Eateries' and 'Food Server Roadside Eateries'** as they have received training numbers from various stakeholders. Earlier these qualifications were archived on the request of THSC.

27. The Committee took note of the same and **approved to activate the two qualifications for one year** to be reviewed for further extension subsequently.

28. Dr. Neetu Bhagat, AICTE apprised the committee that while entry criteria of qualifications for NSQF alignment have been streamlined as per NCrF and revised NSQF norms, a generic order may be considered by the Committee to modify the entry criteria of the qualifications from candidates who have completed B.Tech./ B.E to include B.Tech. / B.E. 3rd year pursuing candidates, so that the outreach of the qualification can be maximized.

29. **The Committee appreciated the suggestion and directed NCVET to issue a generic order to allow the provisions in all such type of qualifications (for level 6 and below qualifications only) which would also be in line with the National Credit Framework (NCrF).**


30. The Committee was apprised that a meeting of all the CEOs/ Heads of recognized ABs



and AAs is being planned in the 2nd week of April 2023 with an aim to enhance co-operation and develop an effective network among ABs and AAs.

The Meeting ended with a Vote of Thanks to the Chair.




