

MINUTES OF THE 29th MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE (NSQC) HELD ON 03rd MAY 2023

1. The **29th meeting** of the National Skills Qualifications Committee (NSQC) under National Council of Vocational Education and Training (NCVET) was held on 03rd May 2023, through Video conferencing, under the Chairpersonship of Dr. Nirmaljeet Singh Kalsi, Chairperson, NCVET. The list of participants is at **Annexure- I**.
2. The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA ITEM 01: CONFIRMATION OF THE MINUTES OF THE 28th MEETING OF NSQC HELD ON 29th MARCH 2023

3. The Committee **confirmed** the Minutes of the 28th meeting of the NSQC held on 29th March 2023. The Committee also approved two minor editorial changes in the minutes of the 25th & 28th meetings of NSQC held on 5th January 2023.

AGENDA ITEM 02: ACTION TAKEN REPORT ON DECISIONS TAKEN IN THE NSQC MEETINGS

4. The Committee was given a detailed account of the **action taken** on the Minutes of the 28th NSQC meeting. The Committee took note of the action taken, **approved** the same and further emphasized on the following:
 - 4.1. The Committee advised all the Awarding bodies to check their qualifications for NCO mapping and share the list of qualifications that are not having NCO code or not fitting into any existing NCO code.
 - 4.2. The Committee emphasized on submission of qualifications in the new template formats including in bilingual mode. A decision was taken that henceforth, the qualifications without bilingual format may not be brought before the NSQC.
 - 4.3. The Committee reiterated that all the recognized ABs must submit the qualifications for NSQF alignment and approval duly incorporating the revised Occupational Map (OM) for its implementation in PMKVY 4.0 Scheme as mandated by the MSDE.

The status of compliance is at **Annexure II**.

AGENDA ITEM 03: APPROVAL OF EXISTING NSQF ALIGNED & APPROVED FUTURE SKILLS QUALIFICATIONS FOR IMPLEMENTATION UNDER PMKVY 4.0

5. The Committee was briefed that **89 future skills** qualifications were accorded '**In Principle approval**' in the 28th meeting of NSQC held on 30th March 2023, for implementation under PMKVY 4.0. Detail scrutiny of all the 89 qualifications have been done with respect to the revised standardized NSQF norms in the light of NCrF, and inclusion of Employability of Skills (ES). The details of the qualifications are at **Annexure III**.



The Committee took note of the same and accorded approval to this agenda.

AGENDA ITEM 04: RATIFICATION OF EARLIER NSQF ALIGNED AND APPROVED QUALIFICATIONS RATIONALIZED IN THE MULTIPLES OF 30 HOURS AND INCLUDING THE EMPLOYABILITY SKILLS (ES) MODULE

6. The Committee was apprised that in the meetings of 16th, 20th & 21st NSQCs held on 24th Feb 30th June and 28th July 2022 respectively, the Committee had advised all the recognized Awarding Bodies (ABs) to rationalize their NSQF aligned and approved qualifications in the multiples of 30 and include the Employability Skills in order to align with the National Credit Framework.

7. Accordingly, the AB wise details of qualifications rationalized in accordance with the decisions of NSQC as on date is given below:

The Committee took note of the above, ratified the same and also directed that the remaining NSQF aligned and approved qualifications of all such recognized ABs be expedited and action completed by June 2023 positively.

AGENDA ITEM 05: EXTENSION OF VALIDITY OF NSQF ALIGNED AND APPROVED QUALIFICATIONS OF THREE RECOGNISED AWARDDING BODIES

8. Health Sector Skill Council.

- 8.1. The Committee was apprised that the qualification “**Emergency Medical Technician-Basic (EMT-B)**” has been listed in PMKVY 4.0 and has already enrolled 1921 candidates. However, the qualification (EMT-B) is valid until May 2023. In light of this, the HSSC has requested for an extension of the qualification for 3 years based on the demand from all the states for emergency care services.
- 8.2. On a query raised by the Committee, CEO explained that no changes were required or proposed to be made in the qualification for the time being.

The Committee approved the qualification for next 3 years.

9. Domestic Workers Sector Skill Council (DWSSC)

- 9.1. The Committee was apprised that during the 23rd NSQC meeting held on 22 September 2022, three (03) revised qualifications **of DWSSC were accorded approval** for six (06) months due to insufficient number of trainings. The details are given below:

- a) **Professional Cook (Household & Small Establishment).**
- b) **Caregiver - Mother and New-born (Non-Clinical).**
- c) **Baby Caregiver (Non-Clinical)**

- 9.2. The DWSSC has now intimated that as on date a total of 550 candidates have been trained by them. Additionally, they have received a work order from MSSDC for training ten thousand (10,000) candidates for their various job roles, of which the AB shall be training approximately 700-800 candidates in each of the above mentioned three job roles. DWSSC has requested the extension of validity for the above mentioned three qualifications for a duration of 3 years i.e., up to 28th Sept 2025 from the date of actual approval.

The Committee approved the 3 above mentioned qualifications for 3 years up to 28th Sept 2025.

10. Sector Skill Councils for Persons with Disability (SCPwD)

- 10.1. The Committee was briefed that during the 19th meeting of NSQC held on 26th May 2022, validity of 128 SCPwD job roles was extended till 31st March 2023 and thereafter these qualifications were archived as no communication was received from SCPwD for any extension.
- 10.2. The SCPwD has communicated that 41 of the total 128 job roles are to be implemented with UPSDM for which a formal MoU has been signed in the month of February 2023. Further, these job roles are also to be implemented under Himachal Pradesh Kaushal Vikas Nigam (HPKVN). Accordingly, the AB has requested activation of 41 qualifications with one-year validity i.e., till 31st March 2024. The list of qualifications is at **Annexure IV**.



- 10.3. On a query raised by the Committee, CEO submitted that no changes required or proposed to be made in the qualification for the time being.

The Committee approved the activation of 41 qualifications with one-year validity i.e., till 31st March 2024.

AGENDA ITEM 07: SUBMISSION OF QUALIFICATIONS/ NOSs/ MCs FOR NSQF ALIGNMENT AND APPROVAL

11. The Committee was given an account of 94 qualifications (87 New and 14 Revised), and 04 MCs received till 29th Feb 2023 for NSQF alignment and approval. Of these, 69 qualifications (62 New and 07 Revised), were considered for placing in the 29th NSQC Meeting as the remaining qualifications needed to respond to the queries. The decision of the committee on the 69 qualifications is given in succeeding paras. The detailed status of approval and decision of the committee is at **Annexure V**.

Awarding Bodies -

12. **CIPET:** One (01) revised qualification was presented before the Committee and was approved.
13. **DGT:** One (01) new **NOS** was presented before the Committee and was approved.
14. **Indian Defense Forces (Tri services):** Four (04) new qualifications presented before the Committee were approved.
15. **Health SSC:** Two (02) new qualifications were presented before the Committee and were approved.
16. **Hydrocarbon SSC:** Eleven (11) new qualifications presented before the Committee were approved.
17. **Leather SSC:** One (01) new qualification namely 'Footwear and Fashion Accessories Advisor' was presented before the Committee. The Committee **approved** the qualification subject to change in the nomenclature of the qualification to '**Footwear and Fashion Accessories Retail Associate**' which was agreed upon by the CEO Leather SSC.
18. **Lifesciences SSC:** Two (02) new qualifications presented before the Committee were approved.
19. **Logistics SSC:** Four (04) new qualifications presented before the Committee were approved.
20. **Management SSC:** One (01) new qualification and three (3) new **Micro-credentials** were presented before the Committee for approval. The Committee approved one new qualification. Three (03) new **Micro-credentials** were approved subject to fulfilling following compliances which were agreed upon by the CEO, MEPSC:

20.1. Submission of 30 industry validations for each micro-credential.

20.2. Change of nomenclature of MC named "Virtual Assistant" to "Office Assistant- Virtual (Upskilling)"



21. **Sports SSC:** Four (04) new qualifications were presented before the Committee. The Committee advised Sports SSC to review all the 04 qualifications and resubmit accordingly.

22. **SCPwD:** One (1) revised and thirty-two (32) new qualifications were presented before the Committee and were approved. However, the qualifications in which the training numbers were 'NIL' or **less than 100**, the approval was given with a **validity of 01 year** keeping in view the challenges in the PwD sector as against the normal policy of 06 months for other sectors.

23. **WBSCTVESD:** Five (05) revised qualifications were presented before the Committee. The Committee approved four qualifications without any change. One qualification, namely "Fruit and Vegetable Products Manufacturer" was approved with revised nomenclature as "Fruit and Vegetable Product Producer" which was agreed upon by the CAO, WBSCTVESD.

24. **OEM ('Service Now') through NASSCOM:** One (01) new **Micro-credential** was presented before the Committee and was approved.

AGENDA ITEM 08: ADDITIONAL AGENDA WITH THE PERMISSION OF THE CHAIR

25. The Committee was apprised that Water Management & Plumbing Skill Council (WMPSC) has submitted a qualification on "Technician Water Distribution System (Multi-Skill)" for NSQF alignment and approval at a short notice requesting for seeking NSQC approval as the qualification aims to provide training to rural youth of Odisha under ORMAS, Panchayati Raj and Drinking Water Department, Govt. Of Odisha.

26. This qualification is directly aligned with **Honorable Prime Minister's 'Jal Jeevan Mission'** to assist, empower and facilitate States/ UTs for creation of water supply infrastructure so that every rural household has a Functional Tap Connection (FHTC) by 2024 and water in adequate quantity of prescribed quality is made available. The details of the qualification is at **Annexure V**.

The Committee took note of the above and approved the qualification.

27. The Committee was apprised that in the 27th meeting of NSQC, one qualification of MEPSC namely 'Certified Public Accountant' was conditionally approved subject to re-examination of the nomenclature. Accordingly, MEPSC has revised the nomenclature of the Qualification to '**Public Accountant**' for consideration and according the approval.

The Committee took note of the above and approved the qualification with the revised nomenclature.

The Meeting ended with a Vote of Thanks to the Chair.
