1. AGENDA ITEM NO. 01: CONFIRMATION OF THE MINUTES OF THE 26th MEETING OF THE NATIONAL SKILL QUALIFICATION COMMITTEE (NSQC) HELD ON 31st JANUARY 2023

2. AGENDA ITEM NO. 02: ACTION TAKEN REPORT ON THE DECISIONS TAKEN IN THE MEETINGS OF THE NSQC

3. AGENDA ITEM NO 3: USAGE OF NCVET LOGO ON NSQF ALIGNED AND APPROVED STT CERTIFICATE FOR TRAINING UNDER SAMAGRA SHIKSHA

3.1. In the 24th NSQC meeting, the Committee had approved 10 standard certificate templates (STT, LTT, DGT, Armed Forces etc.) for certification by all the NCVET recognized Awarding Bodies (ABs). The Committee had also consented to the use of the logo of funding agencies/ organizations at the designated place in the certificate.

3.2. Now NCVET has received requests from some of the recognized ABs seeking the process for issue of NCVET approved STT certificates with NCVET logo for the certification of school students enrolled in centrally sponsored scheme for vocationalization of Secondary and Higher Secondary Education under 'Samagra Shiksha'. It is pertinent to highlight that under 'Samagra Shiksha', multiple awarding bodies, mainly the Sector Skill Councils in collaboration with the CBSE/State School Boards which implement NSQF aligned and approved short term qualifications/job roles.

3.3. Under Samagra Shiksha Scheme, NSQF aligned and approved qualifications are implemented by the CBSE boards as well as the state boards through recognized awarding bodies (SSCs). As the CBSE has also been recognized as NCVET awarding body (dual category) they may get NSQF aligned and approved qualifications assessed under their own arrangement and issue NCVET approved certificates to the children as per the guidelines on this subject.

3.4. However, if the CBSE board implements the assessment of these VET qualifications through the respective domain SSCs, as is the case in the present scenario, The SSCs/ ABs may continue to get assessed, through the empaneled NCVET recognized Assessment Agencies, all such qualifications as approved by NSQC and they may issue NCVET approved certificates with a combined logo of both the Awarding Bodies.

3.5. In case of the State Boards, who are not recognized as an Awarding Body of the NCVET, they may get the NSQF aligned and approved qualifications assessed through the respective concerned domain Awarding Bodies/ Sector Skill Councils and issue the NCVET approved certificate to the school children through such Awarding Bodies/ Sector Skill Councils. However, they are advised to involve the NCVET recognized ABs/ SSCs through an MoU/ agreement and get the training and assessment implemented as per the policy on the subject.

3.6. However, in case of such state boards which are not recognized ABs of NCVET, wish to run the NSQF aligned and approved qualifications on their own and conduct the training and assessment all by themselves, they shall not issue the NCVET approved nationally recognized certificates to the students/learners. However, they may issue their own certificates as deemed appropriate.

3.7. It is further mentioned that NCVET has already published the policy on use of Logo and Certification vide Para 10 of section 4.3 under continuation criteria of Awarding Body Guidelines. The same is reiterated by reproducing below :

"Para 10. Others

- a. Usage of logo: The recognized AB must ensure that the usage of NCVET logo is in line with the NCVET Guidelines.*
- b. Certification:*
 - i. The recognized AB must ensure that the certificates issued by it are as per the format prescribed by NCVET.*
 - ii. The recognized AB must ensure that certificate is released to the learners within a stipulated time, as defined by NCVET.*
 - iii. Certificate should be available through secured online platforms.*
 - iv. Storage of digital certificates in National Academic Depository"*

3.8. It is reiterated that all NCVET recognized Awarding Bodies shall follow the Guidelines including amendments/addendum issued from time to time in letter & spirit with regard to use of Logo and issue of certification. E copy of this agenda and decision taken on this item may be shared with all the state governments for information and necessary action.

4. AGENDA ITEM NO 4: USAGE OF NCVET APPROVED CERTIFICATE TEMPLATE FOR NSQF ALIGNED & APPROVED QUALIFICATIONS BY THE RECOGNIZED AWARDING BODIES

4.1 A total of 12 certificate templates have been approved by NSQC to cater to various types of programs and by different recognized awarding bodies. In order to enable ABs to issue the certificates to the students/ learners after assessments through Skill India Portal (SIP), these templates along with explanatory notes have been shared with NSDC for implicit implementation so that a proper record of issue of certificates is maintained.

4.2 Currently there is no provision for on boarding all the NCVET recognized awarding bodies other than sector skill councils on the skill India portal (SIP). Further, there is no provision for issue of certification by any NCVET recognized awarding bodies, including sector skill councils, for the fee-based trainings conducted by them. Keeping in view that there is emphasis on fee-based trainings, there is an urgent need to create a common IT platform like SIP at least till suitable upgradation/ modification in SIP is made so that necessary provision can be made immediately for issue of certification on all the NSQF aligned and approved qualifications either government funded or fee based programs so that the process may be brought under regulation for the purpose of record keeping.

5. AGENDA ITEM NO 5: MODIFICATION IN THE ENTRY CRITERIA FOR THREE (03) QUALIFICATIONS OF CTS AND CORRESPONDING CITS

5.1. The Committee in its 22nd NSQC meeting had approved the following three (03) CTS qualifications of DGT:

- a) Fire Technology and Industrial Safety Management (2022/SEC/DGT/06314).
- b) Health, Safety and Environment (2022/HLT/DGT/06272).
- c) Fireman (2022/SEC/DGT/06312).

5.2. The minimum physical standards in the entry requirements of these three qualifications were drafted in line with the Recruitment Rules (RRs) of various government organizations and requirements of the industry which was only applicable for men. Keeping in view the gender equality, the provision for entry of women has also been included and accordingly the physical attributes for the women candidates for the above mentioned three qualifications have been published in RR as also in many states' RRs.

5.3. Accordingly, DGT has proposed to include the following physical standards for the corresponding CTS Qualifications in line with the state and RRs:

For Men	For Women
Height: - Minimum 165 cm. (with provision for relaxation by 5 cm in the case of Garhwals, Assamese, Gorkha and member of the Schedule tribes).	Height: - Minimum 157 cm (with provision for relaxation by 2.5 cm in case of Garhwals, Assamese, Gorkha and member of the Schedule tribes).
Chest: - Minimum 81 cm unexpanded and 86 cm with expansion (Fully expanded with minimum of 5 cm expansion)	
Weight: - Minimum 50 Kg	Weight: - Minimum 46 Kg

6. AGENDA ITEM NO 6: CUSTOMIZATION OF EIGHTY FIVE (85) NSQF ALIGNED QUALIFICATIONS (SHORT TERM TRAINING-STT) WITH 210 NOTIONAL HOURS FOR EXCLUSIVE IMPLEMENTATION UNDER PMKVY4.0

6.1. A meeting was convened regarding shortlisting of existing NSQF aligned and approved qualifications to be run under the PMKVY3.0/ 4.0 scheme. The qualifications of NSQF levels up to 4 which are high in demand in the industry and have good placement prospects were to be selected by the awarding bodies and suitably modifying the notional hours to 210 Hrs with other suitable changes. Following parameters were decided for the customization of existing NSQF aligned and approved qualifications:

- a) The duration of the qualification has been rationalized to 210 Notional hours. (about a month)
- b) 210 hours shall include Employability Skills (ES) of 60/ 90/ 120 hours as proposed by the recognized AB and approved by the NSQC and the balance duration shall be covered under domain skills of that qualification.
- c) The nomenclature of the qualifications has been given as per their Learning Outcome and competencies being achieved. The new qualifications have been renamed as per the need of the industry and NOSs have been selected as per the competency outcome expected from that job role.
- d) The ABs/ SCCs submitting these customized courses are expected to ensure 90 percent placement of the total enrolled candidates under the scheme.

6.2. As number of notional hours of all these customized courses have been rationalized to 210 Hrs, the entry level criteria of these customized qualifications have also been raised by one NSQF level for ease and better comprehension of the qualification content without impacting the competency outcome expected from that qualification.

6.3. The validity of these selected qualifications would be only for a period of 06 months i.e from 15th February 2023 till 15th August 2023.

7. AGENDA ITEM NO 7: REINSTATING RASCI AS AN AWARDING BODY BY THE NCVET

7.1. Retailers Association's Skill Council of India (RASCI) has been recognized as an Awarding Body of NCVET on 07/02/23. The awarding rights with respect to 20 Qualifications originally developed and aligned to NSQF by RASCI, which were earlier given to the other awarding bodies in the absence of RASCI, have also been reinstated vide an Order No. 21004/01/2022/NCVET dated 16/02/23 superseding the previous order No.36002/9/2022/ NCVET and partial modification of Order of even no dated 01/06/2022 issued by NCVET on the subject ibid.

7.2. However, to facilitate undisrupted continuation of training and certification in the retail skill ecosystem in the absence of RASCI as an Awarding Body, adoption rights of RASCI qualifications which were granted to five (05) NCVET recognized Awarding Bodies (AB) vide an Office Order No. 21004/01/2022/NCVET dated 01/06/22 continues to be in vogue mutatis-mutandis.

Agenda is submitted for the kind information and ratification of the Committee.

8. AGENDA ITEM NO 8: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

8.1. A total of one hundred eleven (13 New and 98 Revised) qualifications and two (2) new NOSs have been received till 31st December 2022. Fifty-one qualifications (10 new and 41 revised) and two NOSs are being considered for placing in the NSQC. Sixty (60) qualifications have been returned to the submitting bodies after stakeholders' consultation for compliance and resubmission.

8.2. The details of qualifications being considered for 27th NSQC are as under: -

- a) New QFs - 10.
- b) Revised QFs - 41.
