(c)	Recognition of NCVET approved Qualifications by National Accreditation Board for Hospitals & Healthcare Providers/National Accreditation Board for Testing and Calibration Laboratories (NABH/NABL)	In the 5th NSQC meeting it was brought out by Dr. Sangita Reddy that NABH/NABL recognizes the Diploma as approved by Paramedical Board and not of the NCVET approved qualifications. Taking this into account, the Chairperson directed Healthcare SSC to provide a brief note on the problems in this regard and NCVET may subsequently take up the matter with Ministry of Health and Family Welfare (MoHFW).	Letter has been sent to Healthcare SSC to provide the brief and the same is awaited. The brief note on linking/mapping of NCVET with NABH/NABL has been received from Dr. Sangita Reddy on 22 nd March,2021. Accordingly, a draft DO Letter has been put up for approval.

(d)	Ratification of De-activated Courses related to Healthcare Sector	<p>The Committee was informed about the deactivation of qualifications of healthcare sector based on MoHFW comments and accordingly HSSC was requested to share the details of trainees who have already started training in these courses for taking a considerate decision. The same was ratified by the Committee. Further, the Committee directed that the training w.r.t deactivated courses, being carried out under the programme of Vocational Education in Schools shall continue only for the current academic year in schools. It was also requested from Department of School Education, Ministry of Education, to furnish the details of batches (comprising start date, end date and name of Healthcare Qualifications) of published deactivated courses being run in schools. Chairperson also directed that no fresh training/admissions shall be allowed in these qualifications</p>	<p>Director, Dept. Of School Education communicated that a total of 219 students are undergoing training in the course-'Vision Technician' and will be completed in 2020-21 session i.e. by March 2021.</p> <p>The course 'Vision Technician' was deactivated wef 09th December, 2019 and all the stakeholders like- NSDC, Healthcare SSC, MoE, were intimated to ensure that no fresh admissions are made in the said course.</p> <p>The said course also has reference to a Writ petition wherein the Hon'ble court was informed through counter affidavit that the said course has been deactivated and the judgement of the court is as follows- "All qualifications for Health care or Eye Care sectors are to be initiated in accordance with law, rules and regulations & Govt. polices."</p> <p>The matter has been brought before the Committee for further direction.</p>

	(i) Directorate General of Training(DGT)	In 24 th NSQC meeting (under NSDA) held on 27 th February, 2020, three (03) Qualifications of DGT namely “Health Sanitary Inspector (CTS)”, “Health Safety & Environment (CTS)”, and “Old Age Care (CTS)” relating to Health sector were conditionally approved subject to concurrence of Ministry of Health and Family Welfare (MoHFW).	MoHFW has approved three Qualifications with proposed changes. The compliance wrt these three Qualifications have been completed by DGT and the files are placed for approval of the Committee. Details of files are placed at Annexure 1(C).

AGENDA ITEM NO 03: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

1. A total of 31 files were received by NCVET from 1st January to 31st January2021 for NSQF alignment. The details of the files received are as under: -

- a) Fresh QFs - 13
- b) Revised QFs - 18

2. Following twelve Qualification Files are not being considered for 6th NSQC. Justifications are mentioned as under: -

- a) The revised Qualification-'Pradhan Mantri Aarogya Mitra' submitted by Healthcare Sector Skill Council is not being considered as the study report on appropriateness of hours and progression as suggested by NSQC in its 21st meeting held on 03.08.2018 was not furnished by the Submitting Body.
- b) One Qualification File of 'Furnace Technician' submitted by Iron and Steel SSC is not being considered as comments of DGT related to NAPS files were shared with SSC. However, the response of SSC on the comments is still awaited.

- c) Seven revised Qualification Files of Telecom SSC have not been considered as the files have been found incomplete wrt Industry validations and Line Ministry concurrence. Revised files are yet to be received from SSC.
- d) Three Qualification Files submitted by Directorate of Handicrafts and Cottage Industries, Odisha were found to be incomplete wrt curriculum and industry validations.

3. Hence **nineteen (19) Qualification Files** are being placed for consideration in the 7th NSQC under NCVET. Summary of the Qualification Files are as below: -
