**AGENDA ITEM NO 03: SUBMISSION OF FRESH QUALIFICATIONS FOR NSQF ALIGNMENT**

4. A total of 38 files were received by NCVET from 1<sup>st</sup> November 2020 to 30th November 2020 for NSQF alignment. The breakup of the files received is as under:-

(a) Fresh QFs - 13

5. Following Qualification Files not being considered for 5<sup>th</sup> NSQC. Reasons mentioned as under:

- a) Four Qualification files (2 new and 2 revised) of Gems & Jewellery SSC were rejected and returned as supporting documents (Industry validations and Line Ministry concurrence) submitted by them were under a different name.
- b) One new QF from Retail SSC neither had Line Ministry concurrence nor have shown any correspondence with Line Ministry to indicate such effort.
- c) Seventeen revised files of NIELIT are not being tabled in the 5<sup>th</sup> NSQC. Out of 17 QFs, 11 Qualification files were first approved in 19<sup>th</sup> NSQC dated 28.11.2018. They have been submitted for the first revision without any modifications. 6 QFs were first approved in 13<sup>th</sup> NSQC dated 02.05.2018. They had come up for first revision in 23<sup>rd</sup> NSQC without any modification, however were approved. The same 6 qualifications have now come up for the second revision without any modifications. It is noted that even though these files pertain to the technology sector, they haven't been regularly updated and no justification has been provided for the same. Furthermore, industry validations are missing for these 17 files.

6. Hence **sixteen Qualification Files** are being placed for consideration in the 5th NSQC. Summary of the Qualification Files are as below:

#### **AGENDA ITEM NO 04: APPROVAL OF QUALIFICATIONS SUBMITTED BY SKILL COUNCIL FOR PERSONS WITH DISABILITIES (SCPwD)**

7. SCPwD has developed an expository to modify training and assessment methodologies based on the requirements of specific disabilities (like Visual Impairment, Speech & Hearing Impairment, etc) without altering the assessment criteria of the adopted job roles. In order to train PwD under PMKVY 3.0, SCPwD has adopted 41 NSQF aligned job roles in 15 following sectors **with concurrence of domain Sector Skill Councils** and after mapping with types of disabilities has submitted 74 Qualification Files along with supporting documents for approval.

**Sectors:** Automotive, Beauty & Wellness, Construction, Domestic Workers, Electronics, Food Processing, Furniture, Gems & Jewellery, Green Jobs, Handicrafts, Healthcare, Leather, Media, Retail and Textile.
