

**MINUTES OF THE 33rd MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE
(NSQC) HELD ON 01st November 2023**

The **33rd meeting** of the National Skills Qualifications Committee (NSQC) was held on **01st November 2023**, through Video conferencing, under the Chairpersonship of Dr. Nirmaljeet Singh Kalsi, Chairperson, National Council of Vocational Education and Training (NCVET). The list of participants is at **Annexure- I**.

The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

1. AGENDA ITEM 01: Confirmation of the Minutes of the 32nd Meeting of NSQC held on 29th September 2023

1.1 The Committee **confirmed the Minutes** of the 32nd meeting of the NSQC held on **29th September 2023** and approved the same.

1.2 The Committee was apprised about one Qualification namely '**Security Supervisor**' of **Directorate of Infantry, Indian Army**, which was approved at NSQF Level 5 in **30th Meeting** of NSQC held on 23rd June 2023. However, the NSQF level of the qualification was inadvertently mentioned at NSQF level 4.5 in the minutes of the meeting. The necessary corrections are given as under:

The Committee took note of the editorial correction and approved the same.

2. AGENDA ITEM 02: Action taken report on the decisions taken in the 32nd Meeting of NSQC

2.1 The detailed account of the **action taken** was presented before the Committee on the Minutes of the 32nd NSQC meeting. The Committee took note of the action taken and **approved** the same and further emphasized the following:

2.1.1 Status of 10 NSQF Aligned and Approved Foreign Language Qualifications submitted by English & Foreign Languages University, Hyderabad (EFLU)

The Committee was given the status update regarding 10 NSQF aligned and approved foreign language qualifications submitted by English & Foreign Languages University (EFLU), which were approved in the 19th meeting of NSQC dated 26th May 2022. The Committee in its 32nd meeting of NSQC requested UGC to issue directions to the concerned universities to expedite the submission of training numbers conducted by them. Further, the Committee also requested EFLU to expedite the submission of NSQF level 2 and 3 of afore-mentioned 10 Foreign Language Courses. Accordingly, the Committee was apprised that as per the information received from UGC so far, no

trainings have been carried out on these qualifications. Also, it was further apprised to the Committee that there was a lack of clarity between stakeholders and EFLU on the implementation of these qualifications across NCVET recognized Awarding Bodies, School Boards and Higher Education Institutions.

The Committee took note of the status update. Regarding the implementation of these qualifications, the Committee clarified that all the NCVET recognized Awarding Bodies and Higher Education Institutions have the autonomy to offer trainings on these foreign language qualifications for the utility of international learners desirous of going overseas. Further, the Committee requested EFLU to expedite the submission of NSQF level 2 and 3 qualifications on these ten (10) qualifications.

2.1.2 Rationalization of Qualifications:

The Committee was presented a detailed account of the status of NSQF aligned and approved qualifications rationalized with the inclusion of ES and making NOSs multiples of 30 hours, as applicable, in order to align with the National Credit Framework (NCrF). The Committee in its 32nd meeting instructed all the awarding bodies to complete rationalization of qualifications by the 33rd meeting of NSQC, ie, 1st November 2023. The Committee was apprised that out of 2775 qualifications due for rationalization, a total of 1830 qualifications have already been rationalized. The rationalization of balance 945 qualifications is under progress by the respective Awarding Bodies. A detailed table giving the same has been attached as **Annexure II**.

The Committee took note of the pending qualifications due for rationalization and on special request of the Awarding Bodies, the Committee decided to provide a final extension of one month's time period for all the recognized ABs to complete the rationalization of their remaining NSQF aligned and approved qualifications latest by 30th November 2023.

The Committee further decided that the qualifications that remain unratinalized beyond this timeframe it will be presumed that Awarding Body concerned doesn't want to pursue the qualification and the same will be archived on the NQR portal.

2.1.3 Registration and on-boarding of the NCVET recognized Awarding Bodies and Assessment Agencies on SID by NCVET as part of the process of recognition.

The Committee in its 32nd meeting had asked NSDC to create a separate section for NCVET on the dashboard of SID portal. Accordingly, the committee was apprised about the progress made so far in this regard. The Committee was informed that NCVET has conducted a meeting with NSDC and the process flow designing for onboarding Awarding Bodies has already been developed. Furthermore, a similar process flow designing for Assessment Agency onboarding is under progress and shall be completed in due course. On the request of NSDC, NCVET has already provided the list of key attributes that need to be displayed on the dashboard under the SID portal. In addition, the Committee was also apprised about the existing QP building software facility on SID which shall be integrated with NCVET dashboard and provided to all the NCVET

recognized Awarding bodies for assistance in developing their qualifications and the facility is being developed on the portal.

The committee took note of the current status and acknowledged the progress made so far in this regard.

2.1.4 Training of Trainers' (TOT) and Training of Assessors' (TOA) calendars.

In the 32nd meeting of NSQC, the committee had directed all the NCVET recognized ABs and AAs to submit their Training of Trainers' (ToT) and Training of Assessors' (ToA) calendars and upload/ display the same on their respective websites. The committee was apprised that **so far, out of 62, 16** Awarding Bodies have submitted their TOT and TOA calendars to NCVET. A detailed list is attached as **Annexure III**.

The Committee noted the current status and reiterated that all the NCVET recognized ABs and AAs are required to promptly submit their Trainer of Trainers (ToT) and Trainer of Assessors (TOA) calendars to NCVET and upload/ display the same on their respective websites. The Committee stated that Awarding Bodies that fail to provide these details may not be eligible for participation in schemes such as PMKVY and PM Vishwakarma.

3. Agenda Item 03: Correction in the NSQF level of Qualification- 'Carpet weaver (Divyangjan) - LD' and 'Carpet weaver (Divyangjan) - SHI of SCPwD approved in the 31st meeting of NSQC.

3.1 The Committee was apprised about the two (02) qualifications of SCPwD namely '**Carpet weaver (Divyangjan)-LD**' and '**Carpet weaver (Divyangjan)-SHI**' submitted at NSQF level 3 in the 31st meeting of NSQC held on 31st August 2023. However, due to the notional hours being comparatively higher than the prescribed hours, the Committee approved these qualifications at level 3.5, instead of 3. The Committee was also informed that the above-mentioned two qualifications have been adopted by SCPwD from Handicraft SSC which were originally approved at NSQF level 3.

3.2 The Committee was further informed about the request received from SCPwD to retain the original NSQF level 3 of these qualifications in order to ensure that these qualifications are aligned with the domain qualifications and to avoid any challenges while updating the same on SID Portal.

The Committee approved the request to retain the two qualifications at NSQF level 3.

4. AGENDA ITEM 04: Adoption of NSQF aligned and approved Qualifications by various Defence Awarding Bodies.

4.1 The Committee was apprised that Headquarters, Army Training Command (ARTRAC) vide letter dated 20th Oct 2023, has shared a list of following 31 Qualifications which are proposed for adoption by 16 Directorates of Indian Army (Awarding Bodies). Detailed list of 31 qualifications is attached as **Annexure IV**. The summary of the qualifications being adopted by various defense ABs is given below:

The committee took note of the same and ratified the adoption of qualifications being adopted by various Defence ABs.

5. Agenda Item 05: Submission of Qualifications, NOSs and MCs for NSQF Alignment & Approval by Awarding Bodies



5.1 The Committee was apprised that a total of 83 (52 New and 31 Revised) qualifications, 04 NOSs and 05 Micro-Credentials have been received at NCVET as on 31st August 2023. Out of which, a total of 58 (52 New and 6 Revised) qualifications, 04 NOS and 05 MCs have been considered for placing in this NSQC.

5.2 The decision of the committee on all the considered qualifications, NOSs and MCs is given in succeeding paras. The detailed status of approval and decision of the committee is at **Annexure V.**

5.3 NSQF alignment and approval of qualifications submitted by Awarding Bodies (Central Ministries/State Bodies/SSCs/Other Govt & Pvt Bodies)

- 5.3.1 Directorate General of Training (DGT):** One (01) new qualification was presented before the Committee and was **approved**.
- 5.3.2 International Automobile Centre of Excellence (iACE):** Two (02) new qualifications were presented before the Committee and were **approved**.
- 5.3.3 Institute of Cost Accountants of India (ICAI):** One (01) new qualification was presented before the Committee and was **approved**.
- 5.3.4 National Film Development Corporation (NFDC):** Two (02) new qualifications were presented before the Committee and were **approved**.
- 5.3.5 Haryana State Electronics Development Corporation Limited (HARTON):** One (01) revised qualification was presented before the Committee and was **approved**.
- 5.3.6 Maharashtra State Board of Skill, Vocational Education and Training, Skill, Employment, Entrepreneurship and Innovation Department:** One (01) new qualification was presented before the Committee and was **approved**.
- 5.3.7 Hydrocarbon Sector Skill Council (HSSC):** One (01) new qualification was presented before the Committee and was **approved**.
- 5.3.8 Life Sciences Sector Skill Development Council (LSSSDC):** Seven (07) new qualifications were presented before the Committee and were **approved**.

With reference to the qualifications pertaining to LSSSDC sector, the Committee took reference of the meeting held between the Pharmacy Council of India (PCI) and NCVET. During this meeting, it was conveyed that the Curriculum Committee of PCI is actively working on the implementation of NCrF and NEP across all their qualifications and is also looking forward to integrate the skill qualifications developed by the LSSDC in their regular degree program curriculum under the provisions of NCrF.

The Committee emphasized that on the need to incorporate soft skills/ employability skills in the curriculum structure of PCI. In view of the shortage of the pharmacists, the Committee decided to request PCI to design their courses centered around the BSc. Chemistry program as well to enable entry gateways in the field of Pharmacy.

- 5.3.9 Retailer Association's Skill Council of India (RASCI):** One (01) new qualification was presented before the Committee and was **conditionally approved subject to the submission of adequate number of industry validations**. The Committee also pointed out that the qualification is not a future qualification.

5.3.10 Skill Council for Persons with Disability (SCPwD): Fourteen (14) new qualifications presented were **approved** and five (05) revised qualifications presented before the Committee were **approved** for **one year** due to insufficient training numbers.

With reference to the five revised qualifications of SCPwD, the Committee took a note of the lesser number of trainings conducted in revised qualifications. It was reiterated by the Committee that SCPwD has been provided an extended timeframe of one year to conduct trainings on the qualifications, as against the original 6-month duration provided to other ABs. The Committee emphasized on the need to create awareness about these qualifications through social media and collaborations with the concerned Ministries, State Disability Departments, NGOs and other institutions engaged in the empowerment of Persons with Disabilities. The Committee stressed on the importance of conducting Trainer of Trainers (ToT) and Trainer of Assessors (ToA) for these qualifications and the availability of certified trainers, master trainers and assessors in this area.

The Committee recommended that psychometric assessments of interested Persons with Disabilities also needs to be carried out to assist them in career guidance and employment opportunities. If necessary, additional training centers can be established in areas where there is a huge demand for PwD based qualifications. SCPwD responded that the PM Daksh portal currently offers the facility to register interested candidates for training under qualifications for Persons with Disabilities. ***Additionally, the Committee recommended CEO, SCPwD to organize a meeting with Indian Defence Forces and gain an understanding of the training requirements in clusters where former defence personnel with disabilities can be identified and attain gainful employment as trainers/ assessors with training centers.***

5.3.11 Centurion University (CUTM): Four (04) new qualifications were presented before the Committee and were **approved subject to the submission of adequate number of industry validations, which was agreed upon by the AB.**

5.3.12 Medhavi Skills University (MSU): One (01) new qualification was presented before the Committee and was **approved subject to changes in the entry requirements of the qualification, which was agreed upon by the AB.**

5.4 NSQF alignment and approval of NOSs submitted by Awarding Bodies (Central Ministries/State Bodies/SSCs/Other Govt & Pvt Bodies)

5.4.1 Haryana State Electronics Development Corporation Limited (HARTRON): One (01) new NOS was presented before the Committee and was **approved**.

5.4.2 Construction Skill Development Council of India (CSDCI): One (01) new NOS was presented before the Committee and was **approved**.

5.4.3 Life Sciences Sector Skill Development Council (LSSSDC): Two (02) new NOSs were presented before the Committee and were **approved, subject to the submission of adequate number of industry validations, as agreed upon by the AB.**

5.5 NSQF alignment and approval of Microcredentials submitted by Awarding Bodies (Central Ministries/State Bodies/SSCs/Other Govt & Pvt Bodies)

5.5.1 Life Sciences Sector Skill Development Council (LSSSDC): Four (04) new NOSs were presented before the Committee and were **approved subject to the submission of adequate number of industry validations, as agreed upon by the AB.**

5.5.2 International Automobile Centre of Excellence (iACE): One (01) new NOS was presented before the Committee and was **approved.**

5.6 NSQF alignment and approval of Qualifications submitted by Defence Forces

5.6.1 Corps of Engineers: Thirteen (13) new qualifications were presented before the Committee and were **approved** subject to the following changes in the nomenclature, which were agreed upon by the AB:

5.6.3 Directorate General of Army Air Defence: One (01) new qualification was presented before the Committee and was **approved**.

5.6.4 Army Medical Corps: One (01) new qualification was presented before the Committee and was **approved**.

6. AGENDA ITEM 06: Additional Agenda with the permission of the Chair

6.1 Proposal for NSQF alignment and approval of qualifications and certification of Participants at various levels in the run-up to the World Skills Competition

6.1.1 The Committee was apprised that NSDC, under the aegis of MSDE, conducts the India Skills Competition, on the basis of the qualifications for the WorldSkills competition. IndiaSkills is country's biggest skill competition and is designed to demonstrate the highest standards of skilling and offers a platform to young people to showcase their talent at national and international levels. Further, the participants of India Skills Nationals emerge from winners of district/state and subsequently pre-national level competitions which are organised by NSDC. The winners of national skills competition, through the process of selection, represent India at WorldSkills and other international competitions.

6.1.2 The competition is conducted under **61 (52+ 09) trades/skills/ job roles**. **52 trades/skills/ job roles** have been specified in **six sectors as specified by the WorldSkills**, namely **Construction and Building Technology, Creative Arts and Fashion, Information and Communication Technology, Manufacturing and Engineering Technology, Social and Personal Services, Transportation and Logistics**. In addition, under **Special/Exhibition Skills** **nine (09) traditional and new skills** have also been included in the competition till India Skills . The detailed skills (job roles) in each sector is attached as **Annexure I**. The committee was also informed that standards for all the qualifications mentioned in the **Annexure I** are well established and published as per the international standards. The standards are set every year with certain percentage of change.

6.1.3 The committee **accorded 'In principle' approval** to the proposal and **advised the following**:

- a) Recognised ABs (SSCs) of the concerned sectors to adopt WorldSkills standards including the nomenclature of skills NOS and weightage and prepare these qualifications as per the National Skills Qualification Framework and submit before the National skills Qualification Committee (NSQC) for consideration of NSQF alignment and approval by the committee **by 18 November 2023 on Top Priority**.
- b) Concurrently, owing to the peculiarities of training and assessment of the participants for preparing them in run-up to the World skills event, a combined **ToT and ToA**

qualifications of the six sectors as per para 2 above may also be developed by the respective recognised ABs(SSCs) and brought before the NSQC for NSQF alignment and approval.

- c) As the content of these skills (qualifications/job roles) are revised periodically for the WorldSkills competition, the **validity of these skills (qualifications), may be only for two years/ as per the WorldSkills competition cycle whichever is earlier.**
- d) The requirement of **industry validation and line ministry concurrence** for these skills may be **waived off**.

6.1.4 Keeping in view that at the pre-screening stage, assessment of the skill proficiency of the participants who register themselves directly on the Skill India Digital portal managed by NSDC, on behalf of MSDE, would be difficult owing to the large numbers, hence as the participants go through various phases of screening through assessments, they may be given NCVET approved certificate after clearing the prescribed assessment at various levels. Further, the learning outcomes/competency being achieved from the said qualifications being the same, it was decided by the committee that to distinguish the participants clearing the various phases of the competition, the award of certificates at each level would be given as follows:

- a) At the Pre-Screening assessment, participants clearing the assessment as per prescribed norms may be given an '**India Skills competition eligibility**' certificate.
- b) At the state Competitions/Track 2 Competition Phase, participants qualifying the prescribed assessment may be given NCVET approved certificate duly suffixed with '**India Skills- State Level**' for the Skills qualification individual has successfully cleared the prescribed assessment.
- c) At the Pre-National Competition Phase participants qualifying the prescribed assessment may be given NCVET approved certificate duly suffixed with '**India Skills Pre-national**' for the Skills qualification individual successfully cleared the prescribed assessment.

Finally at the national level – participants may be given NSQC approved Certificate duly suffixed with '**India Skills-National**' for the Skills qualification in which the successfully cleared the prescribed assessment.

6.1.5 The committee further advised that the assessment process to be adopted will be through formative assessment in the form of competition. The state government may carry out the assessment through the industry experts or may take the assistance from the recognized assessment agencies on boarded by the concerned sector skill councils who have originally developed the respective qualifications. In either case, it would be mandatory to give an orientation capsule on the assessment norms prescribed in the NSQC approved and NSQF aligned skills qualifications.

6.1.6 It was informed by the NSDC that they have also introduced a wild card entry from this year for the world skills competition. The eligibility criteria for such entry have been given as all those participants who had secured first three positions in the competition held at national level for the last world skills competition in their respective skills and could not secure a position in the world skills competition and are still within the prescribed age limit, may register themselves under the wild card category and they would be assessed directly at the national level assessment.

6.1.7 Further NSDC has also proposed that five trades/skills/ job roles namely, welding, industrial control, robot system integration, additive manufacturing and industry 4.0 be transferred to ASDC on the basis of industry connect and subject matter expertise.

The Committee deliberated on the proposal of NSDC and approved for the implementation. The committee also advised that NSDC may frame a working Guidelines on the process of certification of IndiaSkills participants at each level of competition in consultation with concerned ABs (SSCs), get these guidelines approved by NCVET in respect of the NSQF aligned and approved Qualification and communicate to all the states with due approval of the Ministry of Skill Development and Entrepreneurship, MSDE

6.2 Submission of New/ revised/ rationalized qualifications by the recognized Awarding Bodies to NCVET for NSQF alignment and approval

6.2.1 The Committee was given a brief background of the Revised National Skills Qualifications Framework (NSQF), which has been notified on 6th June 2023. Accordingly, the Committee in its previous meetings has time and again asked all the recognized Awarding Bodies to rationalize their approved qualifications with the inclusion of ES and making NOSs multiples of 30 hours, as applicable, in order to align with the National Credit Framework so that every learning hour is creditized in consonance with the provisions of NCrF.

6.2.2 The Committee was further apprised that NCVET has recently upgraded the National Qualification Register (NQR) portal, which is currently live with the new enhancements and functionalities. In addition, the data migration from the old portal to the new one is under progress. Considering the challenges associated with the formats of the already uploaded files on NQR, the Committee was apprised that to enable timely migration of the pending data and to facilitate improved navigation, all the Awarding Bodies have been advised to submit the new, revised and rationalized qualifications in the following format.

- Industry validation as per the existing format
- Line Ministry concurrence
- Evidence of need
- Occupational Map
- Photograph of each qualification in JPG format (not exceeding 50 KB)
- NOS Table in excel format (enclosed as Annexure VII)

The committee directed all the NCVET recognized awarding bodies to submit their qualifications in the specified format as illustrated above. The Committee requested all the concerned CEOs of the recognized Awarding Bodies to personally check their respective qualifications in collaboration with the concerned NCVET officials and provide a confirmation regarding the correctness of the same.
