**OFFICE MEMORANDUM**

**Subject: Constitution of Internal Committee (IC) in respect of the employees of NCVET under Section 4 of the Sexual Harassment of Women at Workplace (prevention, Prohibition and Redressal) Act, 2013**

Under the provisions of Section 4 of the Sexual Harassment of Women at Workplace (prevention, Prohibition and Redressal) Act, 2013, Competent Authority, NCVET has constituted the Internal Committee (IC) in NCVET with the following composition:-

- i) Dr. Neena Pahuja , EM, NCVET, -Presiding officer
- ii) Dr. Manasi Mishra, HoD, Research Division, Centre for Social Research Member
- iii) Ms. Sarika Dixit , Consultant Grade-II, NCVET
- iv) Dr. Suhas Deshmukh, Director, NCVET-Member Convener

2. The terms of reference of the Committee shall be as under:

- i) The internal Committee (IC) shall look into complaints of Sexual Harassment at work in National Council for Vocational Education & Training (NCVET) and devise effective measures to ensure a better environment for women at workplace. It would also welcome complaints, grievances or suggestions, if any, in this regard to ensure a congenial atmosphere to the working of men and women.
- ii) The Presiding Officer and every member of the IC, NCVET shall hold office for a period of three years or till further orders, whichever is earlier.
- iii) The Committee shall be effective and functional at all times. It will meet once a quarter even if there are no live cases.
- iv) The Committee shall in each calendar year prepare a report for inclusion in the Annual Report of the NCVET.
- v) The Committee shall furnish an annual return (as on 31st March) in the prescribed proforma to DoPT by 30th April every year.
