17. AGENDA ITEM 17: Submission of Qualifications for NSQF Alignment & Approval.

- 17.1 A total of **260 Qualification/NOSs/MCs** (which include 101 New and 74 Revised qualifications, 59 NOSs and 26 Micro-Credentials) have been received at NCVET during the qualifying period. **A total of 200 Qualification/NOSs/MCs** (which includes 55 New and 64 Revised qualifications, 58 NOSs and 23 Micro-Credentials) were placed in the 39th NSQC Meeting (Phase I) held on 25th July 2024. Details of the Qualifications under consideration are mentioned in the succeeding paras. The details of **56 Qualifications, 1 NOSs and 3 MC** not considered due to compliance issues are attached at [Annexure II](#).
- 17.2 Subsequently, **80 Qualifications/NOSs/MCs** (Comprising 21 New and 14 Revised qualifications, 41 NOSs and 4 MCs) were discussed in the Phase-I of the 39th NSQC Meeting. The following decisions were taken by the committee:




