

**PUBLIC WARNING / सार्वजनिक चेतावनी**

**Subject: Public Warning to 16 Awarding Bodies on Oversight of Compliance with NCVET Guidelines and Office Orders**

1. It has been observed that **16 Awarding Bodies** (Listed in Annexure I) have reported certification-related issues **concerning more than 4,526 batches**. These batches were allegedly formed under Qualifications that were **either expired or not rationalized**.
2. This is in violation of the following Office Orders of NCVET:
  - i. Office Order No. 32001/05/2023/NCVET dated **5th September 2023** regarding "Implementation of National Credit Framework (NCrF) & NSQF Norms Rationalization of Existing NSQF Aligned & Approved Qualifications & Certification by Recognized Awarding Bodies".
  - ii. Office Order No. 32001/10/2024/NCVET dated **15th October 2024** regarding "Clarification on Issuance of Certification for Candidates in Training Batches Initiated Before 1st November 2023".
3. These **16 Awarding Bodies (ABs)** are **warned** that non-compliance with NCVET's orders shall lead to **regulatory actions**, including but not limited to:
  - i. Suspension of AB recognition
  - ii. De-Recognition for repeated violations.
4. Awarding Bodies shall work in coordination frequently with the **project implementing agencies** to resolve technical and functional issues related to batch formation and certification. However, this **does not exempt ABs from their compliance responsibilities**.
5. This public warning is issued with the **approval of the Competent Authority** and is effective **immediately**.
