

MINUTES OF THE 45th MEETING OF NATIONAL SKILLS QUALIFICATION COMMITTEE (NSQC) HELD ON 06th February 2026

The 45th meeting of the National Skills Qualifications Committee (NSQC) was held on 06th February 2026 in hybrid mode, under the Chairpersonship of Smt. Debashree Mukherjee, Chairperson, National Council for Vocational Education and Training (NCVET). The list of participants is at [Annexure I](#). The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA ITEM 01: Confirmation of the Minutes of the Meeting of the 44th National Skills Qualification Committee (NSQC) held on 07th October 2025

1.1. The Committee was apprised that the minutes of the 44th meeting of NSQC held on 07th October 2025 were circulated and following corrections has been received.

1.1.1 Correction in the breakup of Notional Hours of one Qualifications of Management Sector

- a. The breakup of notional hours of one revised qualification of the Management Sector, submitted by the Management & Entrepreneurship and Professional Skills Council (MEPSC), was erroneously mentioned in the agenda placed before the 44th meeting of NSQC. The total notional hours of the said qualification remain the same, i.e. 540.
- b. The corrected breakup of notional hours are placed below for consideration and rectification:

1.1.2 Correction in the NSQF level and entry requirements of two micro-credentials of Food sector, approved in the 43rd Meeting of NSQC:

- a. The National Skill Qualifications Committee (NSQC), in its 43rd meeting, approved two micro-credentials developed by the Food Industry Skill Council of India (FICSI), namely Fundamentals of Internal Audit – Food Industry and Fundamentals of HACCP Implementation – Food Industry, at NSQF Level 4.



b. It has subsequently been observed that in the **Minutes of the 43rd NSQC**, the **entry requirement** of these qualifications was inadvertently mapped to a higher level i.e. 4.5. Although the NSQF Level was correctly recorded as Level 4, the entry requirements were incorrectly reflected in the Minutes, leading to a mismatch. The corrected details of the qualifications are as follows:

AGENDA ITEM 02: Action Taken Report (ATR) on the Decisions Taken in the 44th Meeting of the NSQC

2.1 Decisions taken in the 44th Meeting of NSQC

A detailed account of the 'Action-Taken' with respect to the minutes of the 43rd and 44th meetings of NSQC were presented before the Committee. The Committee took note of the action taken and approved the same and further emphasized the following:

ASCI is working along with Madhya Pradesh Agriculture Engineering (MPAE) department for revision of "Rice transplanter machine operator cum mechanic" qualification to a shorter module as suggested by them. IT-ITeS SSC NASSCOM-Ref para 10.3.13 (c)	Twenty (20) new NOSs developed in collaboration with various Original Equipment Manufacturers (OEMs) were conditionally approved subject to submission of letters from the concerned OEMs confirming their concurrence and endorsement for implementation of the respective qualifications. iii.	Archival/ Deactivation of Non-Active and Expired qualification from National Qualification Register (NQR) Portal.	It was noted that representations were received from various Awarding Bodies (ABs) regarding the archival of their qualifications, necessitating re-examination of the details of qualifications listed under the archival/expired category. The Committee took the note and recommended to take up the archival agenda separately in the forthcoming NSQC meeting after resolving the issues.	The process of archival is an ongoing process. In the 43rd meeting of the NSQC held on 8th May 2025, a total of 607 qualifications were archived. The NQR portal is currently hosting 2599 active qualifications, while a total of 6427 qualifications have been archived so far based on approvals accorded in various meetings of the NSQC. The process of data collection and validation for archival is under way in consultation with the concerned Awarding Bodies. Additionally, the complete qualification lifecycle management is now being undertaken through Kaushalverse, and the process will be automated thereafter.

3.1. Ratification of one (01) Qualification (Transportation & Logistics sector) developed by Adani Skills and Education Foundation

AGENDA ITEM 07: Retention of Qualification Title – Assistant Mechanic – Conveyor Operation and Maintenance (ISC/Q0902)

7.1 The qualification *Assistant Mechanic – Conveyor Operation and Maintenance* (ISC/Q0902), submitted by IISSSC as a revised qualification, was approved in the 36th



NSQC. However, due to a typographical error, the Minutes of the Meeting recorded the title as *Assistant Mechanic Plant Conveyor or Operation*.

- 7.2 IISSSC has submitted that the original title accurately reflects the operational and maintenance skill domains covered under ongoing RPL training and certification programmes being conducted across SAIL plants. The revised title may lead to inconsistencies in certification, reporting, and record management.
- 7.3 SAIL stakeholders, including IISCO Steel Plant, Burnpur, and Bokaro Steel Plant, have also stated that the revised title does not clearly define the specific skill sets and competencies being imparted through the RPL programmes, which have been effectively implemented over the past two years.
- 7.4 The Iron and Steel SSC has clarified that although batches have been created and certificates generated under the revised title, no certificates have been issued to candidates to date.
- 7.5 In view of the above, and considering that no certificates have been issued post NSQC approval, it is proposed to retain the earlier qualification title *Assistant Mechanic – Conveyor Operation and Maintenance (ISC/Q0902)* in place of *Assistant Mechanic Plant Conveyor or Operation*.

The committee took note and ratified the above agenda.


AGENDA ITEM 08: Approval of Extension of Validity of Seven (07) Revised Qualifications submitted by Agriculture Skill Council of India (ASCI)

- 8.1 Seven (07) revised qualifications pertaining to the Agriculture Sector were approved with following validity owing to low training numbers, of which:
 - a. Two (02) were approved in the 39th NSQC meeting held on 27/08/2024 for a validity period of one year (valid till 27/08/2025).
 - b. Five (05) were approved in the 42nd NSQC meeting held on 18/02/2025, with a validity period of six months (valid till 18/08/2025)
- 8.2 The above seven (07) qualifications were approved on-file vide file no. 21002/01/2023/NCVET dated 14/08/2025, for an additional period of 6 months with the validity till (5 qualifications) 18-02-2026 and (2 qualifications) 27-02-2026.
- 8.3 Further as per the NCVET order FNO. NCVET-22/3/2026-O/o dated 16th Jan 2026, these seven qualifications got interim extension till 28-02-2026.
- 8.4 The Awarding body has submitted the details of training undertaken along with evidence of need and demand projections.

8.5 After detailed scrutiny as per the prescribed process and to have continuity of trainings in these seven qualifications, it is proposed that the qualifications may be approved for three years' from the original date of approval.

The committee took note and ratified the above Qualifications.

AGENDA ITEM 09: Ratification of NSQF Alignment and approval of new and revised Qualifications under India Skills/World Skills

9.1 WorldSkills is an international platform showcasing the highest standards of vocational skills, while IndiaSkills serves as the national mechanism for identifying and preparing candidates for WorldSkills competitions. In order to ensure uniformity in standards, assessment and recognition of competencies emerging through these competitions, NCVET had earlier notified the NSQF alignment and creditization framework for 61 WorldSkills/IndiaSkills trades/skills/job roles vide **NCVET Order No. 32001/06/2023/NCVET dated 26.01.2024**.

9.2 Subsequently, NCVET issued an **Office Order No. NCVET-22/18/2025** for NSQF Alignment and Operational Directions for WorldSkills/IndiaSkills Trades/Skills/Job Roles for the 2025–26 cycle various Awarding Bodies have submitted qualifications related to WorldSkills and IndiaSkills for alignment with the National Skills Qualifications Framework (NSQF). These submissions include new qualifications, revised qualifications with changes, and revised qualifications without changes.

9.3 Accordingly, as per the **NCVET Order No. 32001/06/2023/NCVET**, it is proposed that the trades and job roles developed specifically for WorldSkills / IndiaSkills competitions may be considered for NSQF alignment and approval, subject to the following points:



- a. The requirement of industry validation may be exempted for these qualifications.
- b. All such qualifications shall be aligned at NSQF Level 4.5, considering their purpose as competition-oriented skill qualifications.
- c. To avoid any ambiguity or unintended adoption for regular skilling purposes, the term "IndiaSkills / WorldSkills" shall be mentioned in brackets alongside the job role title in the qualification nomenclature.
- d. All approved changes, including nomenclature and alignment details, shall be duly reflected in the Qualification File (Q-file).
- e. The concerned Awarding Bodies shall ensure that the entire process relating to submission, approval, and updation of the qualifications is completed on the **Kaushalverse** platform, as applicable.

9.4 The list of WorldSkills / IndiaSkills qualifications submitted by the Awarding Bodies for NSQF alignment and approval is placed at [Annexure III](#).

9.5 The approval to place these qualifications in NSQC has already been accorded on file by the competent authority on file number NCVET-22/18/2025.

9.6 Awarding Bodies are required to expedite and upload qualifications related to IndiaSkills / WorldSkills on the Kaushalverse portal and NQR portal ensuring the conditions mentioned in para 9.3 a – 9.3 e.

The committee took note and ratified the above mentioned agenda.

AGENDA ITEM 10: Approval for Extension of Validity of NSQF-Aligned Diploma Qualifications of Nettur Technical Training Foundation (NTTF)

10.1 Nettur Technical Training Foundation (NTTF), an Awarding Body recognized by NCVET and has sought an extension of the validity of three (03) NSQF aligned and approved Diploma Qualifications in the Electronics Sector. These Qualifications were initially approved in the 34th NSQC Meeting held on 30.11.2023 for a period of one (01) year, i.e., up to 29.11.2024.

10.2 Upon completion of the initial validity period, NTTF sought extension of the validity of the said qualifications for a further period of one (01) year, i.e., up to 29.11.2025. The request was considered and approved in accordance with Para 8.8.1 of the Guidelines for Diploma Qualifications, and the extension was granted vide Office Order No. 36003/52/2023/NCVET.



10.3 Para 8.8.1 of the Guidelines for Diploma Qualifications provides that the validity of approved Diploma Qualifications may be extended annually for a further period of one (01) year, based on the performance of the Awarding Body.

10.4 In order to ensure continuity of the ongoing training programmes and to avoid any academic disruption, it is proposed to extend the validity of the said Diploma Qualifications for a further period of one (01) year, i.e., up to 30.11.2026.

10.5 The Committee may perused the details of the three (03) Diploma Qualifications as listed in the table below for consideration and approval.



11.4 The Committee considered the agenda items relating to Qualifications, National Occupational Standards (NOSSs), and Micro Credentials (MCs). The decisions and directions of the Committee are recorded below:

11.4.1 Directorate General of Artillery

The Committee considered one (01) Qualification presented by the Directorate General of Artillery and **approved** the same.



11.4.2 Skill Council for Mining Sector (SCMS)

The Committee considered one (01) apprenticeship Qualification presented by SCMS and **approved** the same.

11.4.3 Aerospace and Aviation Sector Skill Council

The Committee considered nine (09) revised Qualifications and one (01) new Qualification. Out of these, eight (08) Qualifications were approved. The Qualifications titled *Airline Ground Support Mechanic* and *Airport Terminal Operations Manager* were granted **approval** for a period of six (06) months in view of the limited number of trainings conducted (fewer than 100). The AB was advised to submit the training details undertaken in these 6 months and also submit projected demand for the qualification to seek full validity of the qualification.

During this period, National Council for Vocational Education and Training shall examine the usability and industry acceptance of certifications within the aerospace and aviation ecosystem, based on which the matter may be placed before the Committee for further consideration. The Committee also directed NCVET to review the availability of industries in sector and to access whether the industry validation submission is actually a concern for the SSC or not.

11.4.4 Directorate General of Training (DGT)

The Committee considered three (03) revised Qualifications and two (02) new NOSs submitted by DGT. Two (02) Qualifications and two (02) NOSs were approved. The Qualification *Computer Operator and Programming Assistant (COPA)* was granted **approval** for a period of one (01) year.

The committee advised that DGT, in consultation with National Council for Vocational Education and Training, shall review the relevance, nomenclature, and future roadmap of the Qualifications submitted by DGT, including COPA, and place the outcome before the Committee, as appropriate.

11.4.5 Food Industry Capacity and Skill Initiative (FICSI)

The Committee considered one (01) revised Qualification and two (02) new Qualifications and approved two Qualifications. The Qualification Small Food Business Operator was **not approved** due to its overlap with entrepreneurship Qualification 'Nano Entrepreneur (street food vendor)' developed by MEPSC. The Awarding Body has been advised to undertake a comprehensive review and resubmit the qualification accordingly.

11.4.6 Home Management and Care Givers Sector Skill Council

The Committee considered one (01) new Qualification and the same was **not approved**. The committee advised to the review the qualification by the Awarding Body, in consultation with National Council for Vocational Education and Training, and submission of a comparative mapping with existing caregiving-related Qualifications in the forthcoming meeting of the Committee.

11.4.7 Handicrafts and Carpet Sector Skill Council



The Committee considered twelve (12) new NOSs and **approved** the same.

11.4.8 Healthcare Sector Skill Council

The Committee considered one (01) new Qualification and **approved** the same.

11.4.9 Indian National Space Promotion and Authorization Centre (IN-SPACe)

The Committee considered two (02) new NOSs and **approved** the same.

11.4.10 Life Sciences Sector Skill Development Council

The Committee considered two (02) new OEM Qualifications and four (04) new NOSs as a part of additional agenda and **approved** the same.

11.4.11 Logistics Sector Skill Council

The Committee considered thirteen (13) revised Qualifications and granted approval to 6 qualifications. The Qualification *Supply Chain Supervisor - Agri Commodities* was granted **approval** for six (06) months due to low training uptake. The AB was advised to submit the training details undertaken in these 6 months and also submit projected demand for the qualification to seek full validity of the qualification.

The balance 6 qualifications pertaining to e-commerce and courier operations were **not approved**. The committee advised a detailed examination of Qualifications, including the feasibility of converting certain Qualifications into NOSs. The Awarding Body was advised to undertake a comprehensive review and resubmit the proposals in the forthcoming meeting of the Committee.

11.4.12 Management and Entrepreneurship and Professional Skills Council

The Committee considered six (06) revised Qualifications of which it granted approval to four (04). The remaining two (02) Qualifications related to entrepreneurship i.e Nano-Entrepreneur and Entrepreneur were **not approved**. The committee advised to review nomenclature and the entrepreneurship-related components, including having a common entrepreneurial qualification at a defined NSQF level and may be placed before the Committee again in an upcoming NSQC meeting.

For the qualification Nano-Entrepreneur (Street Vendor), the committee advised that the qualification may be compared with "Small Food Business Operator" submitted by FICSI for overlaps with the qualification.

Further, DGT was further advised to integrate relevant entrepreneurship modules/NOSs within its Qualifications.

11.4.13 National Academy of RUDSETI



The Committee considered one (01) NOS and one (01) new Qualification and **approved** the same.

11.4.14 National Institute of Electronics and Information Technology (NIELIT)

The Committee considered seven (07) new and two (02) revised Qualifications; seven (07) new and three (03) revised NOSSs; and two (02) new Micro Credentials and **approved** the same.

11.4.15 Sports, Physical Education, Fitness and Leisure Skills Council
